Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Culligan Soft Water Services Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Culligan Soft Water Services Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the Culligan Soft Water Services Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally established by Culligan Soft Water Service (the Company) effective January 1, 1963. The Plan was most recently amended effective April 16, 2025. The Plan includes all employees (excluding union employees and nonresident aliens) of the Company and the following affiliated employers:

- Southwest Water Conditioning Company
- Susquehanna Valley Water Conditioning Company
- Northern Iowa Water Conditioning Company
- UNCO Data Systems, Inc.
- NorthCentral Minnesota Water Conditioning Company
- St. Croix Valley Water Conditioning Company
- Riverside Water Technology, Inc.
- Eastern Wisconsin Water Conditioning Company
- Northwest Water Conditioning

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees who have attained age 18 and completed three consecutive months of service, are eligible to participate in the Plan. An employee is automatically enrolled as a participant on January 1, April 1, July 1, or October 1, after meeting the eligibility requirements. Union employees at the Minnetonka location who are covered by District Lodge No. 77 of the International Association of Machinists and Aerospace Workers, AFL, CIO are eligible to participate in the Plan, but are not eligible for Company contributions.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401k of the Internal Revenue Code (IRC). New participants are automatically enrolled at 3% of eligible compensation unless otherwise elected by the participant. Participants' elections are automatically increased annually by 1% up to 6% of eligible compensation unless otherwise elected by the participant. The Plan also allows for after-tax Roth contributions from participants. Participants may elect to make salary deferral contributions up to 100% of their eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans and in-plan Roth rollovers are also allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Contributions (Continued)

The Company adopted a safe harbor matching contribution formula whereby the Company will contribute a matching contribution equal to 100% of the participant's pre-tax contributions up to 3% of the participant's eligible compensation and an additional 50% of the participant's pre-tax contribution up to the next 3% of the participant's eligible compensation.

The Plan allows the Company to make discretionary profit sharing contributions in an amount determined each year by the Company's Board of Directors. Contributions are allocated among participants employed on the last day of the Plan year with a year of service (1,000 hours) during the Plan year, unless service is terminated due to death, disability, or retirement. No profit sharing contributions were made in 2024 or 2023. Contributions are subject to certain limitations.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contribution, the Company's matching contribution, and allocations of the Company's discretionary profit sharing contribution, Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants' accounts are valued on a daily basis. Participants are allowed to direct their investments into various investments offered by the Plan.

Vesting

Employee deferral contributions, Company safe harbor matching contributions and all income and gains thereon are immediately 100% vested. Vesting in the Company's discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service or upon termination at normal retirement (age 65), death, or disability.

Forfeitures

Forfeitures of Company profit sharing contributions are used to reduce future Company contributions or reduce Plan expenses. Forfeitures of \$-0- and \$4,133 were used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$1,497 and \$4,233 were used to reduce Plan expenses for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited accounts totaled \$54,945 and \$54,764, respectively.

Notes Receivable from Participants

Plan participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) their investment fund from (to) the participant loan fund. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Distributions

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Under the terms of the Plan, lump-sum distributions from the Plan will be made upon a participant's termination, retirement, death, or financial hardship (as defined by the Plan). The Plan also allows for in-service distributions from the Plan during employment upon the attainment of age 59½. The Plan generally requires lump sum distributions of account balances of less than \$1,000 upon termination. Participants with an account balance greater than \$1,000 but less than \$5,000 will receive a lump sum distribution that is automatically rolled into an IRA for the benefit of the former participant. The Plan also allows for partial withdrawals.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Valuation of Investments and Income Recognition (Continued)

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expense

The Company pays certain administrative expenses on behalf of the Plan.

Subsequent Events

The Plan converted from The Standard to Empower on April 15, 2025.

The Plan has evaluated events and transactions for potential recognition or disclosure through October 22, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Standard Insurance Company (Insurance Carrier) has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held as end of year) as of December 31, 2024.

Minnesota Life Insurance Company has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2023.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023:

Pooled Separate Account: Valued at the net asset value (NAV) of units of the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify, amend, or terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all accounts become 100% vested.

NOTE 6 PLAN TAX STATUS

The Plan utilizes a volume submitter profit sharing plan, which obtained an opinion letter, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by qualified institutions and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
