Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Soft Surroundings 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 9, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to December 9, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103- 8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 9, 2024 and for period from January 1, 2024 to December 9, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Soft Surroundings 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the plan sponsor approved a plan of termination on February 9, 2024, effective March 31, 2024, and determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Soft Surroundings 401(k) Plan’s ability to continue as a going concern at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4a – Schedule of Delinquent Participant Contributions, for the period from January 1, 2024 to December 9, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated August 8, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified

investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Soft Surroundings 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

The Plan was established January 1, 1990, and restated on March 11, 2022 to bring the plan into compliance with legislative and regulatory changes. The Plan was then amended on March 15, 2023, to include new types of contributions.

GENERAL

The Plan is a defined contribution plan, covering substantially all employees of Soft Surroundings (the “Sponsor”) who have obtained sixty days of service and are age twenty-one or older. Employees represented by a bargaining class which have bargained with the Sponsor in good faith on the subject of retirement benefits are ineligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Sponsor is responsible for oversight of the Plan, for determining the appropriateness of the Plan’s investment offerings, and for monitoring investment performance.

CONTRIBUTIONS

Each year, participants may contribute an amount up to the maximum amount allowable, not to exceed the limits of the Internal Revenue Code (“IRC”), of pre-tax contributions, as defined in the Plan. Employees were automatically enrolled to defer 3% of their compensation as of the date they became eligible to participate in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants also contributed amounts representing distributions (rollovers) from other qualified defined benefit or defined contribution plans. Effective March 15, 2023, Roth contributions were also allowed by the Plan. Participants directed the investment of their contributions into various investment options offered by the Plan.

CONTRIBUTIONS (CONTINUED)

The Sponsor may contribute qualified nonelective contributions (QNECs) and discretionary contributions on behalf of eligible Plan participants. Eligible Plan participants were employees who have obtained one year of service and have worked at least 1,000 hours and were age twenty-one or older. The contributions were allocated based on a percentage of a participant's annual compensation to the total compensation and credited to the participant's account on the last day of the Plan year, provided they are an active participant as of the last day of the Plan year. The Sponsor did not make a discretionary contribution on behalf of eligible Plan participants for the period from January 1, 2024 to December 9, 2024. There were no QNEC contributions for the period from January 1, 2024 to December 9, 2024.

Effective March 15, 2023, the Sponsor had the option to make discretionary matching contributions on behalf of eligible Plan participants. Eligibility for the discretionary matching contributions is six months and age twenty-one or older. There were no discretionary matching contributions on behalf of eligible Plan participants for the period from January 1, 2024 to December 9, 2024.

PARTICIPANTS INVESTMENT ACCOUNT OPTIONS

Participants directed the investment of their contributions into various investment options offered by the Plan which included registered investment companies, pooled separate accounts, and common collective investment trusts.

PARTICIPANT ACCOUNTS

Each participant account was credited with the participant's contributions, the Sponsor's contributions, Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

FORFEITED ACCOUNTS

If a participant terminated employment at a time when the participant did not have a fully vested interest, the unvested benefits were forfeited. The forfeited amount remained in the Plan and was used to pay administrative expenses or to reduce Sponsor contributions (other than QNECs). Forfeitures that were not used to pay administrative expenses or used to reduce Sponsor contributions would have been allocated to participant's accounts as of the last day of the Plan year in which forfeitures were determined.

There were no forfeitures used to offset Sponsor contributions or administrative expenses during the period from January 1, 2024 to December 9, 2024. As of December 9, 2024 and December 31, 2023, there was no forfeiture balance.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement after the normal retirement age, a participant with a balance in excess of \$5,000 may elect to receive his or her account balance in a lump-sum payment, as a rollover into another qualified plan or Individual Retirement Account (IRA), and annuity options. If a participant's balance does not exceed \$5,000 but is more than \$1,000, the participant may elect to receive their account balance in a lump-sum payment and as a rollover into another qualified plan or IRA. If a participant's balance does not exceed \$1,000, the participant may only receive a lump-sum distribution. Upon termination of service for other reasons, a participant received the value of the vested interest in his or her account in the same manner as above.

The Plan permitted direct rollovers and participants may elect to have any portion of an eligible rollover distribution paid directly to an eligible retirement plan. In addition, hardship distributions were permitted if certain criteria were met.

Participants were not permitted to borrow from the Plan.

PLAN TERMINATION

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

In September 2023, the Plan Sponsor declared bankruptcy and closed its remaining 44 stores and sold its e-commerce business to another company. On February 9, 2024, the Plan Sponsor agreed to terminate the Plan effective March 31, 2024. Participants were provided with instructions and options to withdraw their account balances. All participants employed as of that date were made fully vested in their employer accounts. The Plan completed the distribution of all assets to affected participants in 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor determines the Plan’s valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased and sold, as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Expenses of the Plan, to the extent that the Sponsor does not pay such expenses, may be paid out of the assets of the Plan provided that such payment is consistent with ERISA.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

CONTRIBUTIONS

Contributions from Plan participants and the employer contributions are recorded in the period in which the employee contributions are withheld from compensation.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. No subsequent events have been identified that would require adjustment to or disclosure in the accompanying financial statements and related notes.

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of December 9, 2024 and December 31, 2023, and net appreciation in fair value of investments, and dividend income for the period from January 1, 2024 to December 9, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan at December 9, 2024 and December 31, 2023. This information has not been audited by the Plan's independent auditors.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 9, 2024 and December 31, 2023.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at the NAV of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Common Collective Investment Trusts

Valued at the NAV of units of a common collective investment trust. The NAV, as provided by the trustee of the common collective investment trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - TAX STATUS

The Plan has adopted a non-standardized defined contribution pre-approved plan. The pre-approved plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the written form of the underlying non-standardized defined contribution pre-approved plan is qualified under Section 401(a) of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related plan is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan has been amended since the pre-approved plan received its opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 9, 2024 and December 31, 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined by the DOL's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Sponsor, certain participants, and others. Certain Plan investments are managed by the trustee and their affiliates, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and administrative expenses qualify as party-in-interest transactions. Call out fees paid for trustee/recordkeeper services amounted to \$66,031 for the period from January 1, 2024 to December 9, 2024.

NOTE 7 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements are prepared on the accrual basis of accounting in accordance with U.S. GAAP. The Form 5500 is prepared on a modified cash basis. Accordingly, certain differences exist between amounts reported in these financial statements and those reported in the Form 5500.

The primary difference relates to employer contributions receivable at December 9, 2024, which are recognized in the financial statements but not included in the Form 5500 until received.

NOTE 8 - PROHIBITED OR NON-EXEMPT TRANSACTIONS

During 2024, the Sponsor failed to timely remit participant contributions of \$1,792 to the Plan pursuant to 29 CFR 2510.3-102 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2023, the Sponsor failed to timely remit participant contributions of \$318. The amounts are included on the Schedule of Delinquent Participant Contributions in the supplemental schedule to the financial statements. Under the regulation, amounts paid by a Plan participant or withheld by the Sponsor from a participant's wages for contribution to the Plan are Plan assets on the earliest date they can reasonably be segregated from the Sponsor's general assets, but in no event later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Sponsor. As a result, the Sponsor has engaged in a non-exempt prohibited transaction under ERISA Section 406.

The criteria for identifying late remittances used in these financial statements differ from those used in the Form 5500 Schedule H. We identify late remittances as those which have been withheld from a participant's paycheck and not remitted to the Plan whereas the Form 5500 Schedule H identifies late remittances only when they have been received. This difference resulted in a \$2,110 variance between the two reports.
