## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Qnnect 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Qnnect 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Qnnect 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution that was established on December 1, 2022, for all qualified employees of Qnnect LLC (the "Company" or "Employer") and was most recently restated on September 1, 2024. The Plan is a defined contribution plan to provide benefits to eligible employees as defined in the plan documents. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code ("IRC"), as amended, and subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statement were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company delegates certain responsibilities for the operation and administration of the Plan. Fidelity Management Trust Company (the "Trustee") is the trustee and asset custodian. Fidelity Workplace Services, LLC, an affiliate of the Trustee, provides recordkeeping services and manage participant's accounts and participant related transactions.

Eligibility

Employees of the Company are eligible to participate in the Plan immediately upon hire if at least 18 years of age. The Plan excludes temporary employees of third-party agencies.

Participant accounts

Each participant's account is credited with participant's contributions, Employer contributions, rollovers, and an allocation of Plan investment earnings, and is charged with an allocation of Plan investment losses, and certain administrative expenses. Allocations of investment earnings or losses are based on participant earnings or losses or account balances, as defined by the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN (continued)

Notes receivable from participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. The minimum amount that a participant may request is \$1,000. Notes receivable from participants are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time the loan was made. Principal and interest must be repaid to the Plan within a five year period, unless the loan is used for the purchase of a principal residence, in which case the minimum repayment period may be longer. Participants may only have one loan outstanding at a time. Outstanding notes receivable from participants at December 31, 2024, carry interest rates ranging from 4.25% to 9.75% and mature through April 2043.

Contributions

The Plan documents allow that each year, participants may contribute up to 100% of their eligible annual compensation as defined by the Plan. Participants who have attained or are expected to attain age 50 before the end of the Plan year are eligible to make catch-up contributions. These contributions are subject to annual contribution limitations as determined by the Internal Revenue Code (the "IRC"). Rollovers of participant balances in and out of the Plan are included in employee contributions and benefits paid, respectively, on the accompanying statement of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes enhanced safe harbor matching contributions to the Plan for those eligible participants as defined by the plan documents. For the plan year ended December 31, 2024, the Company's safe harbor match represented 100% of the first 4% of the eligible participant's compensation contributed to the Plan.

The Plan Sponsor may also make profit sharing contributions. No profit-sharing contributions were made in 2024.

Vesting

Participant salary deferral, Roth salary deferral, rollover contributions, enhanced safe harbor matching contributions and profit sharing contributions are 100% vested at all times.

Forfeitures

As all participant benefits are fully vested, the plan had no participant forfeitures in 2024 or 2023. The Plan does hold forfeiture amounts related to merged plans and other employer contributions for administrative needs that will be utilized by the Plan for future expenses and contributions. The balances at December 31, 2024 and 2023 were \$63,008 and \$16,224, respectively.

Payment of benefits

Distributions and withdrawals are payable upon attainment of age 59 1/2, retirement, termination, financial hardship, disability, death, or military active duty callup. Participant account balances equal to or less than \$1,000, are distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Balances greater than \$1,000 and less than or equal to \$5,000 upon termination will be rolled over to an individual retirement plan designated by the administrator if the participant has not requested a distribution. If the account balance is over \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US. GAAP").

Estimates

The preparation of financial statements in conformity with US. GAAP requires the plan administrator to make estimates that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents the amount participants would receive under the terms of the contract.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on sale on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Agreement.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when charged.

Subsequent events

The Plan has evaluated all subsequent events through October 30, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the financial statements.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. Employer contributions are recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based on the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the contributions are received by the Trustee.

3. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.1038 of ERISA. The Trustee (Note 1), determined to be a qualified institution by the Company, has certified to the completeness and accuracy of:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust ("CCT")*: – Valued at the NAV of shares held by the Plan at year end, as reported by the Trustee. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the CCT. While the underlying assets of the CCT are publicly available, the CCT is not. The CCT files annual Form 5500s as a direct filing entity. There are no unfunded commitments or restrictions and there is a daily redemption frequency and daily redemption period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. APEX GUARANTEED FIXED INTEREST FUND

The Plan's investment in the APEX Guaranteed Fixed Interest Fund (GFIF) is unconditionally guaranteed by EAIC. Contributions made to the GFIF are invested in the general account of EAIC. The contract is considered a fully benefit-responsive investment contract. The Plan's balance in the GFIF at December 31, 2024 and 2023, is \$5,998,767 and \$7,004,077, respectively.

For investment contracts that are benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported by EAIC. Contract value represents accumulated cash contributions made under the contract, interest credited to the contract, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk for the contract issuer or otherwise. The GFIF investment contract provides a guarantee of principal, a minimum annual rate of interest of 3%, and the opportunity for additional interest in excess of the guaranteed rate. When declared, additional amounts remain in effect for the six-month period beginning December 1 and June 1. Additional interest is not guaranteed for future years. No interest rate was in excess of 3% in 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with EAIC or with participants are probable of occurring.

The contracts above do not permit the respective issuer to terminate the agreement prior to the scheduled maturity date.

6. PARTY-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to a related party in financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Partyininterest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% of more of such an employer or employee association or relatives of such persons.

The Trustee retains as compensation for services provided to the Plan, any interest (or float) on amounts earned, while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time, subject to the provisions of the Plan and ERISA.

8. TAX STATUS

The Plan adopted the Fidelity Pre-Approved Profit Sharing Plan (the "Pre-Approved plan"). The IRS issued an opinion letter dated June 30, 2020, that the PreApproved plan is designed in accordance with applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company had late contributions totaling \$550,701, \$874,494, and \$37,140 for the Plan years ended December 31, 2024, 2023, and 2022, respectively. The Company will utilize the Department of Labor Voluntary Fiduciary Correction Program calculator to determine lost earnings to self-correct these delinquent contributions during the year ended December 31, 2025.
