Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule H, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Elevance Health Retiree Health Benefits Plan (the "Plan") provides only general information. More detailed information concerning the Plan may be found by consulting the Summary Plan Description available from the plan administrator.

General

The Plan is a contributory health and welfare plan, which provides health benefits for eligible retirees and dependents of certain subsidiaries of Elevance Health, Inc. and other affiliated employers that have adopted the Plan ("participating employers"). The Plan Sponsor is ATH Holding Company, LLC, a wholly owned subsidiary of Elevance Health, Inc. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Benefits

The Plan provides medical, prescription drug, dental, and vision benefits for Pre-Medicare Eligible and Medicare Eligible participants and their covered dependents through various benefit programs. Effective January 1, 2021, the Plan includes a fully insured Medicare Advantage Plan for Medicare eligible participants age 65 or older.

Contributions

The cost of the benefits provided through the Plan is funded in part by the Plan Sponsor and participating employer contributions and in part by retiree contributions. The Plan Sponsor is obligated to pay benefits paid and payable under the Plan, to the extent not paid from retiree contributions.

The Plan Sponsor may make contributions or qualified transfers to the Elevance Health Retiree VEBA Trust, an Internal Revenue Code ("IRC") Section 501(c)(9) voluntary employees' beneficiary association ("VEBA") trust, on behalf of employees and retirees in order to accumulate funds for the payment of benefits of eligible participants in the Plan. Plan Sponsor contributions during 2024 and 2023 consisted of benefits payable on behalf of participants.

Participant contributions can vary depending on a number of factors, such as hire date, retirement date, legacy status, Medicare eligibility, plan option, and tier of coverage elected. A number of current and future retirees are credited with a notional Retiree Medical Spending Account ("RMSA"), which can be used to reimburse premiums paid by the retiree until the account is exhausted.

Notes to Financial Statements (continued)

Eligibility

Generally, retired employees of participating employers who retired at age 55 after completing at least ten years of employment, or at age 65 regardless of years of employment, are eligible to participate in the Plan. Certain legacy participants from previously merged plans may have different eligibility requirements. A retiree's dependents are also eligible, provided that dependent and/or family health coverage is elected at the time of enrollment.

401(h) Account

In addition to the VEBA trust, a separate account has been established and maintained in the Elevance Health Cash Balance Plan B ("CBPB") (or the "Cash Balance Plan") for assets designated to fund postretirement health benefits. The Plan allows the 401(h) account to fund a portion of the postretirement obligations for participants of the Plan with an RMSA. In accordance with Section 401(h) of the IRC and the terms of the Cash Balance Plan document, the 401(h) account is not used for, or diverted to, any purpose other than providing health benefits for retirees and their dependents. On July 9, 2024, the Plan Sponsor, via written consent, acted to amend CBPB, contingent upon obtaining a favorable private letter ruling ("PLR") from the Internal Revenue Service. This amendment allows use of the 401(h) account to support active health and welfare obligations of CBPB participants eligible for a distribution from CBPB; see Note 11, "Subsequent Events", for a discussion of the PLR and associated CPBP amendment in 2025. This obligation for health benefits is not included in the Cash Balance Plan's obligations but is reported as an obligation in the financial statements of this Plan.

Plan participants do not contribute to the 401(h) account. The Plan Sponsor may make contributions or qualified transfers to the 401(h) account on behalf of employees and retirees in order to accumulate funds for the payment or reimbursement of benefits to or on behalf of eligible participants in the Plan.

CBPB and the 401(h) account participate in the Elevance Health Master Trust (the "Master Trust"), which is managed by J.P. Morgan Chase Bank, N.A. ("JPM"), the Trustee of the Master Trust.

Reimbursement to Plan Sponsor

The Plan Sponsor may request reimbursement at any time from the VEBA trust or the 401(h) account, as applicable, for benefits and premiums it has paid under the Plan on behalf of eligible participants.

The Plan Sponsor requested reimbursement from the VEBA trust of \$13,433,680 and \$13,734,933 for benefits and premiums paid during the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor requested reimbursement from the 401(h) account of \$2,171,519 and \$2,852,654 for benefits and premiums paid during the years ended December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits that will be provided to future retirees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, Plan assets would be used as permitted by the Plan documents and ERISA.

2. Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and are in conformity with U.S. generally accepted accounting principles (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Actual results may differ from those estimates.

Payment of Benefits

Claims payments are recorded when paid by the claims processor and are reported as retiree health benefits paid in the accompanying statement of changes in net assets available for benefits. Amounts for benefits reported but not processed for payment at December 31 are recorded as health claims reported and approved for payment in the statements of benefit obligations. Insurance premiums paid for health benefits and Medicare Part B premiums are recorded when paid by the Plan Sponsor and are reported in the corresponding lines on the statement of changes in net assets available for benefits. RMSA credits are reflected in the statement of changes in net assets available for benefits as RMSA reimbursements paid when they are utilized.

Investment Valuation and Income Recognition

Investments of the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements.

Notes to Financial Statements (continued)

The fair value of the 401(h) account's interest in the Master Trust reflects the 401(h) account's interest in the fair value of the underlying net assets of the Master Trust investment accounts. Within the Master Trust investment accounts, purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses are recognized as they occur.

The fair value of trust owned life insurance contracts ("TOLI") is based on the cash surrender value ("CSV") of the policies as reported by the insurance carriers. Changes in the CSV due to investment results are reported on the statement of changes in net assets as net change in CSV of life insurance contracts. Realized gains on life insurance contracts are recognized when death benefits are paid and are calculated as the excess of death benefit payments over CSV of the applicable policies.

Interest income on interest bearing cash is recorded on the accrual basis.

Administrative and Investment Management Expenses

The Plan's trustee fees and investment management fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan.

Postretirement Benefit Obligations

Postretirement benefit obligations are the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) eligible active employees and their beneficiaries and dependents after retirement from service with the Plan Sponsor or a participating employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered as of the valuation date.

Health claims incurred by participants but not reported at year end are estimated by the Plan's enrolled consulting actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's benefit administrators and are included in the postretirement benefit obligation. These claims are paid by the Plan only to the extent they are submitted and approved for payment.

Risks and Uncertainties

The VEBA trust holds investments, including TOLI contracts, and the 401(h) account holds an interest in the Master Trust, which holds various investments. Investments are exposed to various risks such as interest rate, liquidity and credit risks. Investments are also subject to market risks which include global risks such as pandemics. Due to the level of risk associated with investments and certain underlying investments of the Master Trust, as well as the sensitivity of certain fair value assumptions, it is reasonably possible that changes in the values of the VEBA trust's investments and the 401(h) account's interest in the Master Trust will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. In addition investments such as interest bearing cash are subject to the Federal Deposit Insurance Corporation ("FDIC") federally insured limits.

Because of the significant concentration of the VEBA trust's investment in the TOLI contracts, any changes in the financial strength of the TOLI insurance carriers (Lincoln National Life Insurance Company, Nationwide Life Insurance Company and Delaware Life Insurance Company) and their ability to meet long-term contractual obligations could also have a material impact to the financial statements.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

Income Taxes

Per the IRC, certain investments of the VEBA trust that do not generate tax-exempt interest are subject to unrelated business income tax ("UBIT"). UBIT expense is recognized within the statement of changes in net assets available for benefits as administrative expense.

Contributions Receivable

The Plan Sponsor's policy is that health claims reported and approved for payment at year-end represent additional contributions receivable from the Plan Sponsor as these claims have been processed and approved for payment. Accordingly, these are recorded as Plan Sponsor contributions on the statements of net assets available for benefits.

3. Certified Investments

As of December 31, 2024 and 2023, the Plan's investments consist of its assets held in the Cash Balance Plan's 401(h) account, which is invested in the Master Trust, and investments held outside of the Master Trust in the VEBA trust. See Note 5 for further information regarding the Plan's investment in the Master Trust.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in the cash surrender value of life insurance contracts, realized gains from life insurance death benefits (when applicable), and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by JPM, the Trustee of the Plan.

4. 401(h) Account

Net assets available for postretirement health and welfare benefits of the 401(h) account were \$17,793,235 and \$20,001,184 as of December 31, 2024 and 2023, respectively. The related changes in net assets available for postretirement health and welfare benefits of the 401(h) account for the year ended December 31, 2024, is summarized below:

5. Interest in Master Trust

Master Trust assets are managed by various investment managers in separate investment accounts. The 401(h) account has an undivided interest in the net assets of the Master Trust investment accounts in which the Cash Balance Plan has invested. The Trustee maintains a separate record of the 401(h) account and, therefore, the Plan's share of the net asset value of the Master Trust. At December 31, 2024 and 2023, the 401(h) account's interest in the net assets of the Master Trust was approximately 1.12% and 1.21%, respectively.

The Master Trust's interest and dividends, net appreciation (depreciation) and account specific investment fees relating to transactions in portfolio investments are allocated to the Plan based on the Plan's share of the Master Trust investment account's assets. Administrative expenses incurred at the Master Trust level are also allocated to the Plan based on the Plan's share of the Master Trust's assets. For the years ended December 31, 2024 and 2023, the Plan's 401(h) account, the Cash Balance Plan and the Elevance Health Cash Balance Plan A participated in the Master Trust.

Notes to Financial Statements (continued)

The value of the 401(h) account's interest in the Master Trust is based on the beginning of the year value of the 401(h) account's interest in the Master Trust plus actual contributions and allocated investment income. In addition, the 401(h) account's share of the net asset value of the Master Trust is reduced for actual distributions and administrative expenses relating to transactions that are allocated to the Plan.

Additional disclosures related to the net assets held by the Master Trust and the 401(h) account are provided in the Cash Balance Plan's financial statements.

6. Fair Value of Investments

Investments recorded at fair value in the statements of net assets available for benefits are categorized based on the level of judgment associated with the inputs used to measure their fair value. Level inputs, as defined by FASB guidance, are as follows:

<u>Level Input:</u>	<u>Input Definition:</u>
Level I	Inputs are unadjusted, quoted prices for identical assets or liabilities in active markets at the measurement date.
Level II	Inputs other than quoted prices included in Level I which are observable for the asset or liability through corroboration with market data at the measurement date.
Level III	Unobservable inputs that reflect management's best estimate of what market participants would use in pricing the asset or liability at the measurement date.

Transfers between Levels, if any, are recorded as of the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and II and no transfers in or out of Level III.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to determine the fair value of investments held directly by the Plan in the statements of net assets available for benefits.

Interest bearing cash: The carrying amount reported for interest bearing cash approximates fair value due to the short term nature of the assets. Interest bearing cash is maintained for liquidity for benefit payments and other plan transactions and receives daily interest from JPM. Interest bearing cash is designated Level II.

Trust owned life insurance contracts: Valued by the Trustee at the CSV of the contracts as reported by the life insurance carriers, which approximates fair value. The CSV is substantiated by the Plan Sponsor by comparing the value reported by the Trustee to the value of underlying investments reported in insurance carrier's monthly statements. The Plan Sponsor also evaluates the creditworthiness of the life insurance carriers which are rated A+ or above. TOLI contracts are designated Level III.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Postretirement Benefit Obligations

The actuarial present value of the expected postretirement benefit obligation is determined by an enrolled consulting actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

9. Exempt Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The following transactions are exempt from the prohibited transaction rules.

For the years ending December 31, 2024 and 2023, the Master Trust in which the Plan has a beneficial interest held investments managed by JPM. The Plan also paid trustee fees to JPM for the year ended December 31, 2024.

During 2024, the Plan paid \$14,597,652 of insurance premiums for health benefits to affiliates of the Plan Sponsor.

During 2024, the Plan reimbursed the Plan Sponsor \$13,734,933 from the VEBA trust and \$2,852,654 from the 401(h) account for benefit and premium amounts paid by the Plan Sponsor in 2023 on behalf of the Plan.

For the year ended December 31, 2024, the Plan recorded a total liability of \$15,605,199 for reimbursements due to the Plan Sponsor for benefit amounts paid in 2024 on behalf of the Plan. This represents benefit amounts to be paid from the VEBA trust of \$13,433,680 and benefit amounts to be paid from the 401(h) account of \$2,171,519

The Plan Sponsor may bear certain costs associated with administering the Plan. In addition, the plan administrator, which is also a party-in-interest, directly, through its affiliates, or through delegations of authority, provides certain administrative services at no cost to the Plan.

10. Income Tax Status

The VEBA trust that holds funds of the Plan is designed to meet the requirements of a VEBA under Section 501(c)(9) of the IRC. The VEBA trust has received an exemption letter from the IRS dated August 18, 1993 stating that the VEBA trust is designed in accordance with applicable sections of the IRC.

The Cash Balance Plan that holds assets of the 401(h) account on behalf of the Plan has received a determination letter from the IRS dated January 5, 2021 stating that the plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation.

The VEBA trust and the Cash Balance Plan are required to operate in conformity with the IRC to maintain the status of the trusts. The Plan was most recently amended and restated January 1, 2022. The plan administrator believes the Plan, as restated, the VEBA trust, and the Cash Balance Plan are all being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Subsequent Events

The Plan Sponsor has evaluated the impact of subsequent events through October 15, 2025, the date the financial statements were available to be issued. The following subsequent event was noted.

Effective May 5, 2025 (the date as of which the IRS issued a favorable PLR), the Plan Sponsor adopted a CBPB amendment detailing how 401(h) Account assets may be used to reimburse the Plan Sponsor for active health benefits (medical, dental and vision) on behalf of CBPB participants and their eligible beneficiaries, even if the participant has not separated from employment, provided the participant is eligible for in-service distributions from CBPB. As stated in the PLR, this amendment does not adversely affect the qualified status of CBPB under the Code section 401(a) or the Master Trusts's tax-exempt status under Code section 501(a).

No other subsequent events have been recognized or required additional disclosure in the financial statements.
