**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Elevance Health VEBA Retiree Health Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024 and 2023

### **1. Description of the Plan**

The following description of the Elevance Health VEBA Retiree Health Benefits Plan (the "Plan") provides only general information. More detailed information concerning the Plan may be found by consulting the Summary Plan Description available from the plan administrator.

#### **General**

The Plan is a contributory health and welfare plan which provides health benefits for eligible retirees and dependents of certain subsidiaries of Elevance Health, Inc. and other affiliated employers that have adopted the Plan ("participating employers"). The Plan Sponsor is ATH Holding Company, LLC, a wholly owned subsidiary of Elevance Health, Inc. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### **Benefits**

The Plan provides medical, dental, and vision benefits for participants and their covered dependents. Effective January 1, 2021, the Plan includes a fully insured Medicare Advantage Plan for Medicare eligible participants age 65 or older.

#### **Contributions**

The cost of the benefits provided through the Plan is funded in part by the Plan Sponsor and participating employer contributions and in part by retiree contributions. The Plan Sponsor is obligated to pay benefits paid and payable under the Plan, to the extent not paid from retiree contributions.

Participant contributions can vary depending on a number of factors, such as hire date, retirement date, legacy status, Medicare eligibility, plan option, and tier of coverage elected. Certain current and future retirees are credited with a notional Retiree Medical Spending Account ("RMSA"), which can be used to reimburse premiums paid by the retiree until the account is exhausted.

#### **Eligibility**

Generally, retired employees of participating employers who retired at age 55 after completing at least ten years of employment, or age 65 regardless of years of employment, are eligible to participate in the Plan. Certain legacy participants from previously merged plans may have different eligibility requirements. A retiree's dependents are also eligible, provided that dependent and/or family health coverage is elected at the time of enrollment.

## Notes to Financial Statements (continued)

### **Trust and Trustee**

The Plan participates in the Blue Cross and Blue Shield Plans' National Retiree Health Benefits Trust 103-12 investment entity (the "Trust"), a qualifying 103-12 investment entity under ERISA, of which The Northern Trust Company ("Northern") is the Trustee. Northern Trust Global Investments serves as the investment manager and securities custodian for the Trust. The Plan may make contributions to the Trust each year on behalf of employees and retirees in order to accumulate funds for the payment or reimbursement of medical expenses of eligible participants in the Plan. The contribution amount, when applicable, is determined by an independent enrolled actuary. The Plan has the right to terminate its participation in the Trust at any time.

The Trustee maintains a separate record of the Plan's share of the net assets of the Trust. The value of the Plan's interest in the Trust is based on the beginning of the year value of the Plan's interest in the Trust plus actual contributions and allocated investment income. In addition, the Plan's share of the net assets of the Trust is reduced for actual distributions and administrative expenses relating to transactions in the portfolio that are allocated to the Plan based on the Plan's share of the net assets of the Trust.

### **Reimbursement to Plan Sponsor**

The Plan Sponsor may request reimbursement from the Trust for benefits and premiums it has paid under the Plan on behalf of eligible participants. The Plan Sponsor requested reimbursement from the Trust of \$2,239,835 and \$1,681,422 for benefits and premiums paid during the years ended December 31, 2024 and 2023, respectively. The benefit expenses to be reimbursed are reflected in the statements of net assets available for benefits as reimbursement due to Plan Sponsor and in the statement of changes in net assets available for benefits as a decrease in Plan Sponsor contributions when they are accrued.

### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits that will be provided to future retirees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, Plan assets would be used as permitted by the Plan documents and ERISA.

## **2. Significant Accounting Policies**

### **Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and are in conformity with U.S. generally accepted accounting principles ("GAAP").

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Actual results may differ from those estimates.

### **Payment of Benefits**

Claims payments are recorded when paid by the claims processor and are reported as retiree health benefits paid in the accompanying statement of changes in net assets available for benefits. Amounts for benefits reported but not processed for payment at December 31 are recorded as claims payable in the statements of benefit obligations. Insurance premiums paid for health benefits and Medicare Part B premiums are recorded when paid by the Plan Sponsor on the corresponding line on the statement of changes in net assets available for benefits. RMSA credits are reflected in the statement of changes in net assets available for benefits as RMSA reimbursements paid when the reimbursements are utilized.

### **Investment Valuation and Income Recognition**

The value of the Plan's investment in the Trust is its proportionate share of the fair value of underlying investments held by the Trust, measured using Net Asset Value ("NAV") as a practical expedient. Valuation of the underlying investments in the Trust is determined by the Trustee and is reported to the Plan in the audited financial statements of the Trust. The Trustee applies fair value measurements to the underlying investments as defined in the Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurement, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (i.e. exit price) in an orderly transaction between market participants at the measurement date.

The Trust holds a diversified portfolio of common stock, preferred stock, mutual funds and government obligations. The Trust's investments as of December 31, 2024 are allocated between government fixed income securities (62%), equity securities (35%), and mutual funds (3%). The Trust's investments as of December 31, 2023 are allocated between government fixed income securities (58%), equity securities (35%), and mutual funds (7%).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses and net unrealized appreciation (depreciation) of fair value of investments, including investments bought and sold as well as held during the year, are recognized as they occur.

## Notes to Financial Statements (continued)

The methods employed by the Trustee may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the Trustee's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Income Taxes**

Certain investments of the VEBA that do not generate tax-exempt interest are subject to unrelated business income tax. Income tax expense is recognized within the statement of changes in net assets available for benefits as administrative expense.

### **Administrative and Investment Management Expenses**

The Plan pays substantially all administrative costs of operating the Plan including unrelated business income tax, trustee fees, audit, investment management and certain actuarial fees incurred by the Trust and allocated to the Plan. These expenses are shown as Administrative expenses in the accompanying Statement of changes in net assets available for benefits.

### **Postretirement Benefit Obligations**

Postretirement benefit obligations are the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) eligible active employees and their beneficiaries and dependents after retirement from service with the Plan Sponsor or a participating employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered as of the valuation date.

Health claims incurred by participants but not reported at year end are estimated by the Plan's enrolled consulting actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's benefit administrators and are included in the postretirement benefit obligation. These claims are paid by the Plan only to the extent they are submitted and approved for payment.

## Notes to Financial Statements (continued)

### **Risks and Uncertainties**

The Trust holds various investments. Investments are exposed to various risks such as interest rate, and credit risks. Investments are also subject to market risks which include global risks such as pandemics. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

### **3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Northern, the Trustee of the Trust.

### **4. Postretirement Benefit Obligations**

The actuarial present value of the expected postretirement benefit obligation is determined by an enrolled consulting actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

A one percentage point increase in the health care cost trend rate would increase the postretirement benefit obligation by \$371,313 and \$389,507 at December 31, 2024 and 2023, respectively.

These actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 is expected to be funded through future contributions from the Plan Sponsor.

### 6. Exempt Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The following transactions are exempt from the prohibited transaction rules.

The Plan holds an interest in the Trust that is administered by the National Employee Benefits Administration of the Blue Cross and Blue Shield Association; certain of the participating employers are members of the Blue Cross and Blue Shield Association. The Trust invests in common stock of the Trustee, common stock of Elevance Health, Inc., and a registered investment fund managed by the Trustee. In addition, trustee fees are paid by the Trust.

For the years ended December 31, 2024 and 2023, the Plan recorded liabilities of \$2,239,835 and \$1,681,422, respectively, for reimbursements due to the Plan Sponsor for amounts paid by the Plan Sponsor on behalf of the Plan.

The Plan Sponsor may bear certain costs associated with administering the Plan. In addition, the plan administrator, which is also a party-in-interest, directly or through its affiliates, provides certain administrative services at no cost to the Plan.

### **7. Income Tax Status**

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service (“IRS”) dated April 26, 1994 stating that the Trust is designed in accordance with Section 501(c)(9) of the Internal Revenue Code (the “Code”) as a Voluntary Employee Beneficiary Association. The Plan and Trust are required to operate in conformity with the Code to maintain the status of the Trust. The Trust has been amended since receiving the determination letter. The Trust administrator believes the Trust is designed and is currently being administered in compliance with the Code. As a result of unrelated business income relating to the Trust’s investment activity, a provision for income taxes is included in administrative expenses of the Plan.

GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Subsequent Events**

The Plan Sponsor has evaluated the impact of subsequent events through October 15, 2025, the date the financial statements were available to be issued. No subsequent events have been recognized or required additional disclosure in the financial statements.
