**NOTES TO FINANCIAL STATEMENTS**  
**December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of the Resource Innovations, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Resource Innovations, Inc. (the Company) to provide benefits to eligible employees, as defined in the Plan document. Employees are eligible to participate in the Plan on the first day of the month following their date of hire. Employees subject to collective-bargaining agreements, nonresident aliens with no source of U.S. income, temporary hires, interns and leased employees are not eligible to participate in the Plan. The Plan is subject to the applicable requirements of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective August 1, 2024, Cadeo Group, LLC became an Adopting Employer of the Plan. Individuals who became employees of the Company were provided the option to rollover balances from Cadeo Group 401(k) Plan into the Plan.

**Contributions**

Each year, participants may contribute up to 100% of eligible annual compensation as defined in the Plan document, up to the maximum amount allowed under the IRC on a pre-tax or after-tax Roth basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants age 50 or older are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and have their contributions invested in a designated model portfolio based upon birth date until changed by the participant. Active participants with deferrals between 1% and 14% are automatically increased by 2% on April 1 of each year up to a maximum of 15% unless they affirmatively elect not to increase.

For the year ended December 31, 2024, the Company discretionary matching contribution is equal to each participant's elective deferrals up to a maximum of 5% of each participant's compensation, as defined in the Plan document. For the year ended December 31, 2023, the Company discretionary matching contribution was equal to 50% of each participant's elective deferrals up to a maximum of 5% of each participant's compensation, as defined in the Plan document. Matching contributions for the years ended December 31, 2024 and 2023 were \$3,418,269 and \$1,350,637, respectively.

In addition, the Company may make discretionary profit-sharing contributions to the Plan, as determined each year. Participants must complete a year of service and be employed on the last day of the Plan year in order to be eligible to receive a profit-sharing contribution unless termination of employment is due to death, disability or retirement. The Company did not make any discretionary profit-sharing contributions during the Plan years ended December 31, 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching and profit-sharing contributions, as well as allocations of Plan earnings or losses. Allocations of Plan earnings or losses are based on participant account balances, based on investment options selected. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon, and in all Company discretionary matching and profit-sharing contributions.

**Forfeitures**

Forfeitures representing excess Company contributions, as determined annually through Plan compliance testing, remain in the Plan and can be used to reduce future Company contributions or pay administrative fees. At December 31, 2024 and 2023, there were no forfeited non-vested amounts. During the years ended December 31, 2024 and 2023, \$3,417 and \$12,913 of forfeitures were utilized to pay administrative fees, respectively.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The \$50,000 maximum loan amount is reduced by the participant's highest outstanding loan balance during the past 12 months less any loan balance on the date the new loan is made. Participants may only have one loan outstanding at any time. The loans are secured by the vested balance in the participant's account and bear interest rates equal to current lending rates for similar loans at the time of the loan. Loan repayments are generally made ratably through payroll deductions over a period not to exceed five years, unless the loan is used for the purchase of a principal residence, in which case the repayment period may not exceed 30 years.

**Payment Of Benefits**

Upon termination of service, death, disability, reaching the age of 59½ or retirement, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account. Certain minimum distributions are also required by April 1st following the end of the year in which a participant reaches age 73 or retires, if later. Separated participants with vested account balances under \$1,000 will receive a lump-sum distribution as requested by the Plan administrator without the participant's consent, unless otherwise elected by the participant. Additionally, under certain circumstances of financial hardship, a participant is allowed to withdraw funds from the Plan.

**2. Summary Of Significant Accounting Policies**

**Basis Of Presentation**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use Of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Charles Schwab Trust Bank. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Loan origination and related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment Of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and self-directed brokerage account fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments. Administrative expenses recorded for the years ended December 31, 2024 and 2023 totaled \$12,194 and \$18,484, respectively.

### **3. Certified Investment Information**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

**Registered Investment Companies**

Valued at the daily closing price as reported by the funds. Registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**Common/Collective Trusts**

Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of each of the invested funds, is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All common/collective trusts, with the exception of the Wells Fargo Stable Value C Fund, provide for daily redemptions by the Plan at reported NAV with no advance requirement. The Wells Fargo Stable Value C Fund may be redeemed daily, but if the Plan initiates a full redemption a 12-month notification is required. All of the common/collective trusts held by the Plan file annual returns on Form 5500 as direct filing entities.

**Individually Directed Accounts**

The investments underlying the self-directed accounts primarily include common stocks and registered investment companies. Valued at either the closing price reported on the active market on which the individual securities are traded or based on the NAV of the registered investment company.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the report date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

**5. Income Tax Status**

The Plan uses a pre-approved plan document sponsored by Schwab Retirement Plan Services. Schwab Retirement Plan Services received an opinion letter from the Internal Revenue Service (IRS), dated September 21, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Party In Interest Transactions**

Charles Schwab Trust Bank, the Trustee of the Plan, and Schwab Retirement Plan Services, Inc., the recordkeeper of the Plan, receive certain direct fees and indirect asset-based fees as outlined in the various fee disclosures to the Plan. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund. These transactions qualify as exempt party in interest transactions under ERISA.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.

**7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**8. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.
