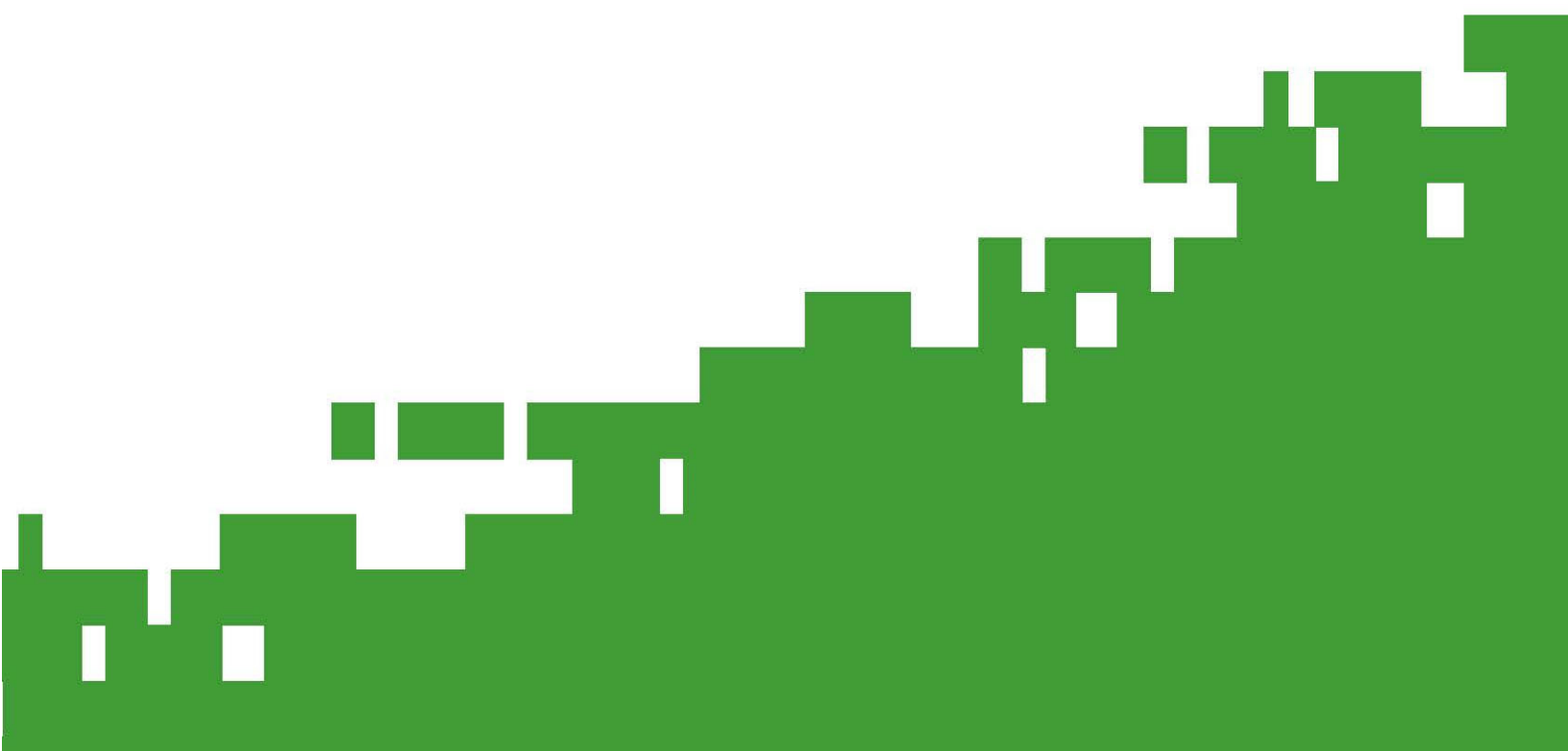

## REQUIRED COMMUNICATIONS

We did not identify any significant unusual transactions.

### Audit Adjustments and Uncorrected Misstatements

There were no audit adjustments made to the original trial balance presented to us to begin our audit.

27. We have no plans or intentions that may materially affect the carrying value or classification of assets or liabilities.



The correction and any excess taxes, if applicable, were paid out of the Plan Sponsor's, and not the Plan's, assets. The late deposits amount totaled approximately \$101,000 for 2023.

  - b. Notes receivable from participants or other receivables or investments in default or considered to be uncollectible that were not disclosed in the financial statements or supplemental schedules.
  - c. Reportable transactions that were not disclosed in the supplemental schedules.

39. During the course of your audit, you may have accumulated records containing data that should be reflected in our books and records. All such data have been so reflected. Accordingly, copies of such records in your possession are no longer needed by us.
