To Whom it may concern:

I was unaware that Paychex (our 401(K) administrator) or my accountant did not file a form 5500 SF for 2022 for my business Wash Boss Inc. We sold the business in the summer of 2022 and I closed our my PayChex account in August 2022. I thought this was the final step needed from me.

This was a very small 401(K) with 1 active employee prior to us closing the account in 2022.

I started receiving correspondence from the IRS looking for form 5500 for calendar year 2023, of which none were required.

After spending a substantial amount of time on the phone with both PayChex and somebody at EFAST, I have now submitted form 5500 SF for 2022 marked FINAL.

I respectfully request that penalties be waived for late filing, as I was under the impression that the accountant and/or PayChex had completed this on me behalf.
