### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the EDEN 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the EDEN 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. A. PLAN DESCRIPTION

The following description of the EDEN (the “Organization” or “Plan Sponsor”) 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The original effective date of this tax-sheltered annuity plan was December 1, 1991, and was restated January 1, 2020. The Plan is a Custodial Account Plan under Code §403(b)(7) which covers substantially all employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) under DOL Regulation 29CFR 2510.3-2(f). The Board of Directors is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Eligibility** - Substantially all employees are eligible to participate as of their first day of employment. Employees who normally work less than twenty hours per week are excluded from the Plan. Employees may enter the Plan the first day of each month.

**Contributions** - Participants may voluntarily contribute up to the Internal Revenue Code (“IRC”) 402(g) limit of their compensation on a pre-tax basis. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualified retirement plans.

The types of employer contributions are as follows:

**Matching Contributions** - The Plan Sponsor may, at its option, match a portion of participants’ voluntary contributions for participants who are age twenty-one or older and have four months of service. For the year ended December 31, 2023, the Plan Sponsor elected to match \$1.00 for each \$1.00 of pre-tax contributions up to 3% of each participant’s compensation. For the year ended December 31, 2023, matching contributions totaled \$166,648.

**Nonelective Contributions** - The Plan Sponsor may, at its option, make a contribution for participants who are age twenty-one or older and have four months of service. The Plan Sponsor may, at its option, make the following contributions to the Plan:

The first type of nonelective contribution has no conditions for allocation. The Plan made a nonelective contribution of 2% of each participant’s compensation during the year ended December 31, 2023 which totaled \$141,087.

The second type of nonelective contribution requires completion of 1,000 hours of service during the Plan year and employment on the last day of the Plan year. The Plan Sponsor did not make this nonelective contribution for the year ended December 31, 2023.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution, employer matching contribution, employer nonelective contribution, investment earnings, and, if applicable, charged an administrative expense. The benefit to which the participant is entitled is their vested balance.

**Investment Options** - Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Participants are subject to a three-year graded vesting schedule in the Plan Sponsor’s contributions.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined at the time the loan is taken based on Prime plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the note terms can range up to ten years. Participants may have only one loan outstanding at any time.

**Payment of Benefits** - Upon termination of service, retirement, death, age 59½, or disability, the participant may elect to receive his or her account balance as a lump-sum payment, in periodic installments, or as a joint and survivor annuity contract. The Plan may automatically make a lump-sum distribution for account balances less than \$1,000. Any terminated participants with a balance between \$1,000 and \$5,000 can be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Participants terminated are entitled to receive their benefits as soon as administratively feasible. Distributions of a participant's 403(b) account balance may be authorized at any time by the Plan Administrator under certain hardship conditions.

**Forfeitures** - Forfeitures may be used by the Plan to offset employer contributions. During 2023, \$16,962 of forfeitures were used to reduce employer contributions. Unused forfeitures totaled \$1,344 and \$1,289 as of December 31, 2023 and 2022, respectively.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for the pooled guaranteed investment contract with insurance company which is reported at contract value (see Note D). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies using information provided by the investment advisor, custodian, and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Contributions** - Participant contributions and the related Plan Sponsor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

If a participant ceases to make loan repayments, the Plan Administrator deems the participant loan to be in default. In lieu of recording an allowance for doubtful notes receivable, the participant loan balance is reduced, and a benefit payment is recorded for both financial statement and Form 5500 purposes.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Administrative Expenses** - Administrative expenses, including third party administrative expenses and direct investment management fees, are paid by the Plan and allocated to participant accounts. Fees attributable to loans, distributions, and deferred payouts are paid by the participants. Investment related expenses are included in net appreciation of fair value of investments. All other expenses of maintaining the Plan are paid by the Plan Sponsor.

**Subsequent Events** - The Plan has evaluated subsequent events through July 9, 2025, which is the date the financial statements were available to be issued.

**C. INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (“VRIAC”), the custodian of the Plan.

**D. POOLED GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (“GIC”) with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a monthly basis for resetting. The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by VRIAC represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2023 and 2022 was \$444,648 and \$190,803, respectively.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet financial obligations. The issuer’s ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

### E. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") guidance in these financial statements are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Security and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**F. RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the VRIAC. VRIAC also provides certain administrative services to the Plan pursuant to a Service Agreement (“SA”) between the Organization and VRIAC. VRIAC receives revenue from mutual fund service providers for services VRIAC provides to the funds. This revenue is used to offset certain amounts owed to VRIAC for its administrative services to the Plan. The transactions involving these investments are allowable party-in-interest transactions under ERISA.

If the revenue received by VRIAC from such mutual fund service providers exceeds the amount owed under the SA, VRIAC remits the excess to the Plan’s expense account for services of expenditures (“EASE”). The amount allocated to the EASE account is directly attributable to excess fund revenue in the amount of 0.45% after one year of Plan’s assets invested in the mutual funds and Fixed Plus Account III under the SA. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to VRIAC for administrative expenses not covered by revenue sharing. No revenue was received from service providers during the year ended December 31, 2023.

**G. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their employer contributions.

**H. FEDERAL INCOME TAX STATUS**

The Plan has adopted a pre-approved defined contribution plan document provided by National Associates Inc. National Associates Inc. has received an opinion letter, dated March 31, 2017. The opinion letter states that the pre-approved plan is acceptable under section 401 of the IRC for use by employers for the benefit of their employees. Subsequently, the Plan has been amended. However, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
