### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Paulsen, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of Plan**

The following description of the Paulsen, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan covering all employees of Paulsen, Inc. (the Company) who have completed one year of eligible service (1,000 hours of service) and are age eighteen or older. Company employees become eligible to participate in the Plan on April 1, July 1, October 1, and January 1 following their initial eligibility date. The Plan is administered by the Paulsen, Inc. 401(k) Profit Sharing Committee (the Committee or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Contributions**

Participants may choose to contribute a percentage or a fixed amount of their annual pay, as defined in the Plan, provided the contribution does not exceed limitations set by the Internal Revenue Service, through either pre-tax or after-tax Roth contributions. Participants who have attained age fifty before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute rollover contributions from other qualified plans. The Company may elect to make 401(k) matching contributions equal to 50% of the first 6% of compensation a participant contributes to the Plan. The Company made matching contributions of \$203,300 and \$212,389 for 2025 and 2024, respectively. The Company also has the option to make additional discretionary contributions, of which there were none in 2025 and 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

**C. Participants Accounts**

Each participant account is credited with the participant's contribution, allocations of Company matching and discretionary contributions, allocations of Plan earnings and losses, and is charged with an allocation of administrative expenses. Allocation of Plan earnings, losses, and administrative expenses is based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**D. Vesting**

Participants are immediately vested in their contributions and actual earnings (losses) thereon. Vesting in the Company contributions is based on years of continuous service. A participant becomes 100% vested after three years of continuous service as defined in the Plan agreement.

**E. Payment of Benefits**

On separation of service or when the participant has attained age 59 ½, a participant may receive a lump-sum cash settlement equal to the value of the participant's vested balance in his or her account, or the participant may elect to remain in the Plan in an inactive status until the age when required minimum distributions begin.

**F. Forfeited Accounts**

Forfeited accounts can be used to pay plan expenses or reduce Company matching or discretionary contributions. At March 31, 2025 and 2024, there were no significant forfeited non-vested accounts, available or used during the year.

**2. Summary of Significant Accounting Policies**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recognized as earned. Net appreciation (depreciation) in the fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

**D. Payment of Benefits**

Benefits are recognized when paid.

**E. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2025 excess contributions to the applicable participants in 2026.

**F. Expenses**

Administrative expenses can either be paid by the Company or by the Plan. Expenses paid directly by the Company are excluded from these financial statements. Investment related expenses are included within the net appreciation (depreciation) in fair value of investments.

**G. Subsequent Events**

Management evaluated transactions and events occurring subsequent to March 31, 2025, and through October 31, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

**H. Risk and Uncertainties**

The Plan invests in various investment securities which are exposed to interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the value will occur, that such changes could materially affect participant account balances and the amount reported in the statements of net assets available for benefits.

**3. Investments**

Investments disclosed in the financial statements and supplemental schedule at March 31, 2025 and 2024 and the net appreciation (depreciation) in fair value of investments and interest income for the years then ended, were obtained from information supplied by the Plan Administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya). **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level is based on the lowest level of any input that is significant to the measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

*Pooled Separate Accounts (PSA):* Are valued at net asset value (NAV), based upon the market value of its underlying investments, which may include equities, bonds, real estate, mutual funds, separate accounts and collective trust funds. The NAV's for PSA's are not publicly quoted prices in an active market.

*Fixed Income Account:* The plan's investment in the fixed income account is issued by Voya. The investment is valued at adjusted contract value, which is the original contributed amount, plus credited interest, plus (less) a market value adjustment. This adjusted contract value approximates fair value.

**6. Related-Party Transactions**

Plan investments are managed by Voya which is also the issuer of the Plan investments. These transactions, therefore, qualify as party-in-interest transactions. Fees incurred by the plan for these investment management services are included in the net appreciation (depreciation) in fair value of investments rather than a direct payment.

**7. Tax Status**

The Plan is a pre-approved non-standardized plan created by the Plan's third-party administrator and adopted by the Company effective April 1, 2020. The Internal Revenue Service determined and issued an opinion letter that the pre-approved plan as of June 30, 2020 is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan. However, the Plan administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by tax authorities. The Plan administrator has analyzed tax positions taken by the Plan, and concluded as of March 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
