Opinion

We have audited the financial statements of Delta Industries, Inc. Employee Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits (cash basis) as of March 31, 2025 and 2024, the related statement of changes in net assets available for benefits (cash basis) for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan on a cash basis as of March 31, 2025 and 2024, and the changes in its net assets available for benefits for the year ended March 31, 2025, in accordance with cash basis of accounting described in Note 2.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). NOTES TO FINANCIAL STATEMENTS (CASH BASIS)

Note 1. Description of the Plan

The following description of the Delta Industries, Inc. Employee Benefits Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a self-insured welfare plan sponsored by Delta Industries, Inc. (the "Company"), which provides health benefits to substantially all full-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan purchases insurance policies to cover excess medical expense indemnity.

Benefits

The Plan provides certain medical, vision, dental and prescription drug coverage for employees electing to participate who have at least 30 standard hours per week. The Plan begins coverage on the first day of the month after 60 days of continuous employment. The Plan also covers eligible dependents of participants. Benefits are available after termination of employment as required by the Consolidated Omnibus Budget Reconciliation Act of 1986 ("COBRA").

The Plan also provides health benefits to participants during periods of employer-certified disability, leave of absence or layoff and during periods of family medical leave subject to the provisions of the Family and Medical Leave Act of 1993 ("FMLA").

Health benefit claims of active participants and covered dependents are processed by the recordkeeper, but the responsibility for payments to participants and providers is retained by the Plan.

The Company has the right under the Plan to modify the benefits provided to all participants of the Plan.

Contributions

The Plan agreement provides that the Company and employees will make contributions to the Plan. Employee contributions are withheld through payroll deductions and remitted by the Company. The Company contributes premiums for both individual and dependent coverage. Premium rates are determined by the Company based on recommendations of the Plan's insurance consultants.

Note 2. Significant Accounting Policies

Basis of Accounting

The accounting records of the Plan are maintained on the cash basis of accounting.

Investment Valuation and Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest income is recognized when received.

Note 2. Continued

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and schedule. Actual results could differ from those estimates.

Payment of Health Claims

Health claims are recorded when paid.

Contract Administrator Fees and Reinsurance Premiums

The Plan has an administrative agreement with Fox Everett, a division of HUB International ("HUB") to process all health claims. Such claims are paid by HUB from the Plan's trust after approval from the Company has been granted. The Plan pays expenses charged by HUB for administering the Plan. The Plan has a reinsurance policy to cover medical health claims over specified limits. Premiums for this policy are paid by the Plan. Stop loss refunds totaling \$278,609 have been netted with health claims paid in the accompanying statement of changes in net assets. The Plan also pays trustee fees to Trustmark National Bank ("Trustmark"). All other expenses, including professional fees, are paid by the Company.

Note 3. Claims Incurred but Not Reported

Management estimates the liability currently payable for claims incurred but not reported from historical claims payment information provided by HUB. The estimate for this liability was approximately \$600,000 and \$575,000 at March 31, 2025 and March 31, 2024, respectively.

Note 4. Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Note 4. Continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value, on a recurring basis. There have been no changes in the methodologies used as of March 31, 2025 or 2024.

Interest bearing deposit account: Carrying amount approximates fair value due to the short-term maturity of this instrument (Level 1).

Note 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are interest bearing deposit funds managed by Trustmark. Trustmark is the trustee of the Plan assets as defined by the Plan and therefore, these transactions qualify as exempt party-in-interest transactions. The Plan paid fees totaling \$733 to Trustmark in connection with trustee and investment management services. Additionally, the Plan paid fees totaling \$237,563 to HUB in connection with contract administration services provided to the Plan that qualified as exempt party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, claims incurred prior to the termination of the Plan will be paid from the net assets of the Plan and additional contributions from the Company, if necessary.

Note 7. Income Tax Status

The trust funding the Plan has received an exemption letter from the Internal Revenue Service dated February 23, 1989, stating the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the "Code").

The Plan has been amended since the issuance of the exemption letter. The Plan and trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust is tax-exempt.

Note 8. Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk include cash deposits placed with financial institutions. The Plan maintains its cash in bank accounts which, at times, may exceed federally insured limits as guaranteed by the Federal Deposit Insurance Corporation. At March 31, 2025, those accounts exceeded the federally insured limit per bank by \$616,913. The Plan has not experienced any losses on such accounts. The Plan believes it is not exposed to any significant credit risk on its bank deposits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 29, 2025, the date these financial statements were available to be issued. No subsequent events have occurred that require recognition or disclosure.
