Dear SOUTH CENTRAL PLANNING & DEVELOPMENT COMMISSIO:

The U.S. Department of Labor has offered guidance on the duty of insurance companies to provide information to plan administrators on commissions and fees paid to producers. The Department rendered Advisory Opinion 2005-02A on ERISA Section 103 and the reporting of these commissions and fees. As required by those provisions, the appropriate commission and fee information is being provided to you herein within 120 days of the end of the plan year.

The following information is being provided to help you better understand how we report our direct commissions and indirect compensation paid to brokers and agents:

- \* *Direct commissions* are based on straight commissions paid on plan year.
- \* *Indirect compensation* includes quarterly bonuses and incentive trips. Indirect compensation can vary significantly from year to year, since it is based on many factors, including the size of a producer's block of business, profitability, persistency and growth of that block of business. Indirect compensation is calculated on a calendar year. Additionally, indirect bonus income is *not* part of your premium and is paid by Blue Cross based on the factors above.
- \* *Bonuses* are allocated to each group based on their percentage of the producer's total premium dollars.
- \* The incentive trips are awarded based on the qualifying application count of each group. The percentage of the trip cost allocated to the group is based on the total block of new business per producer.

Below are the Direct Commissions paid to each producer, based on the plan year, as well as Indirect Compensation, based on the calendar year 2024 Form 5500. The direct commissions listed were paid to these producers for their services to your group. Please note that all other information is calculated using your plan year. We certify the accuracy and completeness of this information, which should serve as written assurance of the truth of the information provided herein.
