1. Plan Description

The following description of Halo Network 403(B) ERISA Plan (the "Plan"), which provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering eligible employees of Halo Network, Inc. (the "Organization"). The Plan was originally effective January 1, 2018 and amended and restated March 4, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Eligibility – All employees of the Organization (except employees who are nonresident aliens and semimonthly self-directed staff) are immediately eligible to make elective deferrals in the Plan and receive employer matching contributions. Employees must complete one year of service in order to participate in employer non-elective contributions.

Contributions – Eligible employees electing to participate in the Plan may contribute between 1% and 100% of their compensation, subject to certain limitations as set forth in section 401(g) of the Internal Revenue Code (the "Code"), into their respective accounts. Roth 403(b) deferrals are permitted and will be matched. Effective January 1, 2022, the Organization will automatically withhold 3% of the employee's compensation each payroll period and contribute that amount to the Plan as an elective deferral.

The IRS maximum dollar limit for elective deferrals was \$23,000 in 2024. All participants who have attained age 50 by the close of the plan year may elect to make catch-up contributions, subject to certain limitations. There are two different types of 403(b) contributions permitted under the Plan: pre-tax 403(b) contributions and Roth 403(b) contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Organization may elect to make a discretionary non-elective contribution to participants who have completed 1,000 hours of service and are employed at the end of the plan year. The employer contribution is allocated based upon the percentage of compensation or dollar amount per participant. Each eligible participant shall receive an allocation of the employer contribution and such allocation will be based on the participant's classification. There shall be a separate classification for each participant identified by the participant's name. A list of each classification and the associated percentage or dollar amount shall be prepared for each Plan year not later than the time prescribed by law for filing the return for such applicable taxable year (including any extensions), and shall be maintained as part of the administrative records of the Plan. The employer contribution to the Plan is determined at the sole discretion of the Organization not to exceed the maximum amount deductible under all applicable codes. The Organization's discretionary non-elective contribution for 2024 was \$134,131.

The Organization will make a safe harbor matching contribution calculated as 100% of the elective deferral that does not exceed 3% of compensation, plus 50% of the elective deferral that exceeds 3% of compensation but does not exceed 5% of compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan. Organization contributions are automatically invested based on each participant's election. The Plan currently offers various mutual funds and collective trusts as investment options for its participants.

Participant Accounts – Each participant's account is credited with the participant's contributions and as well as allocations of (a) the Organization's discretionary non-elective contribution (if any), and (b) Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their own contributions plus actual earnings thereon. The Organization's discretionary non-elective contributions vest 20% after one year of service and 20% on each of the second, third, fourth and fifth anniversaries thereafter.

1. Plan Description – continued

Participant Notes Receivable - The Plan permits participants to borrow from their pre-tax elective deferral, Roth elective deferral, and rollover accounts. Loans are not available from the matching or profit sharing accounts. The minimum loan is \$1,000 and the maximum loan is equal to the lesser of \$50,000 or 50% of the vested interest of the participant's account balance. Participant loans are secured by the participants' accounts and bear interest at rates ranging from 5.50% to 9.50%. Repayments are required to be made by payroll deductions. The maximum loan term is five years, with exception of loans used to purchase the participant's principal residence, the terms of which may exceed five years.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or equal installments. If a participant's vested account balance at the time of termination of service is less than \$5,000, the vested account balance will be automatically distributed as soon as administratively feasible after termination of employment. In-service distributions may be made to a participant provided the participant has attained age 59 ½. Under certain circumstances, the Plan may permit hardship withdrawals.

Forfeitures – At December 31, 2024, forfeited nonvested accounts totaled \$63. Under the terms of the Plan, forfeited nonvested accounts will be used to reduce future employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and insurance company. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits – Benefits are recorded when paid.

Expenses - All expenses of maintaining the Plan are paid by the Organization, except for accounting and loan processing fees of \$9,816. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

3. Certified Investments (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C). These institutions were as follows; Principal Trust Company for the period January 1, 2024 through January 31, 2024 and Empower Trust Company, LLC, and Empower Life & Annuity Insurance Company of New York for the period February 1, 2024 through December 31, 2024.

4. Fair Value Measurements (Unaudited)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in markets that are not active.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Fully Benefit – Responsive Investment Contract

The Plan entered into a traditional investment contract with Empower Life & Annuity Insurance Company of New York. This contract met the fully benefit- responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value was \$891 at December 31, 2024. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The traditional investment contract held by the Plan is a group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed in the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan).
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Premature termination of contracts.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and group annuity contract managed by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York. Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan allows for transactions with certain parties who may perform services of have fiduciary responsibilities of the Plan. These transactions permitted under the provision of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder.

8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax.- exempt status for plan participants under Section 403(b). Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has undertaken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Delinquent Participant Contributions

The Organization remitted certain participant contributions and loan repayments to the trustee later than required by Department of Labor ("DOL") Regulation 2510.3-102. Participant accounts will be credited with the amount of investment income that would be remitted on a timely basis as required by DOL guidelines.
