### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of APG Electric, Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of February 28, 2025, and December 31, 2024, and the related statement of changes in net assets available for benefits for the period ended February 28, 2025 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of February 28, 2025, and December 31, 2024, and for the period ended February 28, 2025, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination**

We draw attention to Note 5 of the financial statements, which describes the termination of the Plan effective February 28, 2025. As a result of the termination, all plan assets and participant account balances were transferred to the Kelso Industries, LLC 401(k) Plan, a qualified successor plan sponsored by a different employer. The transfer was executed in accordance with ERISA and IRS guidelines. Our opinion is not modified in respect of this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one period after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

**Note 1—Description of the Plan**

The following is a description of the APG Electric, Inc. 401(k) Profit Sharing Plan (the “Plan”) and provides only general information of the major Plan provisions. Participants should refer to the Plan document for more complete information.

*General* – The Plan was established by APG Electric, Inc. (the “Company” or “Employer”) as a defined-contribution plan effective January 1, 1994. The Plan is a single-employer plan and permits the employees of the Company to participate in the Plan. The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Plan Termination* – Effective February 28, 2025, the Plan was terminated and its assets and obligations were transferred to Kelso Industries, LLC 401(k) Plan. The termination was carried out in accordance with applicable regulatory requirements and the provisions of the Plan document. Following the transfer, the Plan ceased all operations and no longer holds assets or liabilities.

*Plan Administration* – The Plan is administered by the Company. The Plan’s assets were maintained by Empower Trust Company, LLC (the “qualified institution”) as of February 28, 2025 and December 31, 2024 and for the period ended February 28, 2025.

*Participation* – All employees of the Company who have completed at least one year of service are eligible to participate in the Plan. The Plan provides for entry dates as of the first day of each quarter.

*Contributions* – Contributions to provide benefits under the Plan are made by participants and the Company. Participants may contribute the maximum allowed under Section 402(g) of the Internal Revenue Code (“IRC”). Participants who have attained the age of 50 are eligible to make pre-tax catch-up contributions, subject to certain limitations. In addition, the Plan accepts rollovers from other tax-qualified plans. Participants are automatically enrolled into the Plan upon the attainment of relevant eligibility provisions at a deferral rate of 3%. The Company may contribute qualified nonelective-matching contributions and other Company matching contributions at its discretion. The Company matched 50% of employee contributions, up to the maximum participant contribution allowed by the IRC, for the period ended February 28, 2025.

*Participant Accounts* – Each participant’s account is credited and/or reduced with the participant’s contributions and withdrawals, Employer-matching contributions, and allocations of Plan earnings and losses. Allocations are based on participant earnings, participant elective contributions, or account balances, as defined. The benefit to which a participant is entitled is the vested balance in the participant’s account.

*Vesting* – Participants are immediately vested in their employee contributions and rollovers, plus or minus any earnings or losses thereon. Vesting of Employer-matching contributions, plus or minus actual earnings or losses thereon, is based on periods of credited service. A participant is 100% vested after six periods of credited service as follows:

If a participant's service is terminated due to retirement, disability, or death, the Employer-matching contributions are deemed to be fully vested.

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than two loans outstanding at any given time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five periods, unless the loan was used to acquire a principal residence, in which case the repayment period may exceed five periods. Notes are secured by the vested balances in participants' accounts.

*Payment of Benefits* – Distribution of a participant's vested account balance to the participant or his or her beneficiary may commence upon the retirement, death, disability, or separation from service. Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in a single lump-sum payment or direct rollover. Distributions are subject to the applicable provisions of the Plan Agreement.

The Plan allows, in certain hardship situations as defined in the Plan Agreement, participants to withdraw amounts from their account balances while actively employed. A participant experiencing financial hardship may, with sufficient evidence, withdraw a portion of their account attributable to employee contributions and rollover contributions. The amount of the withdrawal may not be greater than the immediate financial need. These hardship withdrawals are subject to IRC restrictions and penalties.

*Forfeitures* – Any nonvested portion of Employer-matching contributions credited to the accounts of participants who withdraw from the Plan are forfeited and used for either payment of eligible administrative expenses or to reduce employer-matching contributions. The Plan had forfeiture balances of \$-0- and \$845 as of February 28, 2025 and December 31, 2024, respectively. The Company used approximately \$70,495 of forfeitures to pay administrative expenses during the period ended February 28, 2025.

**Note 2—Summary of significant accounting policies**

*Basis of Presentation* – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Accounting Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the period. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

*Fair Value Measurement* – The methods used to measure fair value of the Plan's investments may produce amounts that may not be indicative of net realizable value or may not be reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There were no transfers between levels during the period ended February 28, 2025.

*Mutual Funds* – Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are included within Level 1 of the fair value hierarchy.

*Common Collective Trust* – This investment is a public-investment vehicle valued using NAV as a practical expedient provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The Common Collective trust investment has not been classified under the fair value hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits are recorded when they have been processed and paid by the Plan.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and, are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants and certain participants distributions are included in administrative expenses and charged directly to the participant’s account.

**Note 3—Information certified by the qualified institution (unaudited)**

Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. The qualified institution has certified to the completeness and accuracy of the following data included in the accompanying financial statements and was not subjected to any auditing procedures performed by the independent public accountant:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of February 28, 2025 and December 31, 2024.
- Net appreciation in fair value of investments, interest and dividends from investments, and interest income on notes receivable from participants as shown in the statement of changes in net assets and available for transfer out for the period ended February 28, 2025.

The Plan’s independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements.

**Note 5—Plan termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances. Effective February 28, 2025, the Plan was terminated and its assets and obligations were transferred to Kelso Industries, LLC 401(k) Plan. The termination was carried out in accordance with applicable regulatory requirements and the provisions of the Plan document. Following the transfer, the Plan ceased all operations and no longer holds assets or liabilities

**Note 6—Party-in-interest transactions**

Certain Plan investments are shares of mutual funds managed by Empower Retirement, the third party administrator of the Plan and an affiliate of the qualified institution; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the period for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transaction rules (ERISA, Title 1, and Section 401(b)).

**Note 7—Income tax status**

The Plan is a non-standardized prototype plan which obtained its latest opinion letter dated November 14, 2022, from the IRS, stating the Plan is designed in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and, has concluded that, as of February 28, 2025 and December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
