Note 1: DESCRIPTION OF THE PLAN

The following description of The Blossman Companies, Inc. Employee Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined benefit health and welfare plan established to provide medical and other benefits to substantially all employees of The Blossman Companies, Inc., its subsidiaries, and affiliate, Abston Transport Co., Inc. (collectively, the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan Administrator and the Board of Directors of the Company is responsible for oversight of the Plan.

Benefits

Benefits are recognized when paid and are presented net of reinsurance refunds. The Plan provides benefits to all employees who have a scheduled work week of thirty hours or more. Each active full-time employee regularly scheduled to work at least 30 hours per week is also eligible to participate upon retirement. An employee may elect retirement on or after one of the following points in time:

1. The birthday when the employee reaches an age that is three years earlier than the age at which the employee would be eligible for Medicare coverage and has at least ten years of continuous employment with the Company.
2. The birthday when the employee reaches an age that is five years earlier than the age at which the employee would be eligible for Medicare coverage and has at least twenty-five years of continuous employment with the Company.
3. The birthday when the employee reaches an age at which the employee would be eligible for Medicare coverage.

Employees electing retirement under options 1 or 2 above, who, at the time of retirement have not yet reached Medicare eligible age, and/or have one or more dependents under Medicare eligibility age covered with the Plan, are allowed to purchase medical coverage under the Plan for themselves and/or such eligible dependents, at the same cost as they would pay if they were still an active employee. Such coverage eligibility continues for the employee or for eligible dependents until the employee or a covered dependent becomes eligible for Medicare, or for five years, whichever comes first. An employee retiring before accumulating at least ten years of continuous employment with the Company is not eligible to continue participation in the medical coverage provision of the Plan for the employee or the employee’s dependents.

Contributions

The Company’s estimates of contributions are determined by the Plan Administrator but are only funded as cash flow needs dictate. An employee may contribute specified amounts, as determined by the Plan Administrator, to extend medical coverage to eligible dependents of the employee. The excess of plan benefit obligations over net assets will be funded through future Company contributions.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Claims

Plan liabilities for estimated claims incurred but not reported are estimated by the administrator of the Plan. Estimated claims incurred but not reported are based on actuarial techniques. Estimated claims incurred but not reported are \$757,000 and \$651,000 for the years ended December 31, 2024 and 2023, respectively.

The Company purchases separate reinsurance to cover the excess over certain specific and aggregate stop loss limitations. Reinsurance refunds and amounts expected to be refunded of approximately \$1,396,000 and \$1,089,000 in 2024 and 2023, respectively, have been netted against claims paid in the accompanying statements of changes in net assets available for benefits and the statements of changes in plan benefit obligations.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets and changes in plan benefit obligations during the reporting period. Actual results could differ from those estimates. Because of the inherent uncertainties in estimating claims incurred but not reported, it is at least reasonably possible that these estimates will be adjusted as more current information becomes available, and any adjustment could be significant.

Reinsurance Receivable

The Plan maintains specific and aggregate stop-loss coverage. Reinsurance recoveries are recognized as a receivable when the related claims are incurred, with claims expense reported net of expected recoveries. Premiums are expensed as incurred. The Plan assesses collectability of the receivable and records an allowance when necessary. Reinsurance does not relieve the Plan of its primary obligations. The Plan maintains specific and aggregate stop-loss coverage. Reinsurance recoveries are recognized as a receivable when the related claims are incurred, with claims expense reported net of expected recoveries. Premiums are expensed as incurred. The Plan assesses collectability of the receivable and records an allowance when necessary. Reinsurance does not relieve the Plan of its primary obligations.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 29, 2025 and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: PLAN BENEFIT OBLIGATIONS

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service already rendered. Postretirement benefits include future benefits expected to be paid to or for (1) certain currently retired or terminated employees and their beneficiaries and dependents and (2) certain active employees and their beneficiaries and dependents after retirement from service with the participating employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant (less contributions to be received from retirees) and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. As of December 31, 2024 and 2023, no explicit changes, either benefit increases or decreases, of the postretirement medical benefits plan have been assumed for the period subsequent to the actuarial valuation, except as may be implicitly constrained by the health care cost trend rate.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 introduced a prescription drug benefit under Medicare Part D as well as a federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.1. However, the actuary's valuation assumes the Plan is not actuarially equivalent under the Act because the Plan does not provide post-65 benefits. Therefore, the Plan's benefit obligations and changes in benefit obligations do not reflect any Medicare subsidy amounts.

For measurement purposes, as of December 31, 2024, a 7.00% annual rate of increase in the per capita cost of covered health care benefits was assumed for 2024 (6.25% assumed for 2023 at December 31, 2023); the rate was assumed to decrease gradually to 5.60% in 2027. The weighted average health care cost trend rate assumption has significant effects on the amounts reported as postretirement benefit obligations. If the rate changed by 1 percentage point in each year, as of December 31, 2024 and 2023, the obligation would increase by \$211,000 and \$195,000, respectively, or decrease by \$192,000 and \$177,000, respectively.

The weighted-average periodic discount rate through June 30, 2024 and 2023 was 4.79% and 4.09%, respectively, and was 5.14% and 4.79% as of December 31, 2024 and 2023, respectively. Mortality benefits were computed using the Pri-2012 Blue Collar Headcount Weighted Mortality Table projected under Improvement Scale MP-2021 for 2024 and 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the Plan benefit obligations.

Note 4: TAX STATUS

Although there is no determination letter program for health and welfare plans, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of Section 501(a) of the Internal Revenue Code and is therefore exempt from taxation.

Note 4: TAX STATUS (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

Note 6: ADMINISTRATIVE EXPENSES

The Plan paid administrative expenses of approximately \$583,000 and \$582,000 for the years ended December 31, 2024 and 2023, respectively, to third-party claims administrators. These expenses are reported in the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.


