Our organization, Illinois Respite Coalition, Inc., is a small 501c3 organization with total net assets of under \$500,000. In accordance with recent Illinois state law, we recently were required to offer a retirement program to our employees and established the Illinois Respite Coalition 401K plan (EIN 03-0516173).

For calendar year 2024, we established a plan and despite having only \$25,626 in the plan, became aware of the need to have an audit due to the way the plan was established and the number of total active participants in the plan.

In coordination with Human Interest, our new retirement plan consultant, we have now properly structured the plan to be more in line with the total size of the plan assets and accordingly will not require an audit going forward. In light of the fact that an audit of the plan for 2024 would likely cost approximately 50% of the total plan assets at 12/31/24, we respectfully request a one-time waiver from the audit requirement.
