Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Williams & Connolly LLP Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Williams & Connolly LLP Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan that was created, effective July 1, 1985, to reward eligible employees for their loyal service, accumulate funds for their later years and provide funds for their beneficiaries in the event of death or disability. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's Pension Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

An eligible employee shall be any person who is a self-employed person under Section 401(c)(1) of the Internal Revenue Code (IRC) with respect to the Partnership who is eligible to participate in the Williams & Connolly LLP Profit Sharing Plan or is a key employee and any employee, other than a leased employee or an attorney who is not a self-employed person under Section 401(c)(1) of the IRC, who was hired by the Partnership prior to January 1, 2008 and has completed two years of service prior to January 1, 2010. Long-term part-time employees who met eligibility requirements under the SECURE Act are also eligible to participate in the Plan.

Master Trust

As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan's trustee was Charles Schwab Trust Bank (the Trustee). Williams & Connolly LLP (the Partnership) has a master trust arrangement (the Master Trust) with the Trustee for the investment of assets of the Plan along with the assets of three other retirement plans sponsored by the Partnership.

A participant may direct contributions into a variety of investment options available through the Master Trust.

Contributions

Nonhighly compensated participants are eligible to contribute 100% of their earnings into the Plan, while highly compensated participants are limited to 20%. The Plan also permits participants to contribute a percentage of their after-tax compensation to a Roth 401(k) account within the Plan, at the participant's election in lieu of all or a portion of a pre-tax deferral contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions are subject to the limitations of the IRC.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a default investment option designated by the Pension Committee until changed by the participant.

Vesting

Participants are 100% vested in the Plan. Each participant's account is credited with the participant's contribution and allocations of the Plan's earnings based on participant account balances.

Notes Receivable From Participants

The Plan permits participant loans based on the provisions of the plan document. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. Principal and interest are paid ratably through payroll deductions. Loan terms cannot exceed five years. Upon termination of employment, a participant's loan becomes due immediately.

Payment of Benefits

Termination of employment, disability, hardship, attainment of age 59½, qualified birth or adoption, or termination of the Plan are causes for distribution of the value of each participant's account balance, as set forth in the plan document. The plan document contains automatic distribution provisions if a terminated participant's vested balance is less than \$7,000. If no method of distribution is specified by the participant, distributions of vested balances less than \$7,000 will be distributed to an individual retirement account designated by the plan administrator; however, distributions under \$1,000 will be paid out in the form of a cash lump sum payment.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments, held in the Master Trust, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian/trustee. See Note 3 for discussion of fair value measurements.

The Plan's interest in the investment gain (loss) of the Master Trust, in the accompanying Statement of Changes in Net Assets Available for Benefits includes the Plan's allocation of interest, dividends, net appreciation (depreciation), including the gains and losses on investments bought and sold as well as held during the year, and fees charged to the Master Trust, which are netted against or included with net appreciation (depreciation) in fair value of investments. These fees represent charges by the Trustee for services provided in connection with recordkeeping and investment management. Net unrealized appreciation (depreciation) in fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investments as of the beginning of the period or the cost of the investment if purchased during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Transfers to or From Affiliated Plan

From time to time, employees may no longer meet the eligibility requirements of the Plan and become eligible to participate in another qualified plan sponsored by the Partnership, or vice versa. These employees have their account balances transferred between the Plan and another qualified plan sponsored by the Partnership.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses, including investment advisory fees and accounting fees, are paid by the Partnership. Transaction expenses are paid by either the participant or the Plan.

Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory and certain optional provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Master Trust has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Master Trust are deemed to be actively traded.

Investments measured at NAV: Consisting of common-collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Master Trust to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts: Consisting of investments in cash and interest-bearing cash, U.S. treasury notes, money market funds/cash equivalents, common stocks/exchange traded funds/unit investment trusts, mutual funds, corporate bonds/municipal bonds, convertible debt obligations and preferred stocks. Cash and interest-bearing cash are reported at carrying value, which approximates fair value. U.S. treasury notes are valued using pricing models maximizing the use of observable inputs for similar securities. Money market funds/cash equivalents are valued at the quoted NAV of shares held by the Master Trust at year end. Common stocks/exchange traded funds/unit investment trusts are valued at the closing price reported on the active markets on which the individual securities are traded. Corporate bonds/municipal bonds/convertible debt obligations are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. Preferred stocks are valued at the closing price reported on inactive markets on which the individual securities are traded.

4. Interest in Master Trust

At December 31, 2024 and 2023 and for the year ended December 31, 2024, the Plan's investments were held in the Master Trust, which was established for the investment of the assets of the Plan along with the assets of three other retirement plans sponsored by the Partnership. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by the Trustee.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At December 31, 2024 and 2023, the Plan's undivided interest in the net assets of the Master Trust was approximately 26%. Total investment income (loss) (including net appreciation (depreciation) in the value of investments) and administrative expenses of the Master Trust are allocated to the individual plans based upon the amount of time the Plan's assets were invested in the Master Trust.

5. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$98,565,686 and \$84,872,540, respectively, that were concentrated in three funds.

6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 with the exception of \$1,360,553 and \$1,329,860 in self-directed brokerage accounts as of December 31, 2024 and 2023, respectively, within the Plan's interest in the Master Trust, and \$3,307 of investment income for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by an affiliate of the Trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Master Trust for the investment manager services are included in Plan interest in the master trust investment gain (loss), as they are paid through revenue sharing, rather than a direct payment.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Partnership. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Additionally, the Partnership reserves the right, by appropriate action, to amend the Plan. However, any such action will not deprive any participant, former employee or beneficiary under the Plan of any vested right he or she may have, except to the extent that laws or regulations may preclude such vesting in order to prevent discrimination in favor of officers, partners or highly compensated employees.

9. Tax Status

The IRS has determined and informed the Partnership by a letter dated October 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
