Independent Auditor's Report

The Board of Directors of Bronx Parent Housing Network, Inc. as the Sponsor of Housing Solutions of New York 403(b) Plan

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Housing Solutions of New York 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Notes to Financial Statements December 31, 2024 and 2023

#### Note 1 - Description of the Plan

The following brief description of the Housing Solutions of New York 403(b) Plan (the "Plan") is provided for general information purposes only. Readers should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was established by Bronx Parent Housing Network, Inc. (the "Company" or the "Sponsor") on January 1, 2017 and has been amended since. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### General

The Plan is a defined contributions retirement plan established pursuant to Section 403(b) of the Internal Revenue Code (the "Code") that allows employees to defer a portion of their salaries for tax purposes through contributions to the Plan from payroll deductions.

#### Eligibility

The Plan covers all employees of the Sponsor who meet minimum service requirements and are not a non-resident alien who do not receive any compensation from U.S. sources. Employees become eligible to participate in employee deferrals after 30 days of service. Participants in the Plan who are covered under a collective bargaining agreement are not eligible for matching or employer contributions.

#### Contributions

Each year, participants of the Plan may contribute up to any percent of pre-tax annual compensation, as defined in the Plan. Participants can contribute pre-tax and Roth amounts up to the amount allowed under the Internal Revenue Service ("IRS") rules. Participants who have attained age 50 before the end of the Plan year, and who are making regular contributions, are eligible to make catch-up contributions. The Plan allows for discretionary match and discretionary employer contributions each year. The Plan provides for separate classes of participants. The contributions are allocated to the employees based on the classes. Participants are also able to make rollover contributions from other plans.

#### Vesting

Participant contributed funds arising from elective deferrals and non-elective deferrals, and the earning thereon, are fully vested at all times. Prior to January 1, 2021, employer contributions were vested based on the following:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,946 and \$126,197, respectively, and \$135,895 was used to offset the Sponsor's contributions under the Plan in 2024.

#### Pension benefits

Participants are entitled to distribution of their vested benefits upon termination of service due to severance of employment, death, disability, retirement, qualified distribution, or termination of the

Plan. A participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested account balance, or an annuity, subject to the finding vehicle. Participants can also receive in-service distributions for hardship and after attaining age 59.5.

#### **Participant account**

Each participant's account is credited with the participant's contributions as well as allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct their account into various investment options offered by the Plan.

#### **Notes receivable from participants**

The loan cannot exceed 50% of the participant's vested account balance or \$50,000, whichever is lower. The minimum loan amount is \$1,000. The loans are secured by the vested balance in the participants' accounts and bear interest from 4.25% to 9.50%. Loan repayments are made through payroll deductions and are generally payable in installments over periods ranging from one to five years unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to 30 years. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

#### **Regulatory compliance affecting retirement plans**

The Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 1.0 Act") became law on December 20, 2019. The SECURE 1.0 Act made major changes to the Required Minimum ("RMD") rules, increasing the age from 70.5 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 Plan year.

The SECURE Act 2.0 ("SECURE 2.0") was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030. The SECURE 2.0 Act increased the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in the 401(k) plans. The rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employees has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The Plan prepares its financial statements using the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United State of America ("U.S. GAAP").

##### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

##### **Payments of benefits**

Benefits payments to participants are recorded upon distribution.

##### **Contributions**

Contributions from the Plan and the matching contributions from the Company are recorded in the year in which participants compensation is earned.

##### **Notes receivable from participants**

Note receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as deemed distributions based on the terms of the Plan agreement and amounted to \$75,607 and \$69,645 for the years ended December 31, 2024 and 2023, respectively.

##### **Investment valuation and income recognition**

Investments are reported at fair value except for the fully benefit-responsive contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Expenses**

Certain expenses incurred for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and investment related expenses are charged directly to the participant's account and are included in net appreciation (depreciation) in fair value investments.

#### Note 3 - Investments: Information prepared and certified by the investment custodian as complete and accurate

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information, and the information contained in the supplemental schedule of assets (held at end of year), was certified as complete and accurate by Empower Retirement LLC ("Empower"), the custodian of the Plan and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

Empower has certified to the completeness and accuracy of the following investment information included in the financial statements as of and for the years ended December 31, 2024 and 2023.

Notes receivable from participants of \$472,484 and \$279,264 as of December 31, 2024 and 2023, respectively, and interest income on notes receivable from participants of \$26,286 and \$19,178 for the years then ended, respectively, have also been certified by the custodian.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or

liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Mutual funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds carried at December 31, 2024 and 2023 were classified as Level 1 and amounted to \$3,871,738 and \$3,443,828, respectively.

#### **Note 5 - Fully benefit-responsive investment contracts**

The Great-West Investments Fixed Account ("GWIFA") is a fully benefit-responsive stable value product that guarantees principal and accumulated interest. Contract value, as reported by Great-West Life & Annuity Insurance Company of New York ("GWLA of NY"), is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses. Guarantees are provided to participating retirement plans through a group annuity contract issued by GWLA of NY. The investment contract is included in the financial statements at contract value. Contributions are directed to a broadly diversified fixed income portfolio within GWLA of NY's general account. Participants may deposit and withdraw on a daily basis at contract value. Participants may also transfer to other investment options in the Plan.

The investment contract does not have any restrictions that impact the ability of the Plan to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. GWLA of NY may not terminate the contract at any amount less than the contract value.

GWLA of NY determines the minimum interest rate based on an interest rate formula. The minimum interest rate credited by GWLA of NY to the GWIFA is subject to change annually, but will always be subject to a range between 1.00% and 3.00%. The annualized gross credit rate under the group annuity contract was 2.85% and 1.55% as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 6 - Related-party transaction and party-in-interest transactions**

The Plan's investments include mutual funds managed by the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are netted with investment earnings. Administrative fees paid for the years ended December 31, 2024 and 2023 amounted to \$61,503 and \$45,772, respectively.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amount reported in the statements of net assets available for benefits.

#### **Note 8 - Plan termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and the balance of participant accounts will be distributed in a lump sum or by delivery of a fully paid annuity contract as permitted by IRS regulations.

#### **Note 9 - Tax status**

The Plan has adopted the Volume Submitter plan which has been determined by the IRS, in an opinion letter dated March 31, 2017, to be in accordance with the applicable sections of the Code. The Plan has been amended since adoption; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
