Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Beistle Company 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### **Note 1 - Description of Plan**

The following brief description of The Beistle Company 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

#### **General**

The Plan was established February 1, 2005. The Plan is a contributory defined contribution plan, which permits participant contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees of The Beistle Company (the Company) are eligible after completing three consecutive months beginning on the employee's date of hire, during which time, the employee completes 500 hours of service and attaining age 18 or older. An employee is not eligible for the Plan if they are covered by a collective bargaining unit, a non-resident alien, or a leased employee.

An employee becomes a participant in the Plan on the first day of the month after the eligibility requirements are met.

#### **Service Rules**

Employees are credited with a year of service for each plan year during which they have at least 1,000 hours of service.

#### **Contributions**

There are five types of contributions that can be added to a participant's account: an employee salary deferral contribution, a rollover contribution, a safe harbor matching contribution, a discretionary employer matching contribution, and a discretionary profit-sharing contribution. Participants may contribute up to 100% of their annual pre-tax compensation by way of salary deferral contribution. Roth contributions are permitted. Employee elective deferral percentages can only be changed as of the first day of the month. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The participants may direct their accounts into several different investment options. Contributions are subject to certain limitations. Safe harbor employer matching contributions in the amount of \$322,312 and \$330,772 were made for the Plan years ended January 31, 2025 and 2024, respectively. No discretionary employer matching or profit-sharing contribution was made for the Plan years ended January 31, 2025 or 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1 - Description of Plan (Continued)**

#### **Vesting**

The participant's salary deferral accounts, rollover accounts, and safe harbor employer contribution accounts are 100% vested at all times. Vesting of discretionary employer matching contributions and discretionary profit-sharing contributions occurs at the end of three years of service. In the case of death or total disability, regardless of length of service, a participant's account becomes 100% vested.

#### **Payment of Benefits**

Upon retirement, disability, or death, distributions will be paid as soon as administratively possible in a lump sum. Upon termination of service other than by retirement, disability, or death, a participant will receive a lump sum payment if the total of their vested account balance, excluding rollovers, does not exceed \$5,000 (increased to \$7,000 effective February 1, 2024). If the account balance exceeds \$5,000 (\$7,000 as of February 1, 2024), the assets will generally be held in a trust until the participant's normal or early retirement date. However, terminated participants may elect to receive their vested accounts as soon as administratively feasible.

#### **Administrative Costs**

Plan expenses attributable to a specific participant's account under the Plan have been charged to such accounts as permitted by law. Investment related expenses are included in net appreciation in fair value of investments. Recordkeeping fees paid by the Plan were direct expenses from Plan assets for the years ending January 31, 2025 and 2024.

#### **Forfeited Accounts**

Forfeitures of any discretionary employer matching and discretionary profit-sharing non-vested accounts are used to pay the Plan's ordinary and necessary administrative expenses in the year of the forfeitures. Any forfeiture attributable to the discretionary contributions not used by the Plan for administrative expenses will be allocated to participants eligible to share in the discretionary contribution in the same proportion that their compensation bears to the total compensation of all such participants in the year of the forfeitures. The ending forfeiture account balance as of January 31, 2025 and 2024 was immaterial.

### **Note 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements follows:

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting. Contributions from employees are recorded in the period in which the Company makes authorized payroll deductions from Plan participants.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

#### **Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Mutual Funds**

Net investment returns reflect certain fees paid by the mutual funds to their affiliated investment advisors, transfer agents, and others, as further described in each fund or account prospectus. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Income Taxes**

The Plan is exempt from federal income taxes under the Internal Revenue Code.

#### **Employer Contributions**

Employer contributions to the Plan are recognized in the period when the Plan sponsor has made a formal commitment to fund such amounts for the period. Contribution receivables include legal or contractual requirements for the employer to make contributions applicable to past periods.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Note 3 - Fair Value Measurements**

FASB ASC Topic 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 - defined as observable inputs such as unadjusted quoted prices in active markets for identical assets
- Level 2 - defined as inputs other than quoted prices for similar assets in active markets that are either directly or indirectly observable
- Level 3 - defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions

### Note 3 - Fair Value Measurements (Continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at January 31, 2025 and 2024.

#### Level 1: Fair Value Measurements

Investments in mutual funds are recorded at fair value based on quoted prices in the relevant active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

### **Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and distribution is to be made by the Trustee.

### **Note 6 - Income Tax Status**

The Plan is operating under an adoption agreement of the prototype defined contribution plan document prepared by Ascensus, Inc. The Internal Revenue Service (IRS) has determined by a letter dated June 30, 2020 that the Ascensus, Inc. prototype plan document was designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's advisors believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to the year ending January 31, 2023.

### **Note 7 - Related Party and Party-in-Interest Transactions**

All of the Plan's investments are shares in various mutual fund accounts which are managed by the Plan's trustee or an affiliated entity. Administrative maintenance charges are paid to the trustee based on the closing market value of the Funds in the mutual fund account as well as the number of participants with account balances. All transactions which may be considered parties-in-interest transactions relate to normal Plan management, investment and administrative services, and the related payment of fees.

### **Note 8 - Risks and Uncertainties**

Investments of the Plan are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect investment assets reported in participant account balances and in the statements of net assets available for benefits.

### **Note 9 - Subsequent Events**

Management has evaluated subsequent events through October 30, 2025, the date the financial statements were issued. Events or transactions occurring after January 31, 2025, but prior to October 30, 2025, that provided additional evidence about conditions that existed at January 31, 2025 have been recognized in the financial statements for the year ended January 31, 2025.
