INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Thumbtack, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Thumbtack, Inc. 401(k) Plan Notes to Financial Statements

1. Description of the Plan

Thumbtack, Inc. (the Company and Employer) established the Thumbtack, Inc. 401(k) Plan (the Plan), effective July 1, 2012, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a Plan Investment Committee, which consists of Company employees. Charles Schwab Trust Bank (Schwab) serves as the Plan's trustee, and Schwab Retirement Plan Services, Inc. (Schwab RPS) serves as the Plan's record keeper. Schwab holds, invests, and reinvests the Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, aged 18 or older, may participate in the Plan on the first day of the month coinciding with or following their date of hire.

Contributions:

Participants are permitted to make voluntary pre-tax, Roth post-tax, and after-tax contributions up to 75% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan has an automatic enrollment feature under which all eligible employees hired or rehired are automatically enrolled in the Plan at a pre-tax deferral rate of 5% of eligible compensation, defined by the Plan agreement, unless they request a different amount to be contributed or formally decline participation. Following the automatic enrollment in the Plan, the salary deferral amount increases 1% on the first day of each subsequent Plan year, to a maximum of 15%, unless the participant requests a different amount to be contributed or formally declines participation. Participants may adjust their salary deferral rate or discontinue their contributions at any time.

Contributions: (continued)

Company contributions are not permitted under the Plan agreement, other than qualified non-elective contributions to satisfy the requirements associated with applicable non-discrimination tests or to correct for Plan operational failures.

Contributions are subject to certain limitations under the Code.

Participant Accounts:

Participant accounts are credited with participant contributions and rollovers, qualified non-elective Company contributions, if any, and an allocation of Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with Plan provisions. The benefit to which participants are entitled is the benefit that can be provided from the participant account balances.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are fully (100%) vested in their account balances.

Payment of Benefits:

Upon termination of employment, participants may elect to receive an amount equal to the value of their account balance. Distributions will be paid as soon as administratively feasible and may be paid in lump sum cash payment, in installment payments or rolled into another qualified retirement plan or individual retirement account, as elected by the participants, subject to certain stipulations as defined in the Plan agreement. The Plan may elect to distribute terminated participant account balances without participant consent, if the balance is \$7,000 or less. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to current employees. Benefits are recorded when paid.

1. Description of the Plan (continued)

Administrative Fees:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance fees are paid by the Plan and charged to participant accounts. All other administrative fees related to the Plan are paid by the Company and are not reflected in these financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investments:

The Plan's investments consist of mutual funds, a money market fund, and participant-directed brokerage accounts. These investments are accounted for as follows:

- *Mutual Funds and Money Market Fund:* These funds are valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.
- *Participant-Directed Brokerage Accounts:* These participant-managed Schwab self-directed brokerage accounts, may consist of shares in various interest bearing cash and other cash equivalents, publicly traded securities, mutual funds, money market funds, over-the-counter equity securities, bonds, and other fixed-income securities valued based on quoted prices in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes, within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- *Level I:* Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- *Level III:* Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

Fair Value Measurement: (continued)

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net investment income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Subsequent Events

Previously, notes receivable to participants were not allowed under the Plan agreement. Effective April 1, 2025, the Plan agreement was amended to allow notes receivable to participants.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
