We have performed audits of the financial statements of Keystone Urology Specialists Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 (liquidation basis) and March 31, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits for the period ended October 31, 2024 (liquidation basis), and the related notes to the financial statements (liquidation basis).

Note 1 – Description of Plan

The following description of Keystone Urology Specialists Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Termination of the Plan

The Company terminated the Plan effective October 31, 2024. In accordance with Plan provisions, all benefit accruals ceased, all participants became fully vested in their accounts, and all contributions ceased. The Company directed the distribution of participant accounts in a manner permitted by the Plan. All participant accounts were distributed by January 16, 2025.

General

The Plan was a defined contribution plan established by Lancaster Urology, PC (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which included a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company and any participating affiliates were subject to the following eligibility requirements:

- Age: None
- Service: 0 months
- Status Exclusions:
 - a. Part-time employees
 - b. Seasonal employees
 - c. Temporary employees

Upon satisfying the eligibility requirements, employees could participate in the Plan immediately upon eligibility.

Contributions

The Plan was funded through employee elective deferrals and Company contributions. Each year, participants could elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or “roll over” into the Plan distributions they had received from other plans and certain Individual Retirement Accounts (IRAs). Participants who had attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The following contribution types were allowed by the Plan:

- Elective deferrals
- Roth deferrals
- Employer profit sharing
- Rollover contributions
- Employer safe harbor

Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan had an automatic enrollment provision (4% salary deferral) whereby employees must have elected out of the Plan if they did not wish to participate.

The Company had elected to operate the Plan as a safe harbor 401(k) plan, which made the plan exempt from certain compliance testing requirements. The Company made a safe harbor contribution of 3% of compensation.

The Company could make discretionary profit sharing contributions which were allocated in accordance with the plan document provisions.

Participant Accounts

Each participant's account was credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, Employer profit sharing and safe harbor contributions, and actual earnings thereon.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allowed forfeitures of non-vested Company contributions to be used as follows:

- Pay administrative expenses
- Reduce Company contributions

As of October 31, 2024 and March 31, 2024, forfeited non-vested accounts totaled \$0 and \$19,006, respectively. During the period ended October 31, 2024, forfeited non-vested accounts of \$24,322 were used.

Investment Options

Upon enrollment in the Plan, a participant could direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant could change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Notes Receivable from Participants

Prior to the Plan's terminations, participants were permitted to borrow from their participant account. The loans were secured by the balance in the participant's account at an interest rate determined by the Plan administrator.

Participants who were active employees could borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, were secured by the balance in the participant's account, and bore interest at reasonable rates, which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions and generally repaid within 5 years.

Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant was entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account were to be made to the designated beneficiary.

The following types of distributions were also allowed by the Plan:

- Termination partial withdrawal
- Hardship
- Involuntary cash-outs
- In service
- Rollover source withdrawal at any time

Plan Expenses

The Plan's expenses were paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the liquidation basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP). Effective October 31, 2024, the Lancaster Urology, PC Board of Directors adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of October 31, 2024 and March 31, 2024 and for the period April 1, 2024 through October 31, 2024 have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of October 31, 2024 and March 31, 2024 would be fair value.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Reclassification

Certain reclassifications may have been made to the March 31, 2024 financial statement presentation to correspond to the current year's format. Total net assets available for benefits are unchanged due to these reclassifications.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

Other Receivable

The other receivable represents investment income and interest on notes receivable from participants that were received after March 31, 2024 and were recognized during the year end March 31, 2024 due to the liquidation of the Plan.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of October 31, 2024 and March 31, 2024. If a participant ceased to make scheduled repayments and the Plan Administrator deemed the participant note receivable to be in default, the participant note receivable balance was reduced and a benefit payment recorded.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

Subsequent events were evaluated through October 31, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the custodian of the Plan.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at October 31, 2024 and March 31, 2024.

Note 5 – Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the period end October 31, 2024, the Plan made direct payments of \$0 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor paid directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services were included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

The Plan participated in an expense offset agreement whereby certain third party expenses were paid with rebates received by the Plan from investment managers. During the period ended October 31, 2024, the Plan received investment manager rebates which were offset against recordkeeper fees. The rebates were included as a reduction to administrative expenses in the statement of changes in net assets available for benefits.

Note 6 – Risks and Uncertainties

Prior to plan termination, the Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Tax Status

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated October 6, 2020, which states that the Plan was designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan was required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of October 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
