We are writing on behalf of Sunshine Movers to respectfully request abatement of any penalties associated with the late filing of our Form 5500 for the plan year ending [insert date].

This was our first full year offering a 401(k)-retirement plan to our employees, and as such, the Form 5500 filing process was entirely new to our organization. Unfortunately, due to an internal oversight, we did not receive the appropriate reminders or instructions in time to file by the deadline. The contact information listed with our plan administrator (ADP) directed all filing notifications to the company owner, rather than to our accounts manager, who is responsible for handling such compliance tasks. As a result, we were unaware of the necessary steps and due dates until we were recently notified of the missed filing.

As soon as we became aware of the issue, we worked promptly to correct it and ensure the Form 5500 was filed. We have also updated the contact information in ADP's system to ensure that future correspondence is received by the correct personnel.

This delay was unintentional and the result of an administrative error during our first year of compliance with 401(k) filing requirements. Sunshine Movers is committed to full compliance with IRS regulations and takes our fiduciary responsibilities seriously. We respectfully request that any penalties associated with the late filing be waived due to reasonable cause.
