### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Newbury Corporation Profit Incentive & Employees' Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Their report also indicated that the form and content of the 2023 supplemental schedule, other

### 1. Description of Plan

The following description of the Newbury Corporation Profit Incentive & Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established November 1, 1973, and restated July 1, 2022. The Plan covers all employees, excluding union employees, leased employees and temporary employees, of Newbury Corporation (the "Company," the "Employer" or the "Plan Sponsor"). All employees of the Company are eligible to participate in the Plan once they have attained the age of 21 years and completed 1,000 hours of service within 12 months from the date of hire or within a plan year following the date of hire with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Newbury Corporation Retirement Plans Committee is responsible for oversight of the Plan. Responsibilities of the Retirement Plans Committee include, but are not limited to, maintaining and enforcing the Plan's investment policies. The trustee of the Plan is Charles Schwab Trust Bank.

#### *Contributions*

Each year, participants may contribute up to a maximum 75% of annual eligible gross compensation, as defined in the plan agreement, up to the maximum limits of the Internal Revenue code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a salary deferral of 5%, with an opt-out provision. Participants may also designate all or any part of their elective deferrals to the Plan as Roth 401(k) deferrals. Participants who are employed at the end of the year and have at least 1,000 hours of service are eligible for additional employer discretionary profit share contributions at the discretion of the Employer's Board of Directors. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. For the year ended December 31, 2024, there were no profit-sharing contributions.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 40% percent vested after two years years of credited service and continues to vest in increments of 20% percent until 100% vested after five years of credited service.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, bear interest at rates that range from 3.25% and 8.50%, as defined. Principal and interest are paid ratably through payroll deductions. Terms range from one year to five years or greater for the purchase of a primary residence.

#### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

#### *Forfeited Accounts*

At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. In accordance with the Plan's provisions, these accounts may first be used to pay Plan expenses, then to reduce Employer contributions. For the year ended December 31, 2024, forfeited non-vested accounts were used to pay expenses of \$4,833 and to reduce Employer contributions by \$13,161.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

Subsequent events were evaluated through October 14, 2025, the date these financial statements were available to be issued.

Effective January 1, 2026, the Company will enhance the Plan by contributing an amount equal to 6% of each eligible employee's compensation into their 401(k) non-elective plan account on a bi-weekly basis, regardless of employee deferrals. In addition, the Company will provide a matching contribution equal to 100% of employee 401(k) and/or Roth contributions, up to 3% of eligible compensation. These changes are intended to strengthen the overall retirement benefits offered to employees and will be accounted for as part of the Company's ongoing defined contribution plan expense.

Effective January 1, 2026, employees of Union Mutual Fire Insurance Company, an affiliated company, will become employees of Newbury Corporation and become eligible to participate in the Plan.

There were no other subsequent events requiring recognition or disclosure in the accompanying financial statements.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (the "FASB") Accounting Standards Codification (ASC) Topic 820 - *Fair Value Measurement*, are described as follows:

**Level 1** – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at net asset value:* The fair value of a common collective trust fund is based on the NAV of the fund, representing the fair value of the underlying investments, which are generally securities traded on an active market and are redeemed daily. The NAV is used as a practical expedient to estimate fair value and is excluded from the fair value hierarchy noted above. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no trading restrictions or unfunded commitments outstanding related to the Plan's investment in common collective trusts. The Plan's common collective trust investment is designed to deliver stability by preserving principal and accumulating earnings.

*Self-directed brokerage accounts:* Other investments are valued at the closing price reported on the active market on which the individual securities are traded.

Recordkeeping fees are deducted from participant's accounts. During the year ended December 31, 2024, the Plan made payments to Charles Schwab Retirement Services, Inc. for third-party administrator recordkeeping services of \$47,956, that were reported as administrative expenses on the statement of changes in net assets available for benefits.

The Plan allows participants to take loans against their account balances which also qualify as exempt party-in-interest transactions. In addition, the Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **7. Tax Status**

The Plan adopted a pre-approved plan offered by Schwab Retirement Plan Services, Inc. The pre-approved plan received an IRS Opinion Letter dated September 21, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.
