Opinion

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Lockett & Farley Employee Stock Ownership Plan (the “Plan”) provides only general information. The Plan Agreement should be referred to for a more complete description of the Plan's provisions.

General – Lockett & Farley Architects, Engineers, and Construction Managers, Inc. established the Plan effective as of January 1, 2000. Effective January 1, 2013, the stock of Lockett & Farley Architects, Engineers, and Construction Managers, Inc. was contributed to Lockett & Farley Holding Company, Inc. (the “Company” and “Plan Sponsor”). As of January 1, 2015, the Plan was restated and operates, in relevant part, as a fully leveraged employee stock ownership plan (“ESOP”) designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“IRC”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by the Company and an unrelated third party individual is serving as Trustee.

The Plan purchased Company common stock using the proceeds of a borrowing issued by the Company (see Note 5) and holds the common stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against shares once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with vested rights in Allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”).

Employees of the Company and its participating subsidiaries are eligible to participate in the Plan upon the date of hire and are eligible to receive the allocation of Company common stock once they have completed 1,000 hours of service within the same one-year period. Participants who do not have at least 1,000 hours of service during such Plan year are generally not eligible for an allocation of Company contributions for such Plan year.

Contributions – The Company is obligated to make contributions to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on the term loan. The Company may make additional contributions at its discretion.

Participant Accounts – The Plan is a defined contribution plan under which a separate individual account is established in the name of each participant reflecting his or her interest in the Plan. Each participant's account is credited as of the last day of each Plan year with an allocation of the shares of the Company's common stock released from the unallocated account and forfeitures of terminated participants' nonvested accounts. Participants also receive an allocation of shares related to the repurchase of shares from distributions. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting – Participants vest at the rate of 20% for each year of vesting service after the completion of two years of vesting service and are 100% vested after six years of credited service. If a participant's employment with the Company ends due to attainment of normal retirement age, permanent disability, or death, the participant will be 100% vested in their account balance.

Note 1—Description of the Plan (continued)

Payment of Benefits – Distributions on account of death, disability, retirement, or termination are made according to the terms in the Plan Agreement. Distributions are generally made in cash in equal installments over a five-year period or lump sum. For terminations other than retirement, death, or disability, distributions will begin after the close of the valuation of the fifth Plan year. Under the provisions of the Plan Agreement, the Company is obligated to repurchase participant shares which have been distributed so long as the shares are not publicly traded or subject to trading limitations. During the Plan year ended December 31, 2024, the Plan repurchased 8,730 shares at a price determined from an independent appraisal. These shares were reallocated to the remaining participants.

Voting Rights – Each participant is entitled to exercise voting rights attributable to the shares Allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any Allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period not to exceed five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Any participant in the Plan, who is at least 55 years of age and has at least 10 years of Plan participation, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares Allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify may direct the Plan to transfer the portion of their account that is covered by the election to another qualified plan of the Company which accepts such transfers or may receive a cash distribution. During 2024, there were no diversifications requested by eligible participants. If diversifications are executed, the Plan repurchases the diversified shares and reallocates them to active participants in accordance with the provisions of the Plan Agreement.

Administrative Expenses – As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses of the Plan.

Forfeitures – Plan forfeitures are Allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. During the Plan year ended December 31, 2024, forfeitures of terminated nonvested account balances approximating \$202,500 (3,521 shares) were allocated to remaining participants.

Note 2—Summary of significant accounting policies

Basis of Presentation – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The most significant estimate effecting the Plan relates to determining the fair value of the Plan Sponsor stock.

Allocations – The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to allocated and unallocated participant accounts, including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition – The common stock shares of the Company are reported at fair value. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the Plan year.

Payment of Benefits – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 or 2023.

Note 4—Fair value measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Common Stock of Lockett & Farley Holding Company, Inc. – The fair value of the Company's common stock is determined by an independent appraiser as of the Plan's year-end. The independent appraiser utilized a combination of the Discounted Cash Flow Method (Income Approach) and the Guideline Public Companies Method (Market Approach). The valuation reflects the conclusion that market participants would recognize a discount for lack of marketability. The valuation process involves Plan management's selection of an independent appraiser under contract on a yearly basis. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a preliminary report which Plan management, along with the Trustee, reviews in detail, discusses and approves. The appraisal policies and procedures are reassessed at least annually to determine if the current valuation techniques remain appropriate.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no purchases, issuances, or transfers into or out of Level 3 investments during the Plan year ended December 31, 2024.

Note 5—Note payable

On January 1, 2012, the Plan entered into a \$3,865,000 note payable agreement with the Company with an interest rate of 5.00%. The proceeds of the note payable were used to purchase 75,450 shares of Company common stock. Unallocated shares are collateral for the note payable. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 5,030 shares being released and allocated for the Plan year ended December 31, 2024.

The agreement provides for the note payable to be repaid over 15 years. The fair value of the note payable as of December 31, 2024 and 2023 was approximately \$692,000 and \$1,014,000, respectively, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates, and nonperformance risk.

Note 6—Related party and party-in-interest transactions

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. All fees incurred in the administration of the Plan are paid by the Company. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Note 7—Income tax status

The Internal Revenue Service ("IRS") has determined and informed the Company, by a letter dated March 2, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, is exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and all appropriate provisions of the Plan will continue to apply until the account balances of all participants have been distributed.

Note 9—Risks and uncertainties

The Plan invests in the common stock of the Company. The common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock, and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

Note 10—Going concern

The financial statements and supplemental schedules have been prepared assuming that the Plan and the Company will continue as a going concern. The Company has a mortgage note payable of \$7.5M at December 31, 2024 that matures with a balloon payment due in December 2025. Based on this condition management has determined that substantial doubt exists above the Company's ability to continue as a going concern for at least one year beyond the date these financial statements are available to be issued. Management's plans are to obtain a new mortgage with a bank extending this note payable beyond 12 months from the date these financials statements are available to be issued. The financial statements and the supplemental schedules do not include any adjustments that might result from the outcome of this uncertainty.

Note 11—Subsequent events

The Plan has evaluated all subsequent events through October 29, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
