## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Ale-8-One Bottling Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. DESCRIPTION OF PLAN

The following description of the Ale-8-One Bottling Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Ale-8-One Bottling Company Inc. (the Company) for the benefit of all employees of the Company, excluding collective bargaining employees and event team employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Eligibility

Eligible employees, as defined in the plan document, who have reached the age of 21 and six months of service are able to make elective deferrals or receive matching contributions under the Plan beginning on the first day of the month coinciding with, or following their date of hire.

#### Contributions

Contributions made to the Plan are comprised of employee and employer contributions.

Employees may make salary deferral contributions of up to 90% of their eligible compensation, as defined, but not to exceed the maximum annual deferral amount established by the Internal Revenue Code (IRC). The Plan provides for an automatic employee salary deferral contribution of 3 percent of an employee's eligible compensation, unless the employee opts to elect a different deferral percentage or elects to not make a salary deferral contribution. The automatic contribution begins immediately after a new participant meets eligibility requirements.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollover). Effective November 1, 2024, the Plan allowed for participants who were eligible for a distribution from an account, to elect to roll over the distribution to a designated Roth contribution account in the Plan (referred to as an In-Plan Roth Rollover Contribution).

The Company makes a safe-harbor matching contribution for eligible employees each plan year equal to 100% of the first 3% a participant contributes to the Plan, plus 50% of deferrals between 3% and 5% of compensation that is contributed to the Plan.

The Company may also elect to make discretionary profit-sharing contributions, to be determined by the employer. Participants must have completed 1,000 or more service hours in

the plan year and have been employed by the Company as of the last day of the plan year to be eligible. For the year ended December 31, 2024, the Company made a \$147,000 profit-sharing contribution.

Finally, the Company may also elect to make additional discretionary matching contributions, to be determined by the employer. The discretionary additional matching contribution will not exceed 4% of the eligible employees compensation. There were no discretionary matching contributions for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses are charged to each participant's account when a benefit distribution is provided. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the plan year.

#### Vesting

Participants are 100% vested immediately in their elective and rollover contributions, plus actual earnings thereon. Participants are also 100% vested immediately in the safe-harbor matching contributions made by the Company.

A participant is vested in the Company's discretionary profit-sharing contribution portion of their account, if any, plus actual earnings thereon based upon the below vesting schedule:

Participants are 100% vested in their entire account balances upon reaching normal retirement age as defined, disability, or death.

#### Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at Prime, published in the Wall Street Journal on the first business day of the month the loan is originated, as defined. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Upon reaching the age 59-1/2, a participant may elect to receive a lump-sum payment of all, or part of, the value of the participant's vested account. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or, if permitted under the Plan at the time of distribution, an alternative form of payment. Upon termination of service for other reasons, a participant may elect to receive a lump-sum amount equal to the value of participant's vested account. As defined in the plan documents, certain participants are also eligible for hardship distributions, consistent with the provisions of the Internal Revenue Code.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$38,496 and \$29,243, respectively. The accounts may be used to reduce future Company contributions or pay administrative expenses. For the year ended December 31, 2024, \$6,867 of forfeitures were used to reduce employer contributions. No forfeitures were used to pay plan expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued interest. Interest income is recognized when earned. No allowance for credit losses has been recorded at December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses incurred by maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

Plan management has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 31, 2025. See Note 10.

#### **3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified to the completeness and accuracy of the investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, and investment-related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Stable value collective trust fund* – A stable value fund that is composed primarily of fully-benefit responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probably that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issue reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. Investment management fees are paid to Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees and custodians of the Plan. Empower Retirement, LLC is the Plan's recordkeeper. Fifth Third Bank, N.A. (Fifth Third), is the Plan's investment advisor. Blue & Co., LLC is the independent auditor for the Plan. The aforementioned parties generally receive payment from the Company. Certain members of the Plan's Fiduciary Committee are active participants in the Plan.

#### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in the company contribution portion of their account.

#### **7. TAX STATUS**

The Plan has adopted a pre-approved plan document sponsored by Empower Retirement LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
