### **Basis for Opinion**

## NOTES TO FINANCIAL STATEMENTS

---

### 1. Description of Plan

The following description of The Whole Child 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Whole Child - Mental Health & Housing Services (“the Employer”) established the defined contribution plan effective August 1, 2008. The Plan is a 401(K) salary deferral plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”) as amended. The Employer is the Plan’s sponsor and serves as the Plan administrator.

#### Contributions

Participant contributions are based upon an elected percentage. The plan allows participants to contribute, on a pre-tax basis and post-tax basis, an amount up to the lesser of the maximum prescribed amount under the Internal Revenue Code or 100% of their eligible compensation and allows for “catch-up” contributions if a participant is age 50 or older. The amount participants can contribute to the 401(K) went up from \$22,500 in 2023 to \$23,000 in 2024. Catch up contributions is \$7,500 in 2024 same as 2023.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution, the allocation of the Plan sponsor’s contribution, and the Plan’s earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are fully vested in their contributions. Employer contributions vest based on years of continuous service. A participant is 100% vested immediately upon hire (i.e., Safe Harbor Plan).

#### Forfeitures

A participant’s non-vested balance is forfeited at the time of termination of employment. Forfeitures are used to offset future employer contribution. No forfeitures were used during 2024.

**1. Description of Plan, continued**

**Plan Loans**

The Plan allows for loans to participants. Participants may borrow from the Plan using a portion of their plan account as collateral for the loan. Plan loans are not treated as a distribution from the Plan and are not considered plan assets. Therefore, plan loans are not reported on the statements of net assets available for benefits. A participant may apply for a plan loan to be made from his or her vested account balance in the Plan not to exceed the lesser of 50% of the participant's vested account balance or \$50,000 and must be for at least \$1,000. All loans are to be paid back over a period not to exceed five years, excluding loans to acquire the participant's principal residence, which may permit a longer repayment term.

Participants will be charged an interest rate equal to 2% above the prime rate. The interest will be fixed for the duration of the loan. Principal and interest are paid by the participant through payroll deductions.

The plan administrator has concluded that these loans are not plan assets, and that such arrangements are party-in-interest transactions for which a statutory exemption exists. The balances of outstanding loans as of June 30, 2024 was \$114,932.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may receive distributions of their vested interest in his or her account in the form of a single lump sum payment.

**2. Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Notes Receivable**

Notes receivable from the Plan and participants on the Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023, and are recorded at their unpaid balance. Interest income on notes receivable from participants is recorded when it is earned, and the related fees are recorded as administrative expenses and expensed when incurred.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

**Administrative Expenses**

The costs of the plan for accounting and administration expenses are the responsibility of the plan. Expenses made from the Plan's assets can either be allocated to all participants in the Plan or simply allocated to an individual's account, depending on the type of expense.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's investments include concentrations of credit risk. As of June 30, 2024, investments in J.P. Morgan Smart Retirement 2040 R2, J.P. Morgan Smart Retirement 2050 R2, and American Century Equity Growth R represented 60% of the Plan's total investments. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

**Subsequent Events**

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Notes Receivable**

Notes receivable from the participants and employer are repaid monthly at varying interest rates over a period of two to fifteen years. Loans to participants outstanding at June 30, 2024 and 2023 were \$114,932 and \$131,985, respectively.

**4. Information Prepared and Certified by the Custodian**

No auditing procedures were performed on investments and dividend income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The General Account is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the Great West general accounts that is used to determine the Guaranteed Interest Account's crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2023 is 1.40% and for 2024 is 2.08%. The actual average yield earned by the plan for the benefit responsive fund can be derived by averaging the plan's quarterly interest rates. That average for 2023 is 1.40% and for 2024 is 2.08%. The contract outlines the events that may limit the fund's ability to transact at contract value, as well as the circumstances under which the issuer may terminate the contract. Refer to the contract or plan description for a full explanation of investment details.

### 7. **Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$1,945.

The Plan's investment options include funds managed by Empower or its affiliates. As custodian and recordkeeper, Empower's transactions qualify as exempt parties-in-interest transactions.

### 8. **Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### 9. **Tax Status**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan is designed to operate as a volume submitter 401(k) profit sharing plan based on a favorable determination letter issued to the prototype sponsor that provides tax-exempt status under appropriate sections of the Internal Revenue Code. The plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
