I am writing on behalf of **Ocean Fresh Fish LLC**, sponsor of the Ocean Fresh Fish LLC 401(k) Plan, to respectfully request consideration for late Form 5500 filings from **2018 through 2024** under reasonable-cause and disaster-relief provisions. Until receiving ADP's notice, I did not understand that a Form 5500 must be filed each year even during minimal operations. Over the past several years, our small family business endured multiple, overlapping hardships that prevented timely filings. Below is a year-by-year summary.

Year-by-Year Summary

2018: A former worker filed a lawsuit against Stuckey's Sustainable (DBA Ocean Fresh Fish LLC). The legal defense, settlement, and penalties caused severe financial strain and emotional distress for both owners. Because the claimant's family was known to my co-owner, the situation was especially traumatic and led to prolonged mental exhaustion that hindered administrative responsibilities.

2019: Our retail location at 2500 Francisco Blvd, Pacifica, CA was lost after a change in property ownership following the passing of the original landlord. The new owner issued an eviction and reclaimed the space. Business systems (ADP Payroll, 401(k) platform, security, and POS) were abruptly disrupted, leaving us with lease liabilities but no operating base.

2020: We carried substantial debt and, in the pandemic environment, survived only through small farmers' markets. Revenue fell sharply and our focus was on loan obligations and basic survival.

2021: Financial hardship forced us to give up our residence and live aboard a small vessel. Market sales continued at minimal levels while we worked to pay down debts amid unstable income.

2022: My elderly mother in Tokyo developed heart disease and required hands-on care. As her only child, I had to travel repeatedly between California and Japan, incurring significant cost and extended time away from business compliance.

2023: My mother's condition worsened with memory loss, making independent living impossible. I had to reopen her financial accounts and manage property documentation in Japan, which consumed substantial time and attention and reduced my capacity to maintain U.S. bookkeeping and compliance.

2024: My mother entered long-term care. I suffered severe hip pain that ultimately required surgery and rehabilitation while overseas caring for her. Our California storage yard costs also surged (property taxes nearly tripled), adding financial stress. Although I returned to the U.S. in October 2025 and contacted ADP, I realized the **2024 Form 5500** (due October 15, 2025) had been missed. This omission was unintentional and the result of compounded personal and business crises and temporary stress-related memory issues.

As of late 2025, our situation has stabilized. We have scaled operations to a sustainable level and are committed to prompt compliance going forward. I respectfully request relief from penalties and permission to file the delinquent Forms 5500 for 2018–2024 under the applicable reasonable-cause or disaster-relief provisions. These delays were not due to willful neglect but to extraordinary circumstances beyond our control.

Thank you for your time and consideration. I appreciate your assistance in forwarding this letter with our filings for DOL/IRS review. Please advise if any additional documentation is required.
