## **Report of Independent Auditors**

### **Opinion**

We have audited the financial statements of Piper Sandler Companies Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

**NOTE 1 | DESCRIPTION OF THE PLAN**

**General**

The Piper Sandler Companies Retirement Plan (the "Plan") is a defined contribution plan covering employees of Piper Sandler Companies (the "Company" or "Plan sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Schwab Retirement Plan Services, Inc. is the recordkeeper of the Plan and Charles Schwab Trust Bank serves as the Plan trustee. The following provides only general terms of the Plan. A complete description of the Plan is available from the Company.

The Retirement Plan Investment Committee and Retirement Plan Administration Committee oversee the Plan. These committees have the authority to change investment options, such as the replacement of a fund due to the fund's performance, and have the fiduciary responsibility to ensure the Plan is acting in the best interest of the participants.

**Contributions**

Participants may contribute between 1 and 75 percent of their recognized compensation, as defined in the Plan document, for each pay period up to an annual maximum of \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Eligible employees are automatically enrolled in the Plan at a six percent contribution rate of their recognized compensation if the employee does not take affirmative action to stop contributions or change contribution percentages. The contribution percentage of each eligible participant who has elected (or who has been automatically enrolled) to contribute less than 12 percent of their compensation is automatically increased by one percent as of March 1. The automatic one percent increase continues on each subsequent March 1 until the participant's contribution level reaches 12 percent of compensation. An eligible participant may affirmatively elect to override the automatic contribution increase at any time. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions through payroll deductions up to an annual maximum of \$7,500 for 2024 and 2023. Eligible employees may also enroll in after-tax contributions of their recognized compensation, up to an annual maximum of \$35,884 and \$33,888 for 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

The Company matches 100 percent of the first six percent of recognized compensation contributed by the participant ("Matching Contribution") up to the social security taxable wage base of \$168,600 and \$160,200 for 2024 and 2023, respectively. Participants are eligible for the Company's Matching Contribution beginning on the first day of the calendar quarter subsequent to the commencement of a participant's employment. After-tax contributions are not eligible for the Company's Matching Contribution. The Plan also provides for a discretionary profit sharing contribution by the Company ("Profit Sharing Contribution"). Payment and amount of the Profit Sharing Contribution are determined annually on a discretionary basis. For the years ended December 31, 2024 and 2023, the Company did not make a Profit Sharing Contribution. The Company's contributions are generally paid following the end of the Plan year and participants must be employed on the last business day of the Plan year to receive the Company's contributions. All contributions are subject to certain limitations of the Internal Revenue Code (the "Code").

**Vesting**

Participants are immediately vested in all contributions made to the Plan from their recognized compensation and the earnings thereon. In addition, participants are immediately vested in the Company's contributions and earnings thereon.

**Participant Accounts**

Separate accounts are maintained for each participant whereby the participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Mutual fund rebates related to the Plan's investments in certain mutual funds are allocated to participants in the distributing fund on a quarterly basis.

### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms generally range up to five years or up to 15 years if the loan is used towards the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a fixed interest rate of one percent over the prime rate for the business day preceding the date the loan is granted. Principal and interest are paid ratably through semi-monthly payroll deductions. A participant may prepay a loan in full at any time without penalty. Participants who terminate employment with outstanding loan balances have 90 days from the last day of their employment to pay the balance of their loan in full. Loans not repaid within that timeframe will be reported as taxable distributions. Participant loans are recorded at their unpaid principal balance, plus accrued but unpaid interest.

### **Benefits**

After reaching the age of 59 1/2, a participant may elect to withdraw all or a portion of the value of their account without penalty. Hardship withdrawals by actively employed participants before the age of 59 1/2 are permitted for pre-tax contributions, only after meeting specified criteria, as defined in the Plan. Actively employed participants prior to the age of 59 1/2 can also elect to withdraw all or a portion of the rollover contributions or transferred contributions made to the Plan. Although hardship and rollover withdrawals are allowed, a participant may be subject to a ten percent federal penalty tax on certain types of withdrawals.

If a participant's employment ends for reasons other than total or permanent disability or death and the balance is less than \$1,000, a distribution is paid to the participant in the form of a lump-sum payment. If the participant's balance exceeds \$1,000 but is less than \$7,000, a distribution is made in the form of a direct rollover to an individual retirement account. If the participant's balance exceeds \$7,000, the following distribution options are available, subject to certain limitations and required minimum distribution rules: lump-sum distribution, direct rollover, and delayed distribution or installment distribution. Upon death, if the balance in the participant's account is less than \$7,000, a distribution is paid to the designated beneficiary in the form of a lump-sum payment. If the balance exceeds \$7,000, the participant's account is paid to the designated beneficiary via one of the above mentioned distribution options. Benefits are recorded when paid.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA.

## **NOTE 2 | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with United States generally accepted accounting principles ("U.S. GAAP").

### **Fair Value of Financial Instruments**

The Financial Accounting Standards Board Accounting Standards Codification Topic 820, "Fair Value Measurement," ("ASC 820") provides a definition of fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the inputs used to measure fair value and enhances disclosure requirements for fair value measurements. ASC 820 maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from independent sources. Unobservable inputs reflect Company management's assumptions that market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the observability of inputs as follows:

Level I – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities as of the report date.

Level II – Pricing inputs are other than quoted prices in active markets, which are either directly or indirectly observable as of the report date.

Level III – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### **Valuation of Investments and Income Recognition**

The Plan's investments in mutual funds and self-directed brokerage accounts are stated at fair value. Quoted market/redemption prices are used to value these investments. The estimated fair value of the common/collective trusts is net asset value ("NAV") or unit value, as calculated by a third party. See Note 4. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **NOTE 3 | INVESTMENTS IN COMMON/COLLECTIVE TRUSTS**

The Plan was invested in the Galliard Stable Return Fund C as of December 31, 2024 and 2023 (the "Stable Return Fund"), which indirectly holds benefit-responsive investment contracts. Units held by the Plan represent an undivided proportionate interest in all of the assets and liabilities of the Stable Return Fund. The NAV of each unit is determined daily, and reflects all earnings, expenses, gains and losses in the Stable Return Fund. Income on the Stable Return Fund's investments is automatically reinvested and reflected in the NAV of each unit.

### **NOTE 4 | FAIR VALUE MEASUREMENTS**

The degree of judgment used in measuring the fair value of financial instruments generally correlates to the level of pricing observability. Pricing observability is impacted by a number of factors, including the type of financial instrument, whether the financial instrument is new to the market and not yet established and other characteristics specific to the instrument. Financial instruments for which fair value can be measured from actively quoted prices generally will have a higher degree of pricing observability and a lesser degree of judgment used in measuring fair value. Conversely, financial instruments rarely traded or not quoted will generally have less, or no, pricing observability and a higher degree of judgment used in measuring fair value. As the observability of prices and inputs may change for a financial instrument from period to period, this condition may cause a transfer of an instrument among the fair value hierarchy levels.

The following is a description of the valuation techniques used to measure fair value.

#### **Investments**

##### ***Mutual Funds***

Mutual funds are valued based on quoted market prices which represent the NAV of shares held by the Plan as of the report date. There are no restrictions as to redemption of these investments nor does the Plan have any contractual obligations to further invest in any of the individual mutual funds. To the extent these mutual funds are actively traded, valuation adjustments are not applied and they are categorized as Level I.

**Common/Collective Trusts**

The estimated fair value of the common/collective trusts is NAV or unit value. The use of NAV as fair value is deemed appropriate as the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. Prices for securities held in the common/collective trusts are primarily obtained from third-party fund administrators and/or interests in other common/collective trusts that may be valued at NAV or a unit value that represents a practical expedient of fair value. To the extent that the NAVs and unit values are based on observable market data, they are classified as Level II.

**Self-Directed Brokerage Accounts**

Self-directed brokerage accounts are comprised of mutual funds, common stock, bonds and other investments as allowed under the Plan, which are managed at the discretion of the participants. Securities held in self-directed brokerage accounts are valued based on quoted prices in active markets obtained from independent pricing services for identical assets as of the report date. There are no restrictions as to redemption of these investments nor does the Plan have any contractual obligations to further invest in any of the individual securities. To the extent these securities are actively traded, they are categorized as Level I. Self-directed brokerage accounts may also include cash and cash equivalents. Cash equivalents include highly liquid investments with original maturities of 90 days or less which are measured at NAV and classified as Level I.

**NOTE 5 | INCOME TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service ("IRS") dated January 26, 2018, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 | RISKS AND UNCERTAINTIES**

The mutual funds, common/collective trusts, and self-directed brokerage accounts of the Plan invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 7 | RELATED PARTY TRANSACTIONS**

The Company's Matching Contributions to the Plan were \$13.4 million and \$13.0 million for 2024 and 2023, respectively. Matching Contributions are generally made in February of the following year.

**NOTE 8 | ADMINISTRATIVE EXPENSES**

Plan administrative expenses are charged to each Plan participant at a fixed rate on a quarterly basis.

Loan processing and maintenance, qualified domestic relations orders and distribution fees of the Plan are paid out of the account of the requesting participant.

The Company paid certain legal and audit fees related to the Plan during 2024 and 2023.

**NOTE 9 | SUBSEQUENT EVENTS**

The Company has evaluated subsequent events through June 26, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events that require disclosure in the Plan's financial statements.
