## Independent Auditors' Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the GHD, Inc. 401(k) Employees' Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**1. Description of the Plan**

The following description of the GHD, Inc. 401(k) Employees' Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution profit sharing plan, sponsored by GHD, Inc. (the "Plan Sponsor" or "Plan Administrator"). Employees must be at least 18 years of age and have completed 3 months of service in order to become a participant in the Plan. Employees of participating companies may begin participating in the Plan on the first day of the following month after meeting these requirements.

The Plan, established January 1, 1994, was subsequently amended and restated effective January 1, 2022 to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 ("Cycle 3 Restatement"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), and the Internal Revenue Code (the "Code").

The following classes of employees are excluded from eligibility:

- Temporary or contract employees;
- Employees classified as students;
- Employees of CRA Limited who are not employed at a branch office in the United States of America; and
- Employees represented by a collective bargaining agreement.

**Contributions** – Participants may elect to contribute a percentage of their annual compensation to the Plan each year, limited by the amount imposed by law. Participants age 50 or older may also elect to make a catch-up contribution limited to the amount imposed by law. The Plan follows an Eligible Automatic Contribution Arrangement ("EACA") that automatically enrolls individuals upon becoming eligible at a 6% deferral rate of compensation, unless they elect otherwise.

The Plan Sponsor provides Safe Harbor matching contributions of 100% of a participant's elective deferrals that do not exceed 1% of the participant's compensation, plus 50% of the participant's elective deferrals between 1% and 6% of the participant's compensation. The Plan Sponsor may also make annual discretionary profit sharing and matching contributions to the Plan; however, no such contributions were made to the Plan during the years ended December 31, 2024 and 2023.

**Vesting** – Participants are immediately vested in their salary deferral and rollover contributions, as well as the Plan Sponsor's contributions and actual earnings thereon.

**1. Description of the Plan (continued)**

***Participant Accounts*** – Individual accounts are participant directed and are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and the participant's share of Plan expenses and losses.

The allocation of earnings and losses to participant accounts is based on the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Payment of Benefits*** – Upon termination of service due to termination, death, retirement or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or annual installments over a period selected by the participant, which may not exceed the participant's life expectancy, or an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, or as a rollover to another qualified plan. The Plan allows for hardship withdrawals limited to the participant's deferred balance. The Plan permits in-service distributions for participants who have attained the age of 59½ from accounts which are 100% vested.

***Notes Receivable from Participants*** – In accordance with Plan provisions, participants are permitted to borrow a minimum of \$1,000 up to a maximum amount of the lesser of \$50,000 or 50% of the participant's vested balance. The maximum number of loans outstanding at any time for any participant is one loan for the purchase of a primary residence and one loan for any other purpose. Interest will be charged at a reasonable rate determined by the Plan Administrator. The term of the loan may not exceed five years unless the loan is for a principal residence in which case the Plan Administrator may permit a longer repayment term.

***Income Taxes*** – The Plan Sponsor adopted the Minnesota Life Insurance Company Volume Submitter 401(k) Profit Sharing Plan #07-003 which received an advisory letter dated June 30, 2020 issued by the Internal Revenue Service ("IRS") as evidence that the Plan is qualified under Code Section 401. The Plan Sponsor believes the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

***Plan Termination*** – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

***Investment Valuation and Income Recognition*** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on an ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

***Investment Risks and Uncertainties*** – The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

***Participant Notes Receivable*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Benefit Payments*** – Benefits are recorded when paid.

***Plan Expenses*** – Certain accounting and administrative expenses necessary to administer the Plan are paid for by the Plan Sponsor. Expenses relating to certain investment activity are paid by participants from their respective individual accounts. Expenses related to certain recordkeeping functions are paid by the Plan. For the year ended December 31, 2024, expenses are netted against income to the Plan totaling \$71,358 resulting from reporting differences after the change in recordkeeper during 2024 that is discussed below.

***Party-in-Interest Transactions*** – Plan investments are managed by The Standard Insurance Company (“The Standard” or the “Custodian”) and were previously managed by Minnesota Life Insurance Company (“Minnesota Life” or the “Former Custodian”), the asset custodians as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Custodian from Plan assets totaled \$55,175 and \$51,742 for the years ended December 31, 2024 and 2023, respectively.

**2. Summary of Significant Accounting Policies (continued)**

In December 2022, the Standard acquired the recordkeeping operations of Securian Financial, the parent company of Minnesota Life. The Plan formally migrated to The Standard's administrative platform in May 2024.

***Use of Estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

***Accounting Changes*** – Management periodically assesses the applicability of new accounting pronouncements and technical guidance and the effect, if any, on the Plan's financial statements.

***Coronavirus Aid, Relief, and Economic Security (CARES) Act*** – The CARES Act was signed into law on March 27, 2020 in response to the impacts and anticipated impacts of the COVID-19 pandemic. The CARES Act waived all required minimum distributions for calendar year 2020, provided participants with penalty-free access to their balances up to \$100,000 subject to certain eligibility criteria if distributed before January 1, 2021, provided a temporary increase in participant loan limits to the lesser of \$100,000 or 100% of a participant's vested balance, and provided the ability for participants to elect to suspend the repayment of loans prior to December 31, 2020 for one year. Plan management offered these relief options to participants in 2020, and will formally amend the Plan to reflect these changes prior to the IRS deadline of December 31, 2025.

***Setting Every Community Up for Retirement Enhancement (SECURE) Act*** – The SECURE Act was signed into law on December 20, 2019. The SECURE Act increases the age for required minimum distributions (RMD) from age 70½ to age 72, creates penalty-free withdrawals for birth or adoption, and modifies certain aspects of plan administration and participant disclosures. These changes are effective for plan years beginning after December 31, 2019.

On December 29, 2022, the SECURE 2.0 Act was signed into law to address additional retirement issues. SECURE 2.0 Act includes provisions to help participants increase retirement savings and simplify and clarify certain retirement plan rules. SECURE Act 2.0 increases the age for RMDs to age 73, effective January 1, 2023 and increasing it to age 75 by 2033. Plan management is currently reviewing SECURE 2.0 provisions and will amend the plan as required.

***Subsequent Events*** – The Plan Administrator has evaluated subsequent events, for recognition or disclosure, through October 8, 2025, the date the accompanying financial statements were available to be issued. See Note 6.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date. There were no assets of the Plan that that were valued using Level 1 inputs at December 31, 2024 or 2023.

- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. Also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. Investments valued using Level 2 inputs include pooled separate accounts totaling \$464,991,741 and \$423,156,345 at December 31, 2024 and 2023, respectively.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. Investments valued using Level 3 inputs include the general account which had a value of \$8,770,900 and \$9,715,347 at December 31, 2024 and 2023, respectively.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

***Pooled Separate Accounts*** – The Plan invests in various Pooled Separate Accounts (“PSA”) offered by Minnesota Life that utilize a variety of investment managers. This variety allows participants to select the options that best reflect their investment style – from conservative to aggressive. Underlying assets in the PSAs include a variety of fixed maturity securities, equity securities, and cash and cash equivalents. The estimated fair value of PSAs are based on the fair value of the underlying assets owned by the PSA and are generally based on observable inputs. The fair value is determined daily on a marked to market basis. Participants can redeem their investment in PSAs daily without restriction.

***Insurance Company General Account*** – The Plan has a General Account group contract with Minnesota Life Insurance Company which is not fully benefit responsive. General account transfer provisions in the contract prevent the contract from meeting the definition of fully benefit responsive, since such provisions do not allow the participant immediate full access to the general account balance at contract value in all situations. The general account's fair value is determined by the discounted cash flow method (income approach). This valuation technique has an indirect influence on future crediting rates, which are an unobservable input, therefore the General Account utilizes Level 3 inputs as its primary measure of fair value.

**Level 3 Investment** – General Account assets are invested in the general assets of Minnesota Life. Underlying assets in the General Account are predominately high-quality fixed income investments (bonds, mortgages, private placements). The average maturity of these underlying assets is close to 10 years, and the average duration is five and six years. Minnesota Life establishes an interest rate annually that will be credited to participant accounts, based on current market conditions. Participants may withdraw money from their General Account balance for certain specified events without limitations or restrictions. However, for transfers, a participant may transfer up to 20% of the accumulation value or \$2,000, whichever is greater, out of the General Account once during any 12-month period.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("U.S. GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. ### ***Significant Audit Matters***

#### *Qualitative Aspects of Accounting Practices*

We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audits.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The preparation of the Plan's financial statements was based on third-party recordkeeping statements and is deemed adequate for this Plan. There were no misstatements detected as a result of audit procedures that were material, either individually or in the aggregate, to the financial statements taken as a whole.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*
