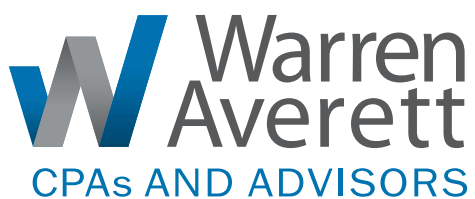

## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of GenOn Pension Plan for Bargained Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit.] The financial statements comprise the statements of net assets available for benefits as of August 31, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to August 31, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2025 and December 31, 2024 and for the period January 1, 2025 to August 31, 2025 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate on the financial statements.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination**

As further discussed in Note 1 to the financial statements, the Company approved a plan termination on June 30, 2024.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audits.

## **1. DESCRIPTION OF PLAN**

The following description of the GenOn Pension Plan for Bargained Employees (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for complete information.

### **General**

On December 14, 2018, GenOn Services, LLC (the Company) ceased to be an affiliate with NRG Energy, Inc. (NRG). As such, the Plan was established on December 14, 2018, by the Company on behalf of specific collectively bargained employees, as defined. The Plan provides benefits when combined with a participant's benefit in the NRG Pension Plan for Bargained Employees (NRG Plan) that is equal to what a participant would have received from the NRG Plan.

The Plan's assets are held in the GenOn Energy Master Trust (Master Trust) in which Northern Trust Company serves as trustee (the Trustee).

The Plan is a defined benefit pension plan intended to qualify under Section 401(a) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective on the close of business of December 31, 2020, the GenOn Keycon Pension Plan for Bargained Employees was merged into the Plan.

The Plan was terminated June 30, 2024. In February 2025, the Company entered into a nonparticipating single premium group annuity contract with Principal Life Insurance Company (Principal). The annuity premium payment of \$11,158,500 was paid in March 2025. Effective May 1, 2025, Principal assumed full responsibility for the payment and administration of future pension benefit payments to participants under the group annuity contract purchased in March 2025. (Note 5).

The following key provisions are relative to the Plan prior to the Plan termination.

### **Pension Benefits**

Benefits are based on various factors including years of service and compensation, as outlined in the Plan document. Normal retirement age is 65; however, the Plan may permit early retirement, as outlined with the Plan document. Eligible employees become vested in their benefit after five years of service. The Plan also provides for death and disability benefits.

### **Administrative Expenses**

Expenses paid by the Master Trust consist of amounts paid to the Trustee for management of the Master Trust assets and investment management fees. These expenses are allocated by the Trustee to each participating plan based on the relationship of the interest of each plan to the total interest of the participating plans. This allocation is reflected in the Plan's financial statements as part of the net investment gain from interest in the Master Trust in the statements of changes in net assets available for benefits.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan's basis of accounting is the liquidation basis.

### **Interest in the Master Trust**

The Company makes contributions to the Master Trust, which supports the Plan. Benefits are paid from the Master Trust to eligible participants of these plans. The assets held by the Master Trust are commingled for investment purposes and are not separately identifiable by the Plan. All investments held by the Master Trust, which includes a common collective trust fund and mutual funds, are carried at fair value.

The common collective trust fund is valued at fair market value by the issuer of the fund, which is based upon the underlying assets held by the fund. There are no restrictions or unfunded commitments noted for the common collective trust fund. Valued at the daily closing price as reported by the fund, these funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net (depreciation) appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits and changes therein at the date of the financial statements. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Master Trust utilizes various investment securities including a common collective trust fund and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, mortality and employee demographics, all of which are subject to change. Due to the uncertainties inherent in these estimates and assumptions, the impact in the near term could be material to the financial statements.

### **Payment of Benefits**

Benefit payments to participants or beneficiaries are recorded upon distribution.

**Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid by the Company are excluded from these financial statements.

Each participating plan has an undivided interest in the Master Trust. Investment income or loss is allocated based on each plan's allocated share of investments at the beginning of the year, net of each plan's actual contributions, benefit payments and administrative expenses.

As of December 31, 2024, the Plan's interest in the Master Trust was approximately 100%. The following table presents the net assets available for plan benefits of the Master Trust as of December 31, 2024.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**3. FUNDING POLICY**

The Company has agreed to make contributions to the Plan sufficient to provide the Plan with assets with which to pay pension benefits to Plan participants. Under provisions of ERISA, the Company may be obligated to make termination payments to the Plan and participants may be eligible for continuation of benefits under insurance provided by the Pension Benefit Guaranty Corporation (PBGC). See Note 5.

The Company met the ERISA minimum funding requirements for the period January 1, 2025 to August 31, 2025 and for the year ended December 31, 2024.

**4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to the service employees have rendered. The actuarial present value of accumulated plan benefits results from applying actuarial assumptions to adjust accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2024, using a beginning-of-year benefit information date, include:

- (a) Rate of return on investments/discount rate of 5.12%.
- (b) The mortality assumption for healthy lives was based on the amounts weighted aggregate rates from the Pri-2012 mortality study projected generationally from 2012 with Scale MP-2021. In addition, the mortality assumption for disabled lives was based on amounts weighted disabled retiree rates from the Pri-2012 mortality study projected generationally from 2012 with Scale MP-2021.
- (c) Unit Cost Method.
- (d) Retirement Various Ages between 55-65, depending on group.

Upon termination, this liability was satisfied through the purchase of the annuity contract noted in Note 1.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025. Had the valuations been performed as of December 31, there would be no material differences. Upon termination, this liability was satisfied through the purchase of the annuity contract noted in Note 1.

## 5. PLAN TERMINATION

The Plan was terminated effective June 30, 2024. (Note 1) In accordance with the termination, the Company funded all remaining unfunded termination liabilities. Subject to the requirements of the PBGC, benefits were provided to participants, spouses, beneficiaries, and contingent annuitants who were receiving benefits or who were eligible to receive benefits at least three years prior to termination of the Plan; second – all benefits guaranteed by the PBGC; third – all vested benefits; and fourth – all other benefits.

## 6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 25, 2025, that the Plan is designed in accordance with the applicable provisions of the IRC, inclusive of the Plan termination. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. There are no ongoing audits.

**7. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of August 31, 2025 and December 31, 2024, and net gain (loss) from Genon Master Trust for the period January 1, 2025 to August 31, 2025 and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee of the Plan.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Certain Master Trust investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers including actuarial, audit and Trustee fees. These transactions are party-in-interest transactions under ERISA.

**9. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 16, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under the Subsequent Events topic of FASB ASC 855, *Subsequent Events*.
