Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Orion South, Inc. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, line 4i – schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Orion South, Inc. Profit Sharing Plan and Trust

Years ended December 31, 2024 and 2023

(See Independent Auditors' Reports)

Note 1

Description of the Plan

The following description of the Orion South, Inc. Profit Sharing Plan and Trust (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution 401(k) and Profit Sharing plan covering all employees of Orion South, Inc. and Point Eight Power, Inc. (collectively, the "Employer") through March 10, 2024. Effective March 10, 2024 Point Eight Power, Inc. no longer participated in the Plan. The participants employed by Point Eight Power, Inc. were transferred by May 31, 2024 to a new plan. The amount transferred as of May 31, 2024 was \$14,496,455. Effective January 1, 2023 Reagan Power & Compression, L.L.C. no longer participated in the plan. The participants employed by Reagan Power & Compression, L.L.C. were transferred by July 31, 2023 to a new plan. The amount transferred as of July 31, 2023 was \$4,445,652. Employees who have completed six consecutive months of service are eligible for non-elective employer and matching contributions. There are no eligibility service requirements for employee deferral contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Each year participants may contribute up to 60 percent of their salaries, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company matches 75 percent of the participant's contribution up to 5 percent of their compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain IRS limitations.

Note 1

(Continued)

(c) Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings (Losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contribution plus actual earnings (Losses) thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of service.

(e) Investment option

Upon enrollment in the Plan, a participant may direct investment of their entire account balance. The employee may change their investment options daily.

(f) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

(g) Payment of benefits

On termination of service due to death, disability, retirement or termination, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account, in a lump-sum amount, a single life annuity if single or a joint and survivor annuity if married, or in periodic installments over a period of time.

(h) Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$56,713 and \$622 respectively. These accounts will be used to reduce the Company's matching contributions and/or plan expenses. The amount of forfeitures used during the year ended December 31, 2024 and 2023 were \$26,301 and \$121,464, respectively.

Note 2

Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting policies generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit investment contract, which is reported at contract value). Mutual funds are valued at quoted market prices, which represent the net asset's value of shares held by the Plan at year end. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (Depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (Depreciation) of fair value of investments.

(Continued)

(g) Reclassifications

Certain prior year amounts have been reclassified for consistency with the current year presentation. This reclassification had no effect on reported net assets available for benefits or changes in net assets available for benefits.

Note 3

Information Prepared and Certified by Trustee (Unaudited)

As pursuant to CFR 2520.103-8, the Plan qualified for an ERISA Section 103(a)(3)(C) audit. Information relating to investment assets, investment transactions, investment earnings, and schedule of investments held for investment purposes was certified as complete and accurate by the Trustee, Fidelity Management Trust Company as of and for the years ended December 31, 2024 and 2023.

Note 4

Fair Value Measurements (Unaudited)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4

(Continued)

Level 2 Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for an asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (Contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money Market Fund: Valued at the closing price reported on the active market on which the funds are traded.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5

Fully Benefit-Responsive Investment Contract (Unaudited)

In 2016, the Plan entered into a fully benefit-responsive investment contract with Fidelity Management Trust Company Fidelity Advisor Stable Value Portfolio (the "Portfolio"). The Portfolio is a commingled pool, dedicated exclusively to the active management of the assets of the participating plans. The fully benefit-responsive investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Fidelity Management Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Unfunded commitments

There were no unfunded commitments on the Portfolio as of December 31, 2024 and 2023.

Redemption frequency

Participant level transactions (like a withdrawal) take place daily. Typically, the liquidation would be requested on one day and processed the next business day. Plan level liquidations (like a de-conversion to another recordkeeper) require notice to Fidelity Management Trust Company and could result in the Plan's investment in the Portfolio being placed into an investment only account for up to 12 months. These funds do file a Form 5500 as Direct Filing Entity with the Department of Labor.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5

(Continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), bankruptcy of the Plan sponsor, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6

Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds and a fully benefit-responsive investment contract managed by Fidelity Management Trust Company, the Trustee and Recordkeeper for the Plan. These are related party and party in interest transactions. As described in Note 2, expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

Note 7

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

Note 8

Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 9

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10

Plan Amendments

The Plan was amended February 23, 2024 to remove Point Eight Power, LLC, (f/k/a Point Eight Power, Inc.) as a related employer that participates in the Plan. As a result, participants that are employed by this entity discontinued participation in the Plan and all of their accounts transferred out of the Plan by May 31, 2024. The Plan was amended on January 1, 2023, to remove Reagan Power & Compression, L.L.C. as a related employer that participates in the Plan. As a result, participants that are employed by this entity discontinued participation in the Plan and all of their accounts transferred out of the Plan by July 31, 2023. Effective November 3, 2023, participants may be permitted to irrevocably designate that a portion or all of the deferral contributions made are Roth 401(k) contributions that are includable in the participant's gross income at the time deferred. In addition, effective November 3, 2023, eligible employees may roll over any eligible rollover distribution as described in Section 5.06 of the Basic Plan Document.
