## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee and Participants of  
the FNBMT 401(K) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of the FNBMT 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 FNBMT 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section -

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the 2024 Audit of the Financial Statements section of our report. We are required to be independent of the FNBMT 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the FNBMT 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ***(1) Description of Plan***

The following description of the FNBMT ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***(a) General***

The Plan is a defined contribution plan covering all full-time employees of the Company who are age twenty-one or older and have completed six months of service. Employees may enroll on the first day of the month on or after fulfilling the age and service requirements. The Plan is administered by the Company in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***(b) Contributions***

Each year, participants are permitted to make pre-tax contributions or elect to reduce their compensation to make Roth 401(K) contributions at rates of at least 1% up to 90% of eligible earnings, as defined by the Plan. Contributions are subject to a maximum annual amount as determined by applicable law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as determined by the Internal Revenue Service ("IRS") and ERISA. Participants may also contribute amounts representing distributions from other qualified deferred benefit or defined contribution plans ("rollover"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to opt-out of the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible pre-tax compensation and their contributions invested in a designated balanced fund until changed by the participant.

Each year the Company may make annual matching and/or discretionary contributions to the Plan for eligible participants at the discretion of the Company's Board of Directors. During 2024, the Company elected to make a discretionary matching contribution of 4% of the eligible participant's compensation.

***(c) Participant Accounts***

Each participant's account is credited with the participant's and the Company's contributions and any rollovers, an allocation of Plan earnings, an allocation of forfeitures of terminated participants' non-vested accounts, and may be charged with some or all of the costs and expenses of operating the Plan. Allocations are based on participant earnings, account balances, or election of investment options, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***(d) Vesting***

Participants are always 100% vested in their voluntary contributions made and rollover contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service.

The Company's matching and discretionary contributions vest in accordance with the following schedule:

Two years	20%

Six or more years	100%

***(e) Payments of Benefits***

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments over a period not to exceed the life expectancy of such participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants with vested account balances less than \$5,000 are immediately distributed as a lump-sum under the terms of the Plan without the participant's consent, unless the participant has made a timely rollover election to an Individual Retirement Account or other qualified arrangement.

**(f) Investment Options**

Investments are made as directed by the Plan's participants. Company contributions are invested in the same manner as participant elective contributions. The Plan currently offers various mutual funds, pooled separate accounts, and a collective investment trust as investment options for participants.

**(g) Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account value or \$50,000, reduced by any outstanding loan balance, if any, in the previous 12-month period ending on the day before the new loan is made, if less. Participants may have only one loan outstanding at a time. An initial loan processing fee of \$75 is charged to the participant's account when the loan is originated. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions. Participant loans are secured by the vested balances in the participants' accounts and are interest bearing at rates commensurate with prevailing rates available for similar loans from commercial lending institutions. At December 31, 2024 and 2023, interest rates on outstanding participant loans ranged from 8.50% to 9.50% and 4.25% to 9.50% with maturities through May, 2030 and September, 2028, respectively.

**(h) Forfeitures**

Upon termination of employment, the unvested portion of the participant's account is forfeited. Forfeitures are retained in the Plan and may first be used to pay administrative expenses and fees and then to reduce Company contributions to the participants remaining in the Plan. During the year ended December 31, 2024 forfeitures totaling \$15,714 were used to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$9,056 and \$15,122, respectively.

**(i) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant would become 100% vested in their employer contributions and is entitled to receive the balance in his or her account (after payment of all expenses and proportional adjustment of such expenses and any investment gains or losses).

**(2) Summary of Accounting Policies**

**(a) Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”) and the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA.

**(b) Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**(c) Payments of Benefits**

Benefits are recorded when paid.

**(d) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit loss has been recorded as of December 31, 2024 and 2023.

**(e) Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, if any, are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants, account maintenance fees, and fees related to distributions to participants are included in administrative expenses and are charged directly to the participant's account.

**(f) Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**(g) Date of Management's Review**

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**(3) Fair Value Measurements**

The Plan accounts for its financial assets and liabilities in accordance with Accounting Standards Codification 820, Fair Value Measurement ("ASC 820"), which are carried at fair value on a recurring basis in the financial statements. ASC 820 establishes a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels are defined as follows:

**Level 1:** Quoted price (unadjusted) or identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

**Level 2:** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in market that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3:** Unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for investments measured at fair value:

*Mutual Funds:*

Mutual funds are valued at the net asset value ("NAV") reported in the active market where the fund is traded on a daily basis and are classified as Level 1 investments.

*Pooled separate accounts:*

Pooled separate accounts ("PSAs") are valued using net asset value ("NAV") as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. PSAs invest primarily in mutual funds, domestic equity securities, and fixed maturity securities. The Plan has concluded that the reported NAVs approximate the fair value of the investment. Participant transactions may occur on a daily basis. The ability to exchange with units of PSAs may be restricted in the event that participants engage in trading patterns which are detrimental to the PSA or underlying investment. Investment funds may be subject to certain trading restrictions that apply to transfers into an investment fund. Transfers out of a PSA are allowed at any time. At December 31, 2024 and 2023, there were no unfunded commitments related to the PSAs.

*Collective Investment Trust:*

The Principal Stable Value Fund, held in a collective investment trust, invests in conventional, synthetic, and separate account investment contracts issued by life insurance companies, banks, and other financial institutions with excess cash invested in cash equivalents. The investment is valued using NAV as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investment assets owned by the fund minus liabilities and then divided by the number of shares outstanding. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on this investment. The trust files an annual report on Form 5500 as a direct filing entity.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes these valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial investments could result in a different fair value measurements at the reporting date.

**(4) Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan, as restated, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to the applicable statute of limitations.

**(6) Risks and Uncertainties**

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan's exposure to concentrations of credit risk is dependent upon the investments selected by participants. The Plan's investments in the Principal LifeTime 2040 Separate Accounts and the TIAA-CREF Large-Cap Growth Index Fund represented approximately 11% and 12%, respectively, of the Plan's investments at fair value at December 31, 2024. The Plan's investments in the Principal LifeTime 2025 Separate Accounts and the TIAA-CREF Large-Cap Growth Index Fund represented approximately 16% and 9%, respectively, of the Plan's investments at fair value at December 31, 2023.

**(7) Related Party and Party-in-Interest Transactions**

Plan assets include investments in various pooled separate accounts held by Principal Life Insurance Company ("Principal Life") and managed by Principal Global Investors, LLC ("PGI"). The Plan also invests in a stable value fund held by Principal Global Investors Trust Company ("PGI Trust Co.") and maintained by Principal Life. Principal Life is the recordkeeper for the Plan. Principal Life, PGI and PGI Trust Co. are affiliates of Principal Trust Co., the trustee of the Plan. Therefore, these investments represent exempt party-in-interest transactions under the provision of ERISA. Fees paid to Principal Life for their services provided totaling \$63,505 were paid by the Plan and are included in administrative expenses on the statement of changes in net assets available for benefits.

All identified party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
