NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the CRA International 401(k) Plan (the “Plan”) provides only general information, participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of CRA International, Inc. and its subsidiaries (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Charles Schwab Trust Bank is the trustee and third-party administrator of the Plan.

Eligibility

Participants who are age 21 or older are immediately eligible to make salary deferrals and are eligible for the Company’s discretionary match contribution. Newly eligible employees are automatically subjected to the Plan’s automatic enrollment provision unless the employee affirmatively elects otherwise. The initial automatic deferral percentage is 3%, increased annually by 1% up to the maximum percentage allowable under the provisions of the Plan (6%) until the participant makes an election to eliminate the automatic deferral increase feature.

Contributions

Each year, participants may contribute to the Plan a percentage of pretax and after-tax annual compensation, as defined by the Plan, up to the maximum amount allowable under the provisions of the Internal Revenue Code (the “Code”). Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts.

The Company’s contributions to the Plan are discretionary and determined by its Board of Directors, but the amounts contributed cannot exceed the maximum amounts allowed under the provisions of the Code. For the year ended December 31, 2024, the Company approved a contribution of an amount equal to 50% of the employee’s deferral up to 6% of compensation.

Investment Elections

Participants may direct the investments of their account. Participants may choose from a selection of investment options, including mutual funds, a common collective trust, and a self-directed brokerage account option. Under the self-directed brokerage account option, participants may select from a variety of investments, including equity securities, unit investment trusts, mutual funds, and cash equivalents. Each participant has the ability to change his or her investment allocation at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s discretionary matching contributions and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant’s earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS - CONTINUED

Vesting

Participants are immediately vested in their contributions and the Company's discretionary matching contributions, plus actual earnings thereon. Effective January 1, 2015, the Plan may no longer make discretionary profit-sharing contributions to the Plan. Vesting in previous discretionary profit-sharing contributions and earnings thereon is based on continuous service. The vested percentage increases 20% annually until a participant is 100% vested after five years of service, as defined by the Plan, or upon permanent disability or death.

Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can have two loans outstanding at any given time. Loans are repayable within a period of five years unless for the purchase of a primary residence, in which case the loan must be repaid in a period not exceeding 10 years. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing market rates for loans made under similar circumstances, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may apply for a hardship withdrawal as defined by the Code to meet excessive medical or educational expenses, expenses incurred to purchase a new principal residence, or to prevent eviction from a principal residence. The application must be approved by the Plan administrator. In addition, in-service withdrawals are allowed upon attainment of age 59½ from a participant's elective deferral account and vested employer contribution account if the contributions to be withdrawn have been allocated to the participant's account for at least two plan years prior to the date of distribution.

Forfeited Accounts

Forfeitures represent the non-vested portion of terminated participants' account balances. Forfeited accounts can be used to pay plan administrative expenses or reduce future employer contributions. There were no forfeitures generated during the year ended December 31, 2024, and \$3,730 of available forfeited accounts were used to offset the employer contribution. Forfeited non-vested accounts totaled \$4,532 and \$5,827 at December 31, 2024 and 2023, respectively.

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. References to U.S. GAAP issued by the Financial Accounting Standards Board ("FASB") in the notes to financial statements are to the FASB Accounting Standards Codification ("ASC").

Valuation of Investments and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodian. See below for discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayment and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earning activity and thus are not separately identifiable as a Plan expense.

Income Taxes

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require revenue recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Fair Value Measurements

The Plan follows the guidance prescribed in FASB ASC 820, *Fair Value Measurements and Disclosures*, which defines fair value, and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Fair value is a market-based measure considered from the perspective of a market participant rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, the Plan's own assumptions are set to reflect those that market participants would use in pricing the asset or liability at the measurement date. The Plan uses prices and inputs that are current as of the measurement date, including during periods of market dislocation. In periods of market dislocation, the observability of prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or Level 2 to Level 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual fund shares held by the Plan at year end are valued at net asset value ("NAV") using quoted market prices. These securities are categorized in Level 1 as these investments are actively traded and no valuation adjustments have been applied.

Common Collective Trust

The common collective trust invests in a “host” fund, which is a stable value collective fund. The fair value of the fund is determined by reference to the fair value of the underlying securities of the host fund. The fund’s unit price is calculated by dividing the total assets less liabilities by the number of trust units outstanding. The common collective trust is categorized as Level 2.

Brokerage Account

The self-directed brokerage accounts consist of equity securities, unit investment trusts, mutual funds, U.S. Government securities, corporate bonds and cash equivalents.

Common Stock

The brokerage account holds common stock (equity securities) that are valued at the quoted closing price reported on the active market on which the individual securities are traded and are categorized as Level 1.

Mutual Funds

Mutual fund shares held in brokerage accounts at year end are valued using quoted NAV per share. These securities are categorized in Level 1 as these investments are actively traded, and no valuation adjustments have been applied.

Cash and Cash Equivalents

The brokerage account holds cash and cash equivalents that are valued at cost plus accrued interest, which approximates fair value, and are categorized as Level 1.

U.S. Government Securities and Corporate Bonds

The brokerage account holds U.S. Government securities and corporate bonds are valued at the closing trade price on the day of valuation based on information from third-party pricing services and are categorized as Level 2.

Unit Investment Trusts

The brokerage account holds unit investment trusts that are valued at the quoted closing price reported on the active market on which the individual securities are traded and are categorized as Level 1.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- The Schedule H, line 4i - schedule of assets (held at end of year) at December 31, 2024.

NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 - TAX STATUS

The Plan uses a prototype plan document. The prototype plan received its latest determination letter on September 21, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan issues loans to participants, which are secured by the balances in the participants' accounts, which also qualify as party-in-interest transactions.

NOTE 7 - NONEXEMPT TRANSACTIONS

As reported on the Schedule H, part IV, line 4a - schedule of delinquent participant contributions, certain Plan contributions in 2023 were not remitted to the trust within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA.

NOTE 9 - SUBSEQUENT EVENTS

Management evaluated events subsequent to December 31, 2024 and through October 14, 2025, the date the financial statements were available to be issued. Management is not aware of any material subsequent events which would require recognition or disclosure in the accompanying financial statements.
