Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Bellarmine University Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified asset information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Notes to the Financial Statements

1. Description of Plan

The following brief description of the Bellarmine University Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan's Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) retirement plan originally established September 1, 1956, by Bellarmine University (the University, Plan Sponsor or Plan Administrator), subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a trust, the trustee of which is Teachers Insurance and Annuity Association-College Retirement Equities Fund (TIAA and CREF). Additional information, including vesting and benefit provisions, is available in the Plan description provided to all employees. The Plan was amended and restated effective June 1, 2020.

Eligibility

The Plan covers substantially all employees of the University except those who are students enrolled and attending classes at the University and part-time faculty teaching less than 18 credit hours between the fall and spring semesters. For part-time faculty, courses must have a minimum of 7 students for the credit hours to be included in the eligibility calculation.

An eligible employee may contribute employee elective deferrals to the Plan on their date of hire. Eligible employees receive employer matching contributions immediately upon completion of two years of eligible service and attainment of age 18.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax basis, as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective June 1, 2022, participants that contribute 3% or more of their eligible compensation as a pre-tax deferral, the University matches 4% of the participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participants' contribution and the University's contributions and allocations of Plan earnings or losses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, as well as the University's matching contributions and related earnings.

1. Description of Plan, continued

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in 1% increments in any of the Plan's investment options. The University's contributions are automatically allocated in the same percentages as participant's contributions. Participants may change their investment options at their discretion.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump sum payment, installment payments, or in the form of an annuity contract equal to the value of the participant's vested interest in their account, subject to the provisions of the Plan's Adoption Agreement.

Plan Loans and Participant Loans

Participants may borrow from TIAA and CREF using a portion of their Plan account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 45% of their account balance. The loans bear interest at rates that range from 4.00% to 5.83%, which are commensurate with local prevailing rates as determined periodically by TIAA and CREF. Principal and interest is paid ratably through monthly or quarterly ACH transfers by the participant to TIAA and CREF. The Plan Administrator has concluded that these loans are not Plan assets and that such arrangements are exempt transactions. The balances as of December 31, 2024 and 2023 are \$154,745 and \$310,264, respectively. Under the borrowing terms, \$55,605 and \$57,638 of Plan assets serve as collateral to these loans as of December 31, 2024 and 2023, respectively. In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan.

1. Description of Plan, continued

Notes Receivable from Participants

Participants may borrow from their account balances subject to the provisions of the Plan agreement up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months.

The maximum term of a loan is 5 years unless the loan is used to purchase a new home. The maximum term for a loan to purchase a new home is 30 years. The loans are collateralized by the balance in the participant's account and bear interest at current market rates of local lending institutions. Principal and interest is paid ratably through bi-weekly or semi-monthly payroll deductions.

Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the University.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Management's Use of Estimates

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events for recognition or disclosure in the financial statements through October 31, 2025, which was the date at which the financial statements were available to be issued.

3. Information Certified and Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by TIAA and CREF, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that asset information provided to the Plan Administrator by the trustee related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the supplemental schedule.

TIAA and CREF also certified to the completeness and accuracy of \$8,710,136 of net realized and unrealized appreciation in the fair value of investments, \$38,900 of other income, \$2,586,931 of interest and dividends related to the investments, notes receivable from participants of \$472,086 and \$27,733 of interest on notes receivable from participants for the year ended December 31, 2024. Also certified by TIAA and CREF is the \$154,745 and \$310,264 of plan loans as of December 31, 2024 and December 31, 2023, respectively.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Valued at cost which approximates fair value.

Term annuity: Valued at net asset value (NAV) per share based on quoted market prices of underlying investments.

Non-benefit responsive investment contracts: These are TIAA Traditional Annuity accounts valued at contract value which equals the accumulated cash contributions and interest credited to the Plan's contracts less any withdrawals. Contract value approximates fair value.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

4. Fair Value Measurements, continued

The fair values of the Plan's investments are based on third-party pricing information without adjustment. As permitted under the accounting guidance for fair value disclosures, the Plan has not provided quantitative information about the significant unobservable inputs used in the fair value measurements of these securities.

5. Investment Contract With Insurance Company

Participants may choose to invest in TIAA traditional annuity accounts, which pay a guaranteed rate of interest plus additional amounts that are not guaranteed but may be established on a yearly basis. These additional amounts, when declared, remain in effect through the end of the "declaration year," which begins each March 1. The guaranteed annual interest rate is generally 3.00%. The interest rate was 4.44% and 4.56% for the years ended December 31, 2024 and 2023, respectively.

6. Benefit Responsive Investment Contracts

The Plan has a fully benefit-responsive investment contract with TIAA and CREF. TIAA and CREF maintain the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by TIAA and CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. If participants want to transfer money from their investment to a competing fund, the amount must first be directed to a non-competing option, where it must remain for 90 days, before being transferred to the competing fund. To minimize the negative effects of frequent trading, transfers into these contracts may not be made for 30 days following a transfer out.

6. Benefit Responsive Investment Contracts, continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

7. Related Party Transactions

The Plan's investments are comprised of a fully allocated insurance contract or accounts managed by TIAA and CREF. TIAA and CREF is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, administrative fees paid to TIAA and CREF amounted to \$312,717.

8. Tax Status

The Plan has adopted a basic plan document sponsored by TIAA and CREF. Effective June 30, 2020, the Plan was restated to reflect all current regulatory changes. The Internal Revenue Service (IRS) has previously not provided plans established under Section 403(b) with a determination or opinion letter indicating that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan is required to operate in conformity with the IRC in order to maintain its tax exemption. Although the Plan has never received a determination or opinion letter, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

9. Contingencies

The Plan Sponsor has historically excluded adjunct employees teaching less than 18 hours per two semesters from making elective deferrals into the Plan. During 2025, it was determined that this has occurred since the Plan was amended in 2015. Based upon that 2015 amendment, these employees should have been eligible to participate in the Plan. Additionally, during 2025, it was determined that the same 2015 Plan amendment began allowing for automatic enrollment into the Plan. Historically, the Plan has not operated with automatic enrollment. The Plan sponsor has determined that the Plan will be amended too clarify the definition of eligible adjunct employees and remove the automatic enrollment election, and therefore, be consistent with the Plan Sponsor's past practice. The Plan has not determined any exposure of loss related to this issue.

10. Plan Termination

Although it has not expressed any intention to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the rights of all affected participants to amounts contributed by them and the sponsor and related earnings thereon will be fully vested.
