Notes to Financial Statements

December 31, 2024 and 2023

(1) **Description of Plan**

The following description of the MRCO, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

Each participant may elect to make voluntary contributions to the maximum dollar limit. The Company may make matching contributions equal to a percentage of the participants' voluntary contributions. The Company determines this matching percentage based on its own discretion.

Participants Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) Plan earnings (losses), including a charge for an allocation of administrative expenses paid by the Plan and (b) employer contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

The forfeiture of any terminated participant's non vested account occurs at the end of the plan year. Forfeitures are used to reduce employer contributions or pay Plan expenses.

Payment of Benefits

On termination of service, a participant shall receive a lump-sum amount equal to the value of his or her account. However, participants with a vested balance of less than \$5,000 will receive a lump-sum amount equal to the vested portion of their account. Participants with a vested balance in excess of \$5,000 may remain in the Plan, but may not make additional contributions.

Vesting

Participants are 100 percent vested in their voluntary contributions and employer matching contributions.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

(2) **Summary of Accounting Policies**

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers and Custodian. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Actual results could differ from those estimates.

Payment of Benefits

Payments of benefits are recorded when paid.

Net Assets Available for Plan Benefits

Net assets available for benefits at December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan

Income Tax Status

On January 1, 2016 the Plan adopted the Access Retirement Systems, LLC Standardized 401(K) Profit Sharing Plan and Trust (Access Plan) , which received its determination letter from the Internal Revenue Service (IRS) in March 2014. The determination letter stated that the Access Plan was in compliance with the applicable requirements of the Internal Revenue Code. As an adopted member of the Access Plan, the MRCO Retirement Plan's administrator and tax counsel believe it has no responsibility to request a separate determination letter. Therefore, believe that the Plan was qualified and was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

(3) Summary of Information Certified by the Custodian

The following information was certified as complete and accurate by the custodian of the plan, John Hancock Life Insurance Company for 2024. The following table presents the fair value of investments.

The Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$401,683 and \$373,096, respectively, for the years ended December 31, 2024 and 2023.

(4) Subsequent Events

Subsequent events have been evaluated through November 3, 2025, the date these financial statements were available to be issued.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

(6) Concentration of Credit Risk

The Plan has an accounting risk of loss in the area of investments in marketable securities. At December 31, 2024 and 2023 this risk amounted to \$4,082,506 and 3,404,965, respectively.

(7) Fair Value

The Plan classifies its investments based on hierarchy consisting of : Level 1 (Valued using quoted prices from active markets for identical assets), Level 2 (not traced on active market but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements, Continued

(7) **Fair Value, continued**

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Pooled separate accounts Valued based on net asset value (NAV), which is determined daily, of the units in participation in the account held by the Plan. On a daily basis, the units of participation are revalued to reflect the performance of the underlying mutual funds less any fees and charges. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (h) These investments seek the highest total return over time consistent with an emphasis on both capital growth and income by investing in a diversified portfolio of stock and bond funds that represent various asset classes and sectors for investors who have a specific maturity date.

(8) **Forfeitures**

For the year ended December 31, 2024 and 2023, forfeitures of \$2,460 and \$471, respectively, were used to reduce employer contributions. No forfeitures were used to pay plan expenses. As of December 31, 2024 and 2023 there were \$7,033 and \$9,244, respectively in unallocated forfeitures.

(9) **Party-In-Interest**

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the plan, the Employer, and certain others. Plan investments are held by the Custodian, and, therefore transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, rather than a direct payment.

The party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.
