## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the The Sullivan University System, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan covering those employees of The Sullivan University, Inc. (Sullivan) (Employer or Plan Administrator) subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective June 1, 1992 and was restated effective January 1, 2022.

#### Eligibility

Employees of Sullivan are eligible to participate in the Plan when they have reached age twenty and a half (20 1/2) and who have either completed six consecutive months of employment with at least 500 hours of service or one year of service. The Plan allows entry quarterly.

#### Contributions

Participants may contribute up to the 85 percent of pre-tax annual compensation as defined in the Plan. Participants who have attained the age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. This deferral amount increases 1% per year up to a maximum elective deferral of 10% of compensation. Each year the Employer, at its discretion, can contribute to the Plan an amount determined by the Board of Directors as a discretionary contribution. These discretionary contributions equal either a percentage of compensation or a dollar amount as it directly relates to elective deferrals made by eligible participants during the plan year. There were no discretionary contributions to the Plan for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Employer's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to the Financial Statements, continued

#### 1. Description of the Plan, continued

##### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Employer's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

##### Vesting

Participants are immediately vested in all participant elective contributions, as well as actual earnings on those contributions. Participants are vested in the Employer's nonelective contributions according to the following schedule:

If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

##### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$50,927 and \$48,220, respectively. These accounts can be used to pay plan expenses, reduce employer contributions or can be reallocated to participants in the same manner as employer contributions. No forfeited non-vested amounts were reallocated to participants or used to pay Plan expenses for the year ended December 31, 2024.

##### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum if the account balance does not exceed \$5,000. If the vested account balance exceeds \$5,000, the participant may request either a single lump sum distribution or regular installments over a fixed period.

##### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

#### 1. Description of the Plan, continued

##### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Administrator. Investment related expenses are included in net appreciation in fair value of investments.

#### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

##### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which employee contributions are withheld from compensation.

##### Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding to contributions. The Plan distributed the 2023 excess contributions to the applicable participants in 2024.

##### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

##### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 17, 2025, the date that the financial statements were available to be issued. There were no other events occurring during the evaluation period that require recognition or disclosure in the financial statements.

### 3. Information Certified and Provided by Trustees

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedules was prepared by or derived from information certified by John Hancock Retirement Plan Services (John Hancock), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from John Hancock that investment information provided to the Plan Administrator by the trustee related to investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedule.

John Hancock also certified to the completeness and accuracy of \$2,011,580 of net realized and unrealized appreciation in the fair value of investments and \$882,488 of interest and dividends related to the investments for the year ended December 31, 2024.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

### 4. Fair Value Measurements, continued

*Collective trusts:* Valued based on the net asset value (NAV) of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Money market:* Valued at cost which approximates fair value.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with accounting standards, investments that are measured at fair value using the NAV practical expedient have not been classified as Level 1, 2 or 3 in the fair value hierarchy, but are included above to permit reconciliation of the fair value hierarchy tables to the amounts presented in the Statements of Net Assets Available for Benefits.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

### 5. Tax Status

The Plan uses a prototype Plan document sponsored by John Hancock from March 1, 2023 to December 31, 2024. John Hancock received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020 which stated that the prototype documents satisfied the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. As of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

### 6. Plan Termination

Although it has not expressed any intention to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### 7. Exempt Party-in-Interest Transactions

John Hancock Retirement Plan Services is the recordkeeper of the Plan for the period and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to John Hancock Retirement Plan Services totaled \$34,125 for the year ended December 31, 2024. Fees paid to Wilshire Associates, Inc. by the Plan for investment advisor services amount to \$37,128 for the year ended December 31, 2024. Certain Plan investments are mutual and collective trust funds managed by John Hancock. These transactions qualify as party-in-interest.

Additionally, indirect fees are paid to John Hancock based on investment account values. These fees range from 0.02% to 1.17% of the investment account value. These fees are included in the net appreciation of the fair value of investments on the statement of changes in net assets available for benefits.

### 8. Prohibited Transactions

During the year ended December 31, 2023, participant withholdings in the amount of \$37,648 were not remitted within the appropriate time period by the Plan Sponsor. This transaction constitutes a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrence and have taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period. These contributions were corrected during the year ended December 31, 2024.
