Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of The Kidz Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to the Financial Statements

1. Description of the Plan

The following description of the The Kidz Club 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document, adoption agreement, and Plan summary for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 2011 and was restated effective January 1, 2022. The Plan was most recently amended on March 1, 2024. The Plan covers all eligible employees of KY PPEC, Inc. d/b/a The Kidz Club and its affiliated companies (the Plan Sponsor).

Eligibility

Employees become eligible after reaching the age of 18 and completing 90 days of service. Employees are eligible to participate in the Plan on the first day of the month on or following completion of the eligibility requirements.

Contributions

Participants may contribute a percentage of eligible compensation on a pre-tax or post-tax (Roth) basis, not to exceed the annual maximum limit established by the Internal Revenue Code (IRC). The Plan Sponsor may contribute a discretionary matching contribution at its discretion. During the year ended December 31, 2024, the Plan Sponsor made discretionary matching contributions of 100% of participants' contribution up to 3% of their eligible compensation.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and any Plan Sponsor contributions, an allocation of the Plan's investment earnings (losses), and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances as defined by the Plan's adoption agreement. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions. The Plan currently offers various pooled separate accounts as investment options for participants.

Notes to the Financial Statements, continued

1. Description of the Plan, continued

Notes Receivable from Participants

Participants may borrow up to a maximum of the lesser of 50% of their vested account balance or \$50,000. The loans' terms range from one to five years (except for loans for the purchases of personal residence), are secured by the balance in the participants' accounts, and bear interest at the prime rate plus 1% at the time the loan is initiated. Principal and interest is paid ratably through regular payroll deductions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 contributions to the applicable participants prior to March 15, 2025.

Vesting

Participants are vested immediately in their contributions plus related earnings (losses) thereon. In addition, the participants are immediately 100% vested in Plan Sponsor contributions to the Plan on behalf of the participant.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or choose from various other payment options. On termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Withdrawals, other than for termination, are permitted under certain circumstances provided by the Plan. All fully vested balances are available for distribution after the participant reaches the age of 59 1/2.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

The custodian did not break out interest and dividends from net appreciation. The Plan's management does not believe the impact of this departure from GAAP is material.

Contributions

Contributions from Plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

The Plan's management has evaluated events for accounting and disclosure requirements through November 3, 2025, which is the date that the financial statements were available to be issued.

3. Information Certified and Provided by Custodian

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedules were prepared by or derived from information provided by John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that asset information provided to the Plan Administrator by the custodian related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the supplemental schedules.

John Hancock certified the completeness and accuracy of \$6,929,376 of pooled separate account investments and \$60,617 of notes receivable from participants as of December 31, 2024. John Hancock also certified the completeness and accuracy of \$672,452 of net realized and unrealized appreciation in the fair value of the investments, \$3,985 of interest on notes receivable from participants, and \$6,528 of other income for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan's investments in pooled separate accounts are measured at net asset value (NAV) as a practical expedient to estimate fair value, and therefore, have not been classified in the fair value hierarchy. There are no participant redemptions for these investments.

4. Investment Contract with Insurance Company, continued

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date, and lifestyle funds which seek returns consistent with the stated investment style.

5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by John Hancock. John Hancock is the custodian of the Plan; therefore, transactions qualify as party-in-interest transactions under ERISA. Indirect fees are paid to John Hancock based on investment account values. These fees range from 0.10% to 0.50% of the investment account value. The fees are included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Additionally, administrative expenses of \$3,049 for the year ended December 31, 2024 were paid by the Plan to Retirement Management Services, LLC, the recordkeeper for the Plan, for recordkeeping services. These transactions qualify as party-in-interest transactions under ERISA.

6. Income Tax Status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan sponsored by Retirement Management Services, LLC. A determination letter was received from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Plan document satisfies the applicable section of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan's management believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and is, therefore, qualified and exempt from taxation.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

8. Prohibited Transactions

During the year ended December 31, 2024, participant withholdings in the amount of \$30,298 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrence and have taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period.
