Report of Independent Auditors

To the Administrator of The Cigna Group Life, Disability and Reimbursement Account Plan

Opinion

We have audited the accompanying financial statements of The Cigna Group Life, Disability and Reimbursement Account Plan (formerly known as Cigna Life, Disability and Reimbursement Account Plan) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan's benefit obligations as of December 31, 2024 and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year then ended, including the related notes (collectively referred to as the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan's benefit obligations of the Plan as of December 31, 2024 and the changes in its net assets available for benefits and changes in its plan's benefit obligations for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

herein, other than the statements of net assets available for benefits and of plan's benefit obligations), were audited by other auditors whose report dated October 10, 2024 expressed an unmodified opinion on those financial statements and included a paragraph regarding supplemental schedules required by ERISA.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Note 1 – Description of the Plan

The following description provides general information about The Cigna Group Life, Disability and Reimbursement Account Plan ("Plan"). Participants should refer to the Summary Plan Descriptions provided by The Cigna Group (f/k/a Cigna Corporation) ("Cigna" or "Company") for more complete information about the benefits provided by the Plan. The Trust is a Voluntary Employees' Beneficiary Association ("VEBA") under Internal Revenue Code Section 501(c)(9). The Cigna Benefit Plans Trust ("Trust") funds certain benefits provided under the Plan. The Cigna Reimbursement Account funds health care flexible spending account ("FSA") and dependent care flexible spending account ("DCFSA") reimbursements under the Plan.

General

The Plan provides for certain life, statutory disability and accidental death and dismemberment insurance benefits to eligible active domestic employees of Cigna and its subsidiaries, their dependents and designated beneficiaries, as well as certain life insurance benefits to eligible retirees. Bank of America ("Trustee") is Trustee for the Trust.

FSAs and DCFSAs for eligible Cigna employees (and COBRA recipients, as applicable) are also a component of the Plan. Bank of America holds deposits and makes payments under both Cigna's FSA and DCFSA arrangements through the Cigna Reimbursement Account, which allow participants to make pre-tax deposits into the account(s) and be reimbursed from the account(s) for eligible medical, dental, vision or dependent care claims paid by the participants, as applicable.

Plan Administration

The Plan Administrator for the Plan is The Cigna Group Health and Welfare Committee ("Committee"). The Committee members are comprised of certain Cigna employees. The Committee (or its delegate) also has responsibility for the Plan's financial management.

Benefits

The Plan provides participants with the following benefits:

- Basic Life Insurance
- Supplemental Life Insurance
- Dependent Life Insurance (including spousal and domestic partners)
- Statutory Disability Insurance (offered in Hawaii, New York and New Jersey)
- Plan IV Life Insurance (Term Life)
- Basic Retiree Life Insurance
- Business Travel Accident Insurance
- Accidental Death & Dismemberment Insurance
- Supplemental Accidental Death & Dismemberment Insurance
- Health Care Flexible Spending Account (a flexible spending account)
- Dependent Care Flexible Spending Account (a flexible spending account)

The benefit programs provided through this Plan, except the DCFSA, are subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan obtained fully-insured benefits through Securian Life Insurance Company ("Securian"), as of January 1, 2023, covering all life, business travel accident, and accidental death & dismemberment for eligible active and retired employees. The Plan has fully-insured benefits for statutory disability benefits through Metropolitan Life Insurance Company (Met Life) since July 1, 2024. Prior to that, these benefits had been provided by subsidiaries of New York Life.

Life insurance available to retirees includes basic life insurance, survivor life insurance, supplemental life insurance, transition life insurance, EQUICOR retiree and survivor life insurance, and Plan IV life insurance. Coverage under each policy varies based on age, eligibility, date of retirement and earnings at retirement. Retirees did not make any contributions to the retiree basic life insurance coverage or the Plan IV life insurance coverage in 2024. The Plan's retiree supplemental life insurance is only available to eligible retirees who retired before July 1, 1993 and those retirees did not fund any of the estimated cost of supplemental life insurance in 2024.

Contributions

Employee contributions are deducted from payroll bi-weekly, in amounts based upon the various benefit provisions and related coverage elected by the employees and funded to the Trust or Reimbursement Account, as applicable. Such contributions are made pursuant to a Code Section 125 (or cafeteria) plan and are used to pay benefits and expenses of the Plan. Cigna makes additional contributions for certain Plan benefits that are either funded to the Trust or the Reimbursement Account or paid directly from its general assets. Employer contributions are generally funded monthly at the direction and discretion of the Plan Sponsor.

General Administrative Services

The cost of administrative services is borne by Cigna.

Termination

Although it has not expressed any intention to do so, Cigna may terminate the Plan, in whole or in part, at any time. In the event of termination, employer and employee contributions for any future benefit payments shall cease, and Cigna shall make additional contributions, if any, that may be required for the payment of benefits with respect to claims incurred prior to Plan termination and related expenses. The Trust agreement provides that upon termination, any remaining assets would be used for payment of benefits to employees with respect to claims arising prior to termination, payment of outstanding premiums payable, payment of reasonable and necessary expenses incurred in such termination and payment of taxes.

Note 2 - Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP). Amounts recorded in the financial statements reflect management's estimates and assumptions that affect the reported

amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Significant estimates are discussed throughout these Notes. Actual results could differ from those estimates and such differences could be material.

Valuation of Investments and Income Recognition

Investments are reported at fair value. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade date basis. Interest income is accrued daily.

Insurance Premiums

As noted in Note 1, fully insured coverage related to all life, business travel accident, and accidental death & dismemberment is provided by Securian as of January 1, 2023. Premiums for basic coverage is paid by the Plan, but all the claim risk is borne by the insurer, Securian. Premiums for supplemental coverage is paid by the participant.

In both 2024 and 2023, the Plan did not pay any premiums to New York Life for life insurance. The life insurance policy with New York Life was in a deficit position at December 31, 2023; based on the contractual provisions, the insurer bears the deficit risk. In June 2024, a final settlement was done and the cumulative deficit as of June 30, 2024 was \$9,963,389. This settlement had no impact on the Plan; deficits (claims in excess of premiums) are the responsibility of the insurer, New York Life. The Plan continued to pay New York Life for statutory disability coverage in 2023 as those contracts are not experience rated. The Plan's relationship with New York Life for these benefits terminated as of June 30, 2024. Met Life began to provide statutory disability coverage effective July 1, 2024.

Benefits Paid - Flexible Spending Accounts

Benefits paid represents claim payments to participants from their FSA and DCFSA for medical, vision and dental costs not covered by the participants' health care plans or for child care and other dependent care costs, respectively. Such benefits are recorded when paid. Funds from the DCFSA remaining at the end of the plan year's claim period, which generally is three months after December 31, are generally forfeited and used to defray any administrative costs and experience losses to provide additional benefits under the Plan. The asset accumulation in the Reimbursement Account primarily represents forfeited FSA and DCFSA money accumulated year over year.

Claims currently payable, presented in the Statements of Plan's Benefit Obligations, represent the amount of incurred claims for the Plan year not processed and paid at the end of the year.

Postretirement Benefits

The postretirement benefit obligations for life insurance represent the actuarial present value of those insured future benefits expected to be paid to beneficiaries upon the death of (1) eligible retirees and (2) currently active employees expected to retire and receive benefits. The actuarial present value of the expected postretirement benefit obligations was prepared by the Plan's actuary. The amounts are actuarially determined based upon assumed rates of turnover, retirement, discount rate, mortality, earnings and coverage.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations. The change in other assumptions was primarily the result of the update in the mortality table.

The postretirement benefit obligations exceeded the net assets available for benefits at December 31, 2024 and 2023. Insurance premiums for future years with respect to the unfunded postretirement benefit obligations will be funded primarily by contributions made by Cigna to the Trust in future years.

Note 3 - Fair Value Measurements

The Plan carries financial instruments at fair value in the financial statements. Fair value is defined as the price at which an asset could be exchanged in an orderly transaction between market participants at the statement of net assets available for benefits date.

Fair values are based on quoted market prices when available. When market prices are not available, fair value is generally estimated using discounted cash flow analyses, incorporating current market inputs for similar financial instruments with comparable terms and credit quality. In instances where there is little or no market activity for the same or similar instruments, fair value is estimated using methods, models and assumptions that the Plan believes a hypothetical market participant would use to determine a current transaction price. These valuation techniques involve some level of estimation and judgment by the Plan, which becomes significant with increasingly complex instruments or pricing models.

The Plan's financial assets carried at fair value have been classified based upon a hierarchy defined by GAAP. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest ranking to fair values determined using methodologies and models with significant unobservable inputs (Level 3). An asset's classification is based on the lowest level input that is significant to its measurement. For example, a financial asset carried at fair value would be classified in Level 3 if unobservable inputs were significant to the instrument's fair value even though the measurement may be derived using inputs that are both observable (Levels 1 and 2) and unobservable (Level 3).

Level 2 Financial Assets

Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves. An instrument is classified in Level 2 if the Plan determines that unobservable inputs are insignificant.

Level 2 assets consist of short-term investments in an institutional money market mutual fund investment that is priced daily using the unadjusted NAV as of the reporting date, which is the basis for current transactions.

There were no Level 1 or Level 3 investments held by the Plan as of December 31, 2024 or 2023.

Note 4 – Tax Status

The Trust that funds certain Plan benefits is intended to be tax qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as a voluntary employees' beneficiary association (also known as a VEBA). The Trust received a favorable determination letter dated October 29, 1984 from the Internal Revenue Service ("IRS"). Management believes that no transaction, plan alteration or other action has been undertaken since issuance of this IRS determination which compromises the Trust's exempt status. Accordingly, no provision has been made for federal income taxes in the accompanying financial statements. The Trust may be subject to IRS audit but there is no such audit currently in progress, nor has there been one in the recent past. Tax

As of December 31, 2024 and 2023, there were no uncertain positions taken that had any effect on the Plan's financial statements with respect to the tax exempt status of the Trust or otherwise or that required disclosure.

Note 5 – Related Party Transactions

There were no related party transactions among the Plan, Cigna and its affiliates in 2024 and 2023.

Note 6 – Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Effective January 1, 2024, the Plan name was changed to reflect the Plan Sponsor change to be The Cigna Group Life, Disability and Reimbursement Account Plan. Effective January 1, 2024, Cigna amended the Plan to provide that any benefit plan surplus in the HCFSAs and DCFSAs arrangements are available to offset and defray any administrative costs and experience losses or to provide additional benefits under the entire Plan.
