Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lantech 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to the Financial Statements

1. Description of the Plan

The following description of the Lantech 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 1976 and was restated effective February 18, 2022. The Plan covers all eligible employees of Lantech.com, LLC and subsidiaries (the Plan Sponsor and Administrator).

Eligibility

Employees are eligible to participate in the Plan if they are 18 years of age and have 60 days of service. Eligible participants can enter the Plan on the first day of the month on or following their 60 day service requirement. At that time, participants can begin deferring compensation into the Plan. Employees are eligible for both the employer matching and employer discretionary or nonelective contributions after one year of service. If an employee is a nonresident alien or is covered by a collective bargaining agreement between the Plan Sponsor and employee representatives on the subject of retirement benefits, they are not eligible to participate in the Plan.

Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants can elect to make monthly contributions of at least 1% of their compensation. The first 6% of participant contributions are subject to a 75% employer match. The Plan also allows participants who have reached the age of 50 by the end of the Plan year to make catch-up contributions up to certain amounts in excess of all applicable limits. A participant may contribute any rollover contribution to which the participant is entitled from another qualified trust. Such rollover contributions are deposited in the participant's account. The Plan Sponsor may elect to contribute a discretionary or nonelective contribution to be determined by the Plan Sponsor.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and an allocation of the Plan Sponsor's contributions, Plan earnings, forfeitures of participants' nonvested accounts, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan.

Notes to the Financial Statements, continued

1. Description of the Plan, continued

Vesting

Participants are vested immediately in their contributions and qualified nonelective contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
0 to 2	0%
3 or more	100%

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Participant Loans

Participants may borrow up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months. The loans are secured by the balance in the participant's account and bear interest at 1% over the Prime rate on the first business day of the month when the funds are borrowed. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's fully vested interest in his or her account. Participants may also request distributions at any time upon attainment of normal retirement age of 65 or due to the occurrence of hardships (as defined by the Plan document).

Forfeited Accounts

Forfeited amounts are first applied to the restoration of any forfeiture of former participants that have rejoined the Plan within five years of termination, under certain conditions. Any remaining forfeitures may be used to pay Plan expenses or offset employer contributions, and any remaining forfeitures will be allocated to participant accounts. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$510 and \$0, respectively. Forfeited participant balances during 2024 totaled \$17,964. During 2024, forfeitures totaling \$17,390 were used to reduce contributions.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds, pooled separate accounts and a stable value collective trust. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes to the Financial Statements, continued

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which employee compensation is earned.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Plan Sponsor.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 31, 2025, the date that the financial statements were available to be issued.

3. Information Certified or Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedules was prepared by or derived from information provided by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that asset information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at NAV per share based on quoted market prices of underlying investments.

Stable value fund: Valued at the NAV of shares held by the Plan at year end. The underlying investments are designed to maintain a stable NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Principal. Principal is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest. Administrative expenses of \$66,025 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Principal for investment management services and withdrawal charges.

Additionally, indirect fees are paid to Principal and investment advisors based on investment account values. These fees range from 0.04% to 0.80% of the investment account value. The fees reduce net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a prototype Plan document sponsored by Principal Life Insurance Co. Principal Life Insurance Co. received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Excess Contributions Payable

During 2025, payments of \$97,308 were made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the Plan year ended December 31, 2024.

During 2024, payments of \$221,995, were made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the Plan year ended December 31, 2023.

9. Contingencies

The Plan Sponsor has historically treated certain compensation as being excluded from employees' compensation for purposes of administering the Plan. This practice has been consistently followed for all employees since the inception of the Plan. During fiscal 2025, it was determined that the definition of compensation, per the Plan document, does include this certain compensation. The Plan Sponsor is working with the Trustee to clarify the definition of compensation to exclude certain compensation and, therefore, be consistent with the Plan Sponsor's past practice. The Plan has not determined any exposure of loss related to this issue.

10. Prohibited Transactions

During the year ended December 31, 2024, participant withholdings in the amount of \$20,804 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrences and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period.
