NOTE 1 - DESCRIPTION OF PLAN

The following brief description of All Heart Home Care 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan, covering substantially all eligible employees of Home Health Care of Middle Tennessee, LLC, d/b/a All Heart Home Care (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

Employees are eligible to participate in the Plan beginning the month following 30 days of employment and after reaching age 21.

Participants are eligible for Employer contributions as of January 1 or July 1 following the satisfaction of the eligibility to participate. Employees are eligible for Employer contributions 30 days after hire and reaching age 21. In addition, a participant must be employed on the last day of the year in order to receive the Employer contribution unless the reason for termination of employment is death, disability, or retirement.

Contributions

Participants may elect to defer up to 100% of their compensation, subject to certain limits, during each plan year. Participants who have attained the age of 50 are eligible to make additional catch-up contributions up to statutory limits. Pre-tax and Roth deferral elections may be changed at the beginning of each month.

The Employer's matching and profit sharing contributions are discretionary as determined by the Employer. No matching contributions were declared for the year ended December 31, 2024. Profit sharing contributions were not elected for the year ended December 31, 2024.

Rollover contributions from other qualified plans are allowed.

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

Contributions from plan participants are recorded in the year in which the participant contributions are withheld from compensation.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions is based on years of continuous service. Participants vest 20% after completion of two years of credited service, and 20% each year thereafter, resulting in 100% vesting after six years of credited service. Participants become fully vested upon death, total and permanent disability, and reaching normal retirement age.

Notes receivable from participants

Notes receivable from participants are not permitted.

Payment of benefits

Benefit distributions equal to a participant's vested account balance are payable to the participant or their beneficiaries upon normal retirement (age 59½), death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in his Employer contributions and are available to be used to pay plan expenses or offset Employer contributions. Forfeitures remaining at December 31, 2024 and 2023, amounted to \$5,966 and \$5,249 respectively.

In-service withdrawals

In-service withdrawals are permitted by participants who have reached the age of 59½. Earlier withdrawals may also be made in the case of financial hardship, as determined by the Employer.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments are recognized in the year paid.

Expenses

The Plan is responsible for its administrative expenses unless paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Recent regulatory update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and November 3, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by Empower Annuity Insurance Company of America, the Custodian of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Pooled separate accounts	Valued based on net asset value (NAV), which is determined daily, of the units of participation in the account held by the Plan. On a daily basis, the units of participation are revalued to reflect the performance of the underlying mutual funds less any fees and charges. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no participant redemption restrictions for these investments and no notice period is applicable to the Plan. If a redemption by a participant or the Plan would result in a negative cash flow in the pooled separate account to the issuer, the issuer reserves the right to require 30 days to pay a transfer or withdrawal.

The description of the significant investment strategies for each category of investment in the separate accounts follows:

- (a) This category seeks a high level of current income, consistent with safety of principal. It invests in securities issued or guaranteed by the U.S. government, its agencies, instrumentalities or sponsored enterprises. Investments in non-U.S. government securities must be of high credit quality.
- (b) This category seeks high total return with a shift to current income and capital appreciation over time as the fund approaches and passes the target retirement date. The funds are "fund of funds" that invest in underlying funds designed to provide exposure to a variety of asset classes.
- (c) This category seeks growth of capital by investing in common stocks of companies that appear to offer promising growth potential. It may invest in securities of issuers domiciled outside of the United States.

- (d) This category invests primarily in equity securities of medium-capitalization companies. The investments seeks to replicate the returns and characteristics of mid cap indexes.
- (e) This category seeks investment returns that closely approximate the performance of index funds that invest in small-capitalization companies. It attempts to replicate returns and characteristics of those indexes.
- (f) This category normally invests in securities of issuers from countries outside of the United States and may have exposure in developing markets. This category seeks long-term growth of capital.
- (g) This category seeks to provide capital growth and appreciation by investing in equity securities of companies operating throughout the world that own, explore, or develop natural resources and other basic commodities, or provided goods and services to such companies. This category also contains investments that seek total returns through investments in common stocks and other equities of real estate companies.
- (h) This category seeks to provide income consistent with stability of principal by investing in high quality, short-term money debt instruments issued by the U.S. government, domestic and foreign corporations and financial institutions, and other entities.

NOTE 5 - CONTRACT WITH TALCOTT RESOLUTION LIFE INSURANCE COMPANY

Plan investments are provided through a group annuity contract with Talcott Resolution Life Insurance Company ("TRLIC"). The contract provides for investments in pooled separate accounts. The fair value of the pooled separate accounts is based on the net asset value as a practical expedient.

Certain events will cause the contract to terminate. Such events include: (1) the contract holder provides written notice of discontinuance on a form satisfactory to TRLIC, (2) the contract holder fails to make any report or provide TRLIC with any information otherwise required by the contract, and does not remedy such failure within 31 days from the date TRLIC notifies the contract holder, (3) the Trust is amended such that its provisions adversely affect, in TRLIC's sole determination, TRLIC's obligation under this contract, (4) changes in state or federal laws or regulations governing contracts of this type adversely affect, in TRLIC's sole determination, TRLIC's obligation under this contract, (5) the assets held, or participants covered under the contract are less than the amount, or number required for the contract to be considered a group annuity contract in the state in which the contract is issued, (6) the contract holder changes organizational structure to where the Plan would no longer be considered an eligible sponsoring organization for this type of contract, (7) the Plan fails to meet the requirements for qualification under Section 501(a) of the Internal Revenue Code or (8) if at any time the contributions or balance are less than the amount required for this type of plan under TRLIC's underwriting standards in effect upon issuance of this contract.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2024 and 2023, the Plan had a concentration of investments in two funds, which represented approximately 66% and 63% of total investments, respectively.

NOTE 7 - INCOME TAX STATUS

The Plan has adopted a pre-approved plan document ("Pre-Approved Plan"). The Pre-Approved Plan received its latest opinion letter on June 1, 2021, in which the Internal Revenue Service ("IRS") stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for a separate determination letter.

The Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 8 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
