## **INDEPENDENT AUDITOR'S REPORT**

The following description of the Arkansas Provider Coalition 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan, established April 1, 2019, is a defined contribution employee benefit plan sponsored by Arkansas Provider Coalition, LLC (the “Employer”). Eligible employees include all employees, who are age 21 or older and have completed one month of service, excluding non-resident aliens, members of a collective bargaining agreement, and employees acquired in a Code Section 410(b)(6)(C) transaction. An employee will be automatically enrolled in the Plan with a 3% deferral rate on the first day of the month after satisfying eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Amendment**

The Plan was amended effective January 1, 2023 to include automatic enrollment into the Plan at a contribution rate of 3% upon satisfaction of the Plan’s eligibility requirements. The plan was also amended to include an automatic escalation feature to employee contributions. In the absence of a declination from the participant, all participants will be subject to a 1% increase to their deferrals on the first day of each plan year until the employee deferrals reach 6% of Plan compensation.

#### **Contributions**

Participants may contribute up to 100% of their annual compensation not to exceed the limit set by the Internal Revenue Code, which was \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans as rollover contributions. Compensation is defined as total compensation subject to income tax, excluding bonuses, reimbursements and other expense allowances, and including any salary reduction contributions. The Employer will make employer matching contributions to employees who are employed on the last day of the Plan year equal to a discretionary percentage that it determines for designated employee groups. The Employer matched 100% of each non-executive participant’s contributions up to 3% of the participant’s compensation received during the plan year ending December 31, 2023. The Employer matched 100% of each executive participant’s contributions up to 4% of the participant’s compensations received and up to 3% of non-executive participant’s compensations received during the plan year ending December 31, 2024. Contributions are subject to certain limitations set by law.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Employer’s contribution and Plan earnings. Participants’ accounts will also be charged with an allocation of the Plan’s administrative expenses. Allocations are based on account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Vesting

Participants are immediately vested in their contributions and any earnings thereon. Vesting in the portion of their account attributable to the Employer's matching contributions is based on each participant's years of service. Participants are 100% vested after five years of service. A participant will also become fully vested upon death, disability or retirement at age 65 or older.

### Investment Options

Participants may instruct the trustee, through an employee election form, on how to invest their account based on the investment options under the Plan. Participants may change their investment selections at any time. The Plan currently offers 19 pooled separate account funds, 5 common collective trust funds, and a guaranteed investment contract as investment options. If a participant directs the investment of his or her assets in either funds or a segregated account, any income, gains or losses from such investments shall be allocated directly to such account, and the Plan administrator will not be responsible for such investments.

### Notes Receivable from Participants

Participants may borrow from their accounts at a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50 percent of the participant's vested account balance. A participant may only have one outstanding note at any time. All notes are required to be repaid within five years of the note's origination unless the note is used for the purchase of a principal residence. The full amount of any note must be secured by the participant's vested account balance. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

Upon death, disability, retirement or upon termination of service due to other reasons, a participant may elect to receive payments of his or her vested account balance, as a lump-sum distribution. Additionally, participants may take in-service distributions from rollover accounts. Upon termination, automatic distributions are required for balances of less than \$5,000, excluding rollover accounts. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Plan administrator. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws. Participants who were automatically enrolled in the Plan have the option to withdraw their deferrals without penalty within 90 days of their automatic enrollment date.

### **Forfeitures**

The portion of the participant's account to which they are not entitled upon termination of participation is deemed a forfeiture. Forfeitures are first used to restore participant balances previously forfeited, then may be used to pay Plan administrative expenses or to reduce Employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$112,039 and \$79,788, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The Plan's most significant estimate relates to the valuation of investments and investment contracts. Actual results could differ from those estimates.

#### **Valuation of Investments and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

The Plan has entered into a group annuity contract with Voya Retirement Insurance and Annuity Company ("Voya") which consists of various investments maintained in pooled separate accounts as well as an unallocated investment in a guaranteed investment contract. The contract is not considered fully benefit responsive. The contract is included in the financial statements at contract value which approximates fair value as reported to the Plan by Voya. The contract is credited with earnings on the underlying investments. Earnings on the pooled separate accounts are considered unrealized and are reflected in the statement of changes in net assets available for benefits as investment income.

#### **Administrative Expenses and Fees**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses and fees. Investment related expenses are included in net change in fair value of investments.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

The Plan has evaluated all subsequent events for potential recognition and disclosure through November 3, 2025, the date these financial statements were available to be issued.

### **Note 3: Plan Termination**

Although it has not expressed the intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer discretionary contributions portion of their account. Employee contributions and their related earnings are always fully vested.

### **Note 4: Fair Value**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are the valuation methodologies the Plan uses to measure financial instruments at fair value:

Pooled Separate Accounts (PSAs): Stated at fair value as determined by the issuer of the pooled separate accounts based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

Guaranteed Insurance Contract: The insurance contract is reported at fair value as determined by Voya and is based on the daily crediting of interest which is subject to minimum contractual guarantees and by applying the contract's market value adjustment (see Note 5).

Common Collective Trust Funds (CCTs): Valued at the NAV of units of a bank collective trust. The investment in a collective trust fund is valued as a practical expedient utilizing the net asset valuation. The practical expedient is used for valuation, unless it is probable that the Fund will sell a portion of the investment at an amount different from the net asset valuation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used during 2024 and 2023.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments. The Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation (depreciation) of the investments held at the end of the year) appreciated in value by \$365,953 in 2024 and \$361,939 in 2023.

#### **Note 5: Guaranteed Investment Contract with Voya**

As of December 31, 2024 and 2023, the Plan held a group annuity contract with Voya Retirement Insurance and Annuity Company. The group annuity contract, Voya Fixed Account, is a fixed account that is part of the general account of Voya Retirement Insurance and Annuity Company and is not considered fully benefit responsive. The methodology for calculating the interest credit rate is based on earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. Interest is crediting rate is reset every 90 days.

#### **Note 6: Income Tax Status**

The IRS has informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 7: Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employee association or relatives of such person.

Voya is the third party administrator and custodian for the Plan. They are by definition a party-in-interest and as a result, all investment transactions were with a party-in-interest. Certain Plan investments are units of pooled separate accounts and guaranteed investment contract managed by Voya. Fees incurred by the Plan for the investment management services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Employer and Custodian are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan paid administrative costs directly to Voya \$40,763 and \$49,706 for their services during 2024 and 2023, respectively. These transactions are exempt from being prohibited transactions under ERISA.

### **Note 8: Information Prepared and Certified by Custodian**

The Plan's investments are held by Voya, the custodian and trustee. The amounts set forth in the accompanying financial statements for investments, investment income, notes receivable from participants and information shown in the supplemental schedules were summarized from information furnished by the custodian. The Plan administrator received from the custodian and trustee certifications that information furnished is complete and accurate for the years ending December 31, 2024 and 2023, respectively.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 10: Reconciliation of Financial Statements to Form 5500**

Certain amounts reported in the Plan's annual Form 5500 for changes in net assets available for benefits are different from the amounts reported in the accompanying financial statements. These differences are due to different presentation of investments and investment income but have no effect on the net assets of the Plan.

### **Note 11: Delinquent Participant Contributions**

During the year ending December 31, 2024, the Employer failed to remit certain employee deferrals to the Plan aggregating \$52,244, in a timely manner according to DOL regulations.
