## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of the  
Distributing Services 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Distributing Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Distributing Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Distributing Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## Distributing Services 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the Distributing Services 401(k) Plan (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering employees of Quickway Carriers, Inc., Quickway Transportation, Inc., Quickway Services, Inc., Quickway Logistics, Inc., Quickway Express, Inc., Capital City Leasing, Inc., Wildhorse Fleet Services, LLC, Product Distribution Service, Inc., Wild Wing Investments, LLC, Freight Contracting Services, LLC, Robert Bearden Inc., MALA, Inc., Dolphin Line, Inc., K&L, LLC, and SNL Distribution Services Corporation (collectively, the “Company”, “Employer”, or “Plan Administrator”). Plan Management adopted the resolution to cease Volunteer Express, Inc.’s participation in the Plan effective May 24, 2020. Affected participants became 100% vested in their accounts and contributions to the Plan were ceased on the effective date. Affected participant accounts remain active but at their sole discretion, participants could receive distributions of their accrued benefits or roll their balance into a separate IRA. As of the date of this report, a portion of participant accounts and balances still remain in the Plan.

The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively, “Principal”), the custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by Plan management and provides certain recordkeeping services. Principal also acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees may become a participant of the Plan when they have reached 90 days of service and are age eighteen or older. Highly compensated employees, leased employees, and independent contractors are not eligible for Plan participation, as defined in the Plan agreement. An eligible employee may enter the Plan as soon as administratively feasible after all entry requirements have been met. Participants must be employed on the last day of the Plan year and have current year employee deferrals to be eligible for the discretionary employer match.

## Distributing Services 401(k) Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may provide matching contributions to each participant in a discretionary amount, as defined in the Plan agreement. For the year ended December 31, 2024, the employer made discretionary matching contributions equal to 50% of the first 6% of compensation deferred by participants covered under a collective bargaining agreement, and 50% of the first 2% of compensation deferred by participants not covered under a collective bargaining agreement. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's discretionary matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of credited service. For discretionary matching contributions made prior to January 1, 2022, participants are 20% vested after 1 year of credited service, 40% after 2 years, 60% after 3 years, 80% after 4 years and 100% after 5 years. For discretionary matching contributions made after January 1, 2022, participants become 100% vested after three years of credited service.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined in the Plan agreement. Principal and interest is paid ratably through weekly payroll deductions.

## Distributing Services 401(k) Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### ***Benefit Payments***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$89,708 and \$0 respectively. Forfeitures are to be used to pay Plan administrative expenses or to reduce future employer contributions. In 2024, employer contributions were reduced by approximately \$54,600 from forfeited nonvested accounts.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements and contract value. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Distributing Services 401(k) Plan Notes to Financial Statements

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### *Payment of Benefits*

Distributions to participants are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, November 3, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, the qualified institution:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.

- c) Total investment income and interest income from notes receivable from participants, information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All amounts included in Note 5, *Investments Reported at Contract Value*.
- f) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## Distributing Services 401(k) Plan Notes to Financial Statements

### Note 4: FAIR VALUE MEASUREMENTS (Continued)

*Pooled separate accounts:* Valued at the NAV of units of participation held by the Plan at year-end. The NAVs, as provided by the custodian, are not publicly traded but are available to current investors via the custodian's website. Based on the availability of this information the investments have a "Readily Determinable Fair Value". These funds are required to publish their daily NAV and to transact at that price. The pooled separate funds held by the Plan are deemed to be actively traded.

*Collective investment trusts (CITs):* The Plan's CITs are valued at the NAV of units of participation held by the Plan at year-end. The NAVs, as provided by the custodian, are not publicly traded but are available to current investors via the custodian's website. Based on the availability of this information the investments have a "Readily Determinable Fair Value". These funds are required to publish their daily NAV and to transact at that price. The CITs held by the Plan are deemed to be actively traded. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the CITs, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the CITs liquidation will be carried out in an orderly business manner. There are no redemption restrictions on the CITs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### Note 5: INVESTMENT REPORTED AT CONTRACT VALUE

In 2014, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal totaling \$567,182 for 2024 and \$828,298 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the guaranteed minimum interest rate, as defined in the agreement. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 5: INVESTMENT REPORTED AT CONTRACT VALUE (Continued)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **Note 6: TAX STATUS**

The Plan uses a pre-approved plan document sponsored by Principal, which received an opinion letter from the IRS, dated June 30, 2020, stating that the pre-approved Plan and related trust is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions take by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal. Principal is the custodian, record-keeper and third-party administrator for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal by the Plan amounted to \$106,150 for the year ended December 31, 2024. Raymond James and Associates and OneDigital Investments provide investment advisory services to the Plan. Fees paid to Raymond James and Associates and to OneDigital Investment by the Plan amounted to \$6,811 and \$1,885 for the year ended December 31, 2024.

### Note 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
