## Independent Auditors' Report

Board of Trustees

### Opinion

We have audited the accompanying financial statements of International Longshoremen's Association Health & Welfare Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits in liquidation as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

In our opinion, the statements referred to above present fairly, in all material respects, the net assets available for benefits in liquidation of the Plan as of November 30, 2024 and 2023, and the changes in its net assets available for benefits in liquidation for the years then ended, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter - Liquidation Basis of Accounting

As discussed in Note 2 to the financial statements, the Board of Trustees of the Plan terminated the Plan effective August 1, 2023, and management has deemed that liquidation of the Plan to be imminent. As a result, the Plan has changed its basis in accordance with GAAP to the liquidation basis used in presenting the financial statements for the periods after August 1, 2023. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Report on Additional Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The additional Schedules of Administrative Expenses are presented for purposes of additional analysis and are not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. In our opinion, the additional information is fairly stated in all material respects in relation to the financial statements as a whole.

**1. Description of the Plan**

The following description of International Longshoremen's Association Health & Welfare Fund (the "Plan") provides only general information. Participants of the Plan should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions.

**General**

The Plan is a multiemployer defined benefit health and welfare plan. The Plan was established effective November 15, 1955 and is maintained pursuant to a collective bargaining agreement ("CBA") between the International Longshoremen's Association ("ILA"), which represents the participating employers (the "Employers"), and the International Longshoremen's Association Local 1765 (the "Union"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board consisting of equal representation from the Employers and the Union.

The Plan's Trustees voted to terminate the Plan, effective August 1, 2023 (the "Termination Date"). See Note 6 for additional information on the termination of the Plan.

**Eligibility**

All full time employees of the Employers and employees of the Union are eligible for coverage after completing one month of service. Some CBAs contain a waiting or probationary period before eligibility. If a CBA contains such a period, participants will become eligible on the first day of the following month following the day the waiting or probationary period is completed. The Plan also provides a continuation of health coverage under the Consolidated Omnibus Budget and Reconciliation Act ("COBRA") to eligible employees and dependents upon termination of employment.

**Employer Contributions**

The Employers are required to make monthly contributions to the Plan as required by the applicable provisions of their respective CBAs for their Union employees. Employee contributions are permitted to provide COBRA benefits, and employees pay the full cost of such benefits. As further described in Note 6, the Plan was terminated effective August 1, 2023, and contributions were no longer required.

**Benefits**

The Plan provides health benefits (medical, dental, and prescription drugs), life insurance, and sickness and accident benefits to eligible participants and beneficiaries. Health and life insurance benefits under the Plan are provided through insurance coverage. The Plan purchases annual insurance contracts and remits monthly premiums at a composite or specified rate per subscriber for each of these insured benefits. The Plan provides sickness and accident benefits on a self-insured basis.

The Plan made a final payout to all participants who were employed by an Employer or otherwise covered by the Plan as of August 1, 2023 in order to terminate the Plan.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

The financial statements of the Plan were prepared using the accrual method of accounting until the Termination Date. In accordance with GAAP, the Plan changed its basis of accounting used to value Plan assets to the liquidation basis for the period after the Termination Date. The liquidation basis of accounting caused no change in the value of Plan assets because the Plan assets are stated at current fair value.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Fair Value Measurements**

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

**Payment of Benefits**

Benefit payments for participants are recorded when paid. Premiums paid are recorded as insurance premium payments in the accompanying statement of net assets available for benefits.

**Administrative Expenses**

The Plan permits the payment of Plan expenses from Plan assets. Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with other related plans. The computation of these allocated costs is based on time spent through an annual common expense study performed for the related plans.

**Subsequent Events**

The Plan has evaluated subsequent events through November 3, 2025, the date on which the financial statements were available to be issued.

**3. Incurred Benefit Obligations**

The Plan does not record an actuarial estimate of obligations for disability claims incurred. The actuarial liability would be for participants who are entitled to a temporary disability benefit that have yet to submit a claim to the Plan. All other Plan benefits are provided through insurance contracts. These amounts and their effect on the financial statements would be insignificant.

**4. Fair Value Measurements**

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical instruments in active markets.
  
- Level 2            Inputs to the valuation methodology to include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement levels within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Level 1 investments consist of a money market fund. The money market fund is derived from quoted prices in active markets for identical assets..

**5. Related Party Transactions**

Most of the Plan's administrative expenses are based on percentages presented in the annual common expense study under an agreement among the Plan, the Union, and the International Longshoremen's Association Pension Fund. Expenses relating to the operation of the office are allocated to and paid by each participating fund. Each fund's shared expenses are computed based on the study with reimbursements being made to funds incurring too much expense through the monthly agreement.

For the year ended November 30, 2024, amounts due from the Union for reimbursement of common expenses amounted to \$26,568. Due to the termination of the Plan, the Union and the Trustees agreed that the additional amount owed would be paid directly to the participants by the Union.

For the year ended November 30, 2023, amounts due to the Union for reimbursement of common expenses amounted to \$11,070.

**6. Plan Termination**

The Trustees have the right under the Plan to discontinue the Employers' contributions under the CBA at any time and to terminate the Plan subject to the provisions of ERISA. Employer contributions were discontinued and the Plan was terminated effective August 1, 2023.

Remaining assets are being used solely for purposes of providing benefits to employees and their dependants who were employed by Employers or otherwise covered by the Plan as of the Termination Date, and defraying the reasonable cost of administering the Plan. No assets shall revert to the Employers.

**7. Tax Status of Plan**

The Internal Revenue Service has determined and informed the Trustees by a letter that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Trustees believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with GAAP, management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of November 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require the recognition of a liability or disclosure in the financial statements. Management believes the Plan is no longer subject to income tax examinations prior to 2021. The Plan is also subject to routine audits by the Department of Labor generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.


