INDEPENDENT AUDITORS' REPORT

To the Trustee and Board of Directors of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Skills Development Services, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Skills Development Services, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

A. General

The Plan is a profit sharing plan covering employees who have thirty (30) days of service. Employees enter the plan on the semi-annual date on or after meeting the eligibility requirement. The plan year is January 1 through December 31. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The Trustee oversees governance of the Plan.

B. Contributions

Each year participants may contribute from 0% to 100% of compensation. Maximum contribution is limited by Federal tax laws. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may match part of the participant contribution based on salary deferrals and pays of the end of the pay period. The Company may make a discretionary contribution at the end of the plan year if an employee is an active participant on the last day of the Plan year and employed at least 30 days before plan entry dates January 1 and July 1 each year. Employer contributions may change in the future. There were no profit sharing contributions made; only matching part of salary deferral contributions.

The Plan includes an automatic contribution arrangement for new participants or re-hired participants as they enter the plan. It includes an automatic 3% deduction from pay contributed to the plan unless participant elects a different salary deferral percentage.

C. Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of plan earnings. Allocations are based on the participant average account balances, as defined.

D. Vesting

Participants are 100% vested in their salary reduction and employer matching contributions based on years of service in which participant worked at least 1,000 hours. Participants are 100% vested in employer matching after four years of credited service.

E. Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the Plan's available investment options. Participants may change their investment options or contribution percentages two times during the year, January 1 and July 1.

F. Payment of Benefits

Benefits will be paid only on death, disability, termination of employment, age 59-1/2 and still working, or at retirement. Upon such event, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in periodic payments over a period not exceeding the life expectancy of the participant or the joint life expectancy of the participant and his designated beneficiary or certain other annuity options. The Plan does allow for hardship withdrawals.

G. Forfeited Accounts

At December 31, 2024, forfeited accounts totaled \$14,827. Of this amount, \$14,827 was used to reduce future employer contributions.

H. Plan Administrative Costs

Plan administrative costs are absorbed by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

B. Date of Management's Review

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

C. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

D. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Investments in pooled separate accounts are valued at quoted market prices, which represent the net asset value at year end. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Unobservable inputs are those that reflect the plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. An example could be real estate valuations, which require significant judgment.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter on June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Management has evaluated the Plan's design and operation and has concluded that the Plan is designed and has been operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles prescribe requirements for the recognition, measurement, classification, and disclosure in the financial statements of uncertain tax positions taken or expected to be taken by the Plan. Further, management believes that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment of the financial statements.

The Plan is subject to routine audits by the IRS; however, there are currently no audits in progress. Generally, the Plan's tax returns remain open for federal income tax examination for three years from the date of filing.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the new term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

These accounts are considered non-benefit responsive; therefore, fair value is the relevant measurement for the benefits attributable to the guaranteed contract.
