Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Vito C. Quatela, M.D., PLLC Employees' Savings and Profit-Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Vito C. 

NOTE 1: DESCRIPTION OF THE PLAN

The following description of Vito C. Quatela, M.D. PLLC Employees' Savings and Profit-Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of the controlled group, which includes Vito C. Quatela, M.D., PLLC, Ambulatory Healthcare Strategies LLC, Vito C. Quatela MD Victor Medical, PLLC, Lindsay House Surgery Center, Rhino Administrative Services, LLC, and Vito C. Quatela M.D., Medical, PLLC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on March 3, 1999.

Employee Contributions - Each year, participants of the Plan may contribute up to a maximum amount as determined by section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set annually as a percentage of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Employer Contributions - The Companies of the controlled group (see above) contributes annually an amount equal to a specified percentage designated each Plan year at the discretion of the Companies' Board of Directors. At the end of the Plan year, the Companies, also at the discretion of the Companies' Board of Directors, may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants.

Participants' Accounts - Each participant's account is credited with the participant's voluntary contribution, the Company's matching contributions, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of participation in the Plan. A participant is 100% vested after three years of participation in the Plan.

Participant Loans - Participants may borrow at the Plan Administrators discretion. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate of interest.

Termination Rights - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions allocated to their accounts.

Payments of Benefits - Upon termination of employment, the participant's attainment of normal retirement age, participant's disabilities or termination of the Plan, the vested portion of a participant's individual account shall be distributed to the participant in a lump sum payment; as soon as administratively feasible, following the date on which a distribution is requested or is otherwise payable.

Forfeitures - Forfeitures of non-vested employer contributions will occur in the Plan year when a terminated participant receives a distribution of his entire vested account. These forfeitures become an asset of the plan and continue to be invested in registered investments until they are either reallocated to other eligible participant accounts or they may be used to reduce future employer contributions or pay plan expenses. On December 31, 2024 and 2023, the forfeiture balance was \$13,323 and \$2,046, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The accompanying financial statements have been prepared on the accrual basis of accounting, which recognizes income when earned and expenses when incurred.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Held in Trust - Empower Trust Company, LLC was the trustee of the Plan and held the Plan's investment portfolio until October 2024 when the investments were transferred to Automated Data Processing, Inc. (ADP) who became the new trustee of the Plan effective October 1, 2024, and held the Plan's investment portfolio on December 31, 2024.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of Mutual funds are valued at the net asset value of shares held by the Plan at year-end. Benefit responsive investment contract is valued at contract value, which is equal to fair value. Participant loans are valued at amortized cost, which represents fair value.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases of sales and securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan and are included in administrative expenses.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Information Certified by the Trustees - The Plan administrator has elected the compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under the election, no audit procedures have been performed with respect to information certified as complete and accurate by the trustee except for comparing such information to that included in the Plan's financial statements. Amounts included in the accompanying financial statements that are certified by the trustee are listed in Note 4.

Subsequent Events - In preparing these financial statements, the Company has evaluated events and transactions for potential recognition and disclosure through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

FASB ASC 820 "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes at December 31, 2024 in valuation methodologies as described in Note 2. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: INVESTMENT CONTRACT WITH INSURANCE COMPANY PRESENTED

The Plan has a benefit-responsive investment contract with Empower Life and Insurance Company of New York; a Guaranteed Interest Fund. The Guaranteed Interest Fund is benefit responsive for participant-initiated transactions. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

NOTE 6: TAX STATUS

The Plan has obtained its latest determination letter dated November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.
