## **INDEPENDENT AUDITOR’S REPORT**

To the 401k Plan Committee of  
Holley Performance Products, Inc.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Holley Performance Products, Inc. Retirement Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Holley Performance Products, Inc. Retirement Accumulation Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. ### **Note 1: DESCRIPTION OF THE PLAN**

The following description of Holley Performance Products, Inc. Retirement Accumulation Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

#### ***General***

The Plan is a defined contribution plan sponsored by Holley Performance Products, Inc. (the “Company”) for the benefit of its full-time employees. The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act (“ERISA”) of 1974. The Board of Trustees is responsible for oversight of the Plan. The Plan’s 401k Plan Committee (Investment Committee) determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Plan assets are held and managed by Reliance Trust Company, the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the 401k Committee. ADP Retirement Services (ADP) acts as the recordkeeper and third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees may become a participant of the plan when they have reached two months of service. An eligible employee may enter the Plan on the first day of each month after all entry requirements have been met.

#### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 60% of eligible compensation. Employee rollover contributions are also permitted. The Plan allows participants who have attained the age of 50 by the end of the Plan year to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and the rate is automatically increased 1% each year of participation up to 6%. At its discretion, the Company makes matching contributions of employees’ salary deferral amounts. The Company made a discretionary matching contributions of \$78,177 and \$882,289 in 2024 and 2023, respectively. The Company contributes a safe harbor matching contribution of 100% of the first 1% of base compensation and 50% of the next 2% to 6% of base compensation that a participant

#### ***Contributions (continued)***

contributes to the Plan. Effective July 15, 2024, the Company paused the safe harbor matching contributions. Safe harbor matching contributions are scheduled to restart effective January 1, 2025. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's safe harbor contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Retirement, Death and Disability***

A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is fully vested after two years of continuous service.

Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service according to the following schedule:

#### ***Payment of Benefits***

Upon termination of service, an employee may elect to receive either, a lump-sum amount equal to the value of his or her account, or installments under a systematic withdrawal plan. Benefit payments

#### *Payment of Benefits (continued)*

to participants are recorded upon distribution. Participants age 59.5 may also elect to receive a lump-sum distribution of their vested account.

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$161,001 and \$48,596 respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2024 and 2023, employer contributions were reduced by \$42,261 and \$69,100 from forfeited nonvested accounts, respectively.

#### *Hardship Withdrawals*

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

#### *Notes Receivable from Participants*

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$500. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan administrator.

#### *Transfers from Other Plans*

Effective December 31, 2022, the Simpson Performance Products, Inc. 401k Plan and Trust ("Simpson Plan") was merged into the Plan, after the Company's acquisition of the assets of Simpson Performance Inc. in November of 2020. The transfer of \$3,569,704, in net assets of the Simpson Plan into the Plan was completed on January 3, 2023.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S.

#### ***Basis of Accounting (continued)***

GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis.

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Administrative Expenses (continued)*

Investment related expenses are included in net appreciation/depreciation (as applicable) of fair value of investments.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 16, 2025, and determined there were no events that occurred that require disclosure.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Net appreciation in fair value of investments and investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at fair value on a daily basis by the market value of the underlying investments held by the fund account at year-end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### Note 5: TAX STATUS

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Investment management fees which are reflected as a reduction of investment return also qualify as party-in-interest transactions. ### **Note 7: PLAN TERMINATION**
