Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chief Industries, Inc. Thrift Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

General

The following description of Chief Industries, Inc. Thrift Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Chief Industries, Inc. (Company), for the benefit of its full-time employees upon hire. This includes employees of Chief Industries, Inc and its wholly owned domestic subsidiaries, Chief Ethanol Fuels, Inc. and Chief Carriers, Inc. Part-time, temporary, seasonal employees, or interns who work at least 1,000 hours of service during the eligible computation period or employment status changes to full-time or have met the long-term, part-time requirements under the 2019 SECURE Act shall become eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company was the trustee and custodian of the Plan through January 31, 2024. Effective February 1, 2024, Charles Schwab Trust Bank became the trustee and custodian of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions between 0% and 100% for non-highly compensated employees and 0% and 8% for highly-compensated employees as defined by the Internal Revenue Code. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may make matching contributions equal to a percentage of participants' compensation and/or a discretionary dollar matching contribution for the Plan year. The Company, at its sole discretion, shall determine the percentage or dollar amount, if any, of such contributions. The Company makes matching contributions of 40% on the first 8% of the participants' contributions. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise.

1. DESCRIPTION OF THE PLAN - CONTINUED

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant becomes fully vested after two years of continuous service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans shall bear a reasonable rate of interest as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions when available.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments only for the purpose of required minimum distribution rules. Upon termination of service, a participant is entitled to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial payment as requested by the participant.

Forfeited Accounts

On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$149,588 and \$19,302, respectively. These accounts may be used to reduce future employer contributions and administrative expenses or can be reallocated to participants in the same manner as employer contributions. Employer contributions were reduced by \$18,023 and \$78,796, from forfeited nonvested accounts during 2024 and 2023, respectively. Administrative expenses were not paid from forfeited non-vested accounts during 2024 and 2023 and no amounts were reallocated to participants during 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the plan at year end.

Pooled separate accounts were valued at estimated fair value as provided by Principal Life Insurance Company.

The Plan's interest in the collective trust was valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) was calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Fully benefit-responsive investment contracts were valued at contract value. Contract value represented contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Administrative expenses related to loan fees are charged directly to the account of the participant requesting the loan.

3. CERTIFICATION OF PLAN CUSTODIAN AND TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate for the period of February 1, 2024 through December 31, 2024. Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate for the period of January 1, 2023 through January 31, 2024:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

From January 1, 2023 to January 31, 2024, certain Plan investments were managed by Principal Trust Company. Principal Trust Company was the custodian and trustee, as defined by the Plan, for the period January 1, 2023 to January 31, 2024. From February 1, 2024 to December 31, 2024, Charles Schwab Trust Bank was the custodian and trustee, as defined by the Plan. Certain Plan investments were managed by Charles Schwab Investment Management, Inc., an affiliate of Charles Schwab Trust Bank. Therefore, these transactions qualified as party-in-interest transactions.

The Plan paid \$33,394 and \$40,639 of recordkeeping/administration fees to Principal Trust Company during 2024 and 2023, respectively. During 2024, the Plan paid \$63,433 of recordkeeping fees to Schwab Retirement Plan Services, Inc., the Plan recordkeeper, and \$110,568 of investment advisory fees to Allen Capital Group, LLC. Certain fees to Charles Schwab Trust Bank and Principal Trust Company are included in net appreciation in fair value of the investment, as they are paid through revenue sharing credits. Those amounts totaled \$45,564 for Charles Schwab Trust Bank for 2024 and for Principal Trust Company, \$17,743 and \$210,855 during 2024 and 2023, respectively. During 2024, individually nonmaterial expenses paid to parties in interest aggregated \$9,200.

5. PLAN AMENDMENT

Effective February 1, 2024, the Plan was amended and restated. Charles Schwab Trust Bank was appointed as the new trustee, administrator and custodian (“Trustee”) of the Plan. Plan assets transferred to the new Trustee were transferred into funds comparable to those offered by the previous custodian.

During this amendment and restatement, certain changes were made to Plan provisions. Prior to February 1, 2024, the Plan permitted eligible employees to make salary deferral elections between 3% and 25% of eligible compensation and forfeited accounts could be used to reduce employer contributions or administrative expenses. Effective February 1, 2024, the Plan permits salary deferral elections between 0% and 100% for non-highly compensated employees and 0% and 8% for highly-compensated employees as defined by the Internal Revenue Code and forfeited accounts can now be reallocated to participants or used to reduce future employer contributions or administrative expenses.

6. DISCLOSURES ABOUT FAIR VALUE OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes to the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sources market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulated loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

Level 3 Activity

During 2024 and 2023, activity of the guaranteed investment contract included purchases of \$0 and \$10,748 respectively. During 2024 all guaranteed investment contracts were sold as part of the transition described in Note 5 and there were no transfers. During 2023, there were no sales or transfers into Level 3.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer had been contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract had been fully benefit-responsive; therefore, contract value was the relevant measurement. Contract value, as reported to the Plan by Principal Life, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily have directed the withdrawal or transfer of all or a portion of their investment at contract value.

There had been no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events had included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator had not believed the occurrence of any such value event, which would have limited the Plan's ability to transact at contract value with participants, was probable.

The guaranteed investment contract had not permitted the insurance company to terminate the agreement prior to the scheduled maturity date.

The investment contract with Principal Life Insurance was terminated during the transition to Charles Schwab Trust Bank as described in Note 5.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. TAX STATUS

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Schwab Retirement Plan Services. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

9. TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.
