We have performed audits of the accompanying financial statements of Atomic Data 401(K) Plan (the Plan), an employee benefit plan subject to Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 16, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the partial plan year ended November 16, 2023, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 16, 2023 and December 31, 2022, and for the partial plan year ended November 16, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the governing body of Atomic Data 401(k) Plan agreed to merge the Plan into the Principal EASE 401(k) Plan, effective November 16, 2023. All plan assets were transferred to the Principal EASE 401(k) Plan on November 16, 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of the Atomic Data 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the original Plan document as amended for a more complete description of the Plan's provisions.

General and Eligibility

The Plan was a defined contribution plan established by Atomic Data, LLC (the Company) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participation in the plan was entirely voluntary. An eligible employee was any person employed by the Company, who had completed six months of service with 500 service hours.

The Company entered into a participation and merger agreement effective November 16, 2023 to transfer all accounts to the Principal EASE 401(k) Plan (the Principal Plan). All assets were transferred to the Principal Plan on November 16, 2023. The Plan did not survive the merger and as a result was effectively terminated on November 16, 2023.

Contributions

Participants were allowed to make an elective deferral contribution of annual compensation, subject to limitations, as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company could make discretionary matching contributions and/or nonelective contributions to the Plan, however, no such contributions were made during the partial plan year ended November 16, 2023. To qualify for the match and nonelective contributions, eligible employees had to have completed at least six months of service with 500 service hours and be employed on the last day of the plan year.

All contributions were subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions, if any, and (b) Plan earnings, and were charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment Elections

All contributions made to the Plan were allocated to the various investment options offered by the Plan as directed by the participant.

Vesting

Participants were immediately 100 percent vested in their contributions, rollover contributions, and actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service according to the following schedule.

Payment of Benefits

Benefit distributions to participants represented the amounts paid during the year to participants, upon the earliest occurrence of any of the following events: death, retirement, total and permanent disability, voluntary or involuntary termination of employment, or hardship. Benefits were distributed in the form of a lump sum, rollovers, transfers to annuities, or in installments over varying periods, as allowed by the Plan. When a participant separated from service, a forced payout could be made for account balances of \$5,000 or less. If a terminated participant's balance was greater than \$0.01, the balance would be automatically rolled into an individual retirement account on behalf of the participant, if no other election was made.

Forfeited Accounts

As defined by the Plan, forfeiture of the non-vested portion of a participant account occurred at the earliest of: a) five consecutive breaks in vesting service or b) when a participant terminated participation in the Plan and requested payment of their entire vested account balance. Forfeitures were utilized to reduce the company matching contributions or for payment of plan expenses. However, if a participant was reemployed and fulfilled certain requirements, as defined in the plan, the participant's account was reinstated.

Forfeited nonvested amounts were used to pay administrative expenses of the Plan, restore unvested amounts to reemployed participants, or reduce company matching contributions into the Plan. Forfeited non-vested accounts totaled \$15,019 at December 31, 2022. During 2023, \$7,132 of forfeitures were used to pay plan expenses and \$15,019 of forfeitures were used to reduce the company matching contribution.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Investment Valuation and Income Recognition

Investments were stated at fair value (except for fully benefit-responsive insurance contracts, which were stated at contract value). Fair value is the price that was received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determined the Plan's valuation policies utilizing information provided by the investment advisor and the trustee. See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for plan benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. Fees related to the administration of distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Additionally, forfeitures may be used to pay plan expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 28, 2025, the date which the financial statements were available to be issued.

Note 3: Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held at November 16, 2023 and December 31, 2022, and net appreciation in fair value of investments and interest for the partial plan year ended November 16, 2023, was obtained by management, and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance Company (the Custodian).

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data, by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 16, 2023 and December 31, 2022.

Pooled separate accounts: Valued based upon the unit values of such pooled separate accounts held by the plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation and other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled separate accounts, there are no unfunded commitments or redemption restrictions. Participant-direct redemptions can be made on any business day and do not have a redemption notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Note 5: Investment Contract with Insurance Company

The Plan's guaranteed income fund was a fully benefit-responsive investment contract with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintained the contributions to the investment contract in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value. Certain events initiated at the Plan-level (including but not limited to spin-offs, sales, mergers, and full or partial plan termination) could have limited the ability of the Plan to transact at contract value with the contract issuer. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, was probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer that have been established. Minnesota Life Insurance Company was contractually obligated to pay the principal and specified interest rate that was guaranteed to the Plan. The crediting interest rate was calculated by Minnesota Life Insurance Company and was reset at least quarterly and was never less than 0%.

Note 6: Risks and Uncertainties

The Plan invested in various investment funds. Investment funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Note 7: Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan constitutes a qualified Plan under Section 401(a) of the Internal Revenue Code (IRC) and that the Trust created under the Plan is exempt from federal income taxes under provisions of Section 501(a). Compliance with the Employee Retirement Income Security Act of 1974 (ERISA) was required to maintain this tax status. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: Party-in-Interest Transactions

Certain plan investments were shares of pooled separate accounts managed by the Custodian as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualified as party-in-interest transactions.
