Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due to which may become due to such participants.

### Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve

collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of delinquent participant contributions and schedule of assets held at end of year for the year ended November 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of Plan**

The Plan operated as a nonparticipant-directed profit sharing plan until June 10, 2024. The Company amended and restated the Plan, effective June 10, 2024. As of this effective date, the Plan will operate as a Safe Harbor 401(k) Plan and allow eligible employees to make elective deferrals into the Plan and self-direct all funds. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General.** The Plan was a defined contribution nonparticipant-directed plan covering substantially all employees of Trend Services, Inc. (the "Company") who are 21 years of age and have completed one year of service.

Effective June 10, 2024, the plan was amended and restated and now operates as a Safe Harbor 401 (k) Plan. The Plan continues to covers all employees of the Company who are 21 years of age and have completed three consecutive months of service with the Employer, during which employee must have completed at least 250 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.

- B. **Contributions.** Effective June 10, 2024, participants may elect to defer a percentage or dollar amount not to exceed the limit of the IRS yearly maximum. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution to the Plan equal to 100% of participant's contributions to the Plan up to 2% of compensation, plus 50% of the participant's contribution that exceed 3% of compensation; but, do not exceed 5% of compensation. Additional profit-sharing contributions may be contributed at the option of the Company. Contributions are subject to certain statutory limitations

- C. **Participant Accounts.** Each participant's account is credited with the participant's contribution, the Company's profit sharing contribution and allocations of (a) Company's profit sharing contribution, (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. **Vesting.** Participants are immediately 100% vested in their contributions plus actual earnings and rollovers. Vesting in the Company's matching and profit sharing contribution portion of their accounts is based on vesting years of continuous service. A participant is 100% vested at six years of credited service.

- E. **Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of 9.50%, which is commensurate with the rate reflected in the Wall Street Journal on date of loan plus 1%. However, participants may qualify for a lower interest rate if they are on active duty in the military. Principal and interest are paid ratably through weekly payroll deductions.
- F. **Payment of Benefits.** On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in a lump-sum or partial lump sum.
- G. **Investment Options.** Effective June 10, 2024 or upon enrollment in the Plan, a participant may direct contributions in any of the investment options permitted under the Plan. Participants have the ability to change their investment option at any time they choose.
- H. **Forfeited Accounts.** At November 30, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$376, respectively. This account will be used to pay Plan expenses.

Note 2. Summary of Accounting Policies

**Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of November 30, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits:**

Benefit payments to participants are recorded when paid.

**Expenses:**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Date of management's review of subsequent events:**

Subsequent events were evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

The Plan's investment in pooled separate accounts are reported at fair value, using the net asset value per share, as a practical expedient, in the accompanying statement of net assets available for benefits. The net asset value of the investment is based on the market value of their underlying investments and is not a public-quoted price in an active market. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no Plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

*Net Asset Fair Value Measurement*

The Plan had \$3,630,921 of investments held in pooled separate accounts at November 30, 2024.

*Level 1 Fair Value Measurement*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U. S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair value of equities are based on closing price reported on the active market where the individual securities are traded

The objective of these investment vehicles invested in equity investments is to provide income and to provide opportunity for growth of principal; to seek long term capital appreciation; approximate the risk and return characterized by various indexes; and/or to seek income. The objectives of the investment vehicles invested in fixed income is to maximize total return through income and capital appreciation; and/or provide inflation protection and earn current income consistent with inflation-protected securities. The objective of the investment vehicles invested in target date funds is to seek to provide capital appreciation and current income consistent with its current asset allocations.

Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented are intended to permit the reconciliation of the fair value hierarchy to the amount presented in the statements of net assets available for benefits.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended November 30, 2024, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers of investments into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended November 30, 2024, there were no transfers of investments into or out of Level 3.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions. The Company would direct the distribution of participant accounts in a manner permitted by the Plan as soon as practical.

**Note 6. Tax Status**

The Company has not applied for a determination letter from the Internal Revenue Service (IRS) regarding the compliance of the Plan's design with applicable sections of the Internal Revenue Code (IRC); however, the prototype plan which it has adopted and is currently operating under has received a favorable IRS determination letter, dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 7. Related Party Transactions and Party in Interest Transactions**

Parties in interest, as defined under ERISA, include persons and entities such as the Plan sponsor, employers and Plan administrators, custodian and plan auditors among others. As custodian, by UBS Financial Services, Inc. (UBS) and the Vanguard Group, Inc. held all Plan investments throughout the year. Administrative fees paid to by UBS Financial Services, Inc. (UBS) and the Vanguard Group, Inc. totaled \$22,732 for the year ended November 30, 2024.

**Note 8. Administrative expenses**

Administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan. Any remaining balance for administrative expenses associated with the prototype sponsor's fee and the independent auditor's fees are paid directly by the Company. Investment advisor fees are absorbed by the Plan.

**Note 9. Prohibited Transactions**

During 2024, the Plan sponsor inadvertently failed to deposit approximately \$9,752 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. These failures to timely remit participant withholdings qualify as a non-exempt prohibited transaction. In order to correct, the Company intends to remit the corrective contributions to the plan for the lost opportunity costs associated with untimely remitted participant withholdings and allocate to the affected participants.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
