### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Family Resource Agency, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**(1) DESCRIPTION OF PLAN**

The following description of the Family Resource Agency, Inc. 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible class employees of Family Resource Agency, Inc. (the Company). The Plan is approved under Internal Revenue Code Section 403(b). The plan is funded under a tax deferred group annuity contract. Employees are eligible to make salary deferral contributions as of the first day of employment. Eligible class employees are eligible to receive employer contributions when they have 1,000 hours of service. Specifically excluded from employer contributions are employees that are classified as substitutes or those that normally work less than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on August 28, 1989.

**Contributions**

Each year participants may elect to have compensation deferred up to the maximum amount allowed by law as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other plans and certain IRAs (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Company makes a contribution of 5% of eligible compensation for all eligible employees.

**Participant accounts**

Each participant's account is credited with the participant's contribution and allocation of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their employee contribution account plus actual earnings thereon. Vesting in the employer contribution account is based on years of continuous service. Participants vest in 20% of their employer contribution account beginning in year two and each year thereafter until 100% vested after six years of credited service.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested value of the account or \$50,000. Loan terms range from 1-5 years, except for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the rate of 4.25% based upon prevailing interest rates. Principal and interest is paid ratably directly by the participants.

**Forfeitures**

The forfeiture balance was \$790 for the year ended December 31, 2024. There was no forfeiture balance at year ended December 31, 2023. These accounts are used to reduce future employer matching contributions. Employer contributions were reduced by \$16,777 during the year ended December 31, 2024.

**Payment of benefits**

Upon termination, retirement, disability, or death, a participant may elect to receive a lump sum amount equal to the value of the participant's account if consented to by the plan administrator, or an annuity payout.

**Policy loans**

Participants may borrow amounts directly from the plan custodian. Policy loans may be requested by a participant, using their account balance as collateral for the policy loan. A policy loan is not withdrawn from the participant's balance and is maintained in the loan collateral and loan escrow account. A participant may apply for a policy loan to be made from his or her vested account balance in the Plan not to exceed the lesser of (i) \$50,000 or (ii) 50% of the participant's vested account balance in the Plan. Policy loans may be further limited by the funding vehicles.

When a policy loan goes in default, but cannot be distributed because no distributable event has occurred, the participant receives a 1099R for the outstanding principal and interest at time of default. When this happens, the loan collateral (collateral and escrow accounts) must remain in the participant account as part of the plan assets. See Note 7 for reconciliation of the collateral and escrow accounts to the active policy loans reported on the statements of net assets available for benefits.

**Revenue account**

The Plan carries a revenue account used to cover plan costs. Administrative fees are collected from the Plan's investments and maintained in this account to pay recordkeeping and administrative fees. For the year ended December 31, 2024, there were \$17,271 of fees paid from the account during the year. There was no balance in this account at December 31, 2024 or 2023.

**Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**(3) CERTIFIED INVESTMENTS AND INVESTMENT INCOME**

The plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Corebridge (formerly VALIC) and American United Life Insurance Company have certified that the following information, as well as investment information in the notes to the financial statements and information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024 and 2023, is complete and accurate.

**(4) FAIR VALUE**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 assets are valued using quoted prices in active markets for identical investments. Level 2 assets are valued using inputs other than quoted prices. Level 2 inputs are observable, either directly or indirectly for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life. Level 3 inputs are unobservable for the investment, indicating that the inputs reflect the entity's own assumption used in pricing an investment based on the best information available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The Plan uses the following methods and assumptions in estimating the fair values of the Plan's financial instruments:

Pooled separate accounts

While some pooled separate accounts may have publicly quoted pricing inputs, the account values of separate accounts are not publicly quoted and are therefore classified as level 2 investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between levels.

**(5) INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Company entered into a fully benefit-responsive investment contract with American United Life Insurance Company (OneAmerica) totaling \$1,768,063 and \$1,575,644 at December 31, 2024 and 2023, respectively. In 1997, the Company entered into a fully benefit-responsive investment contract with the Corebridge (formerly VALIC) totaling \$343,179 and \$553,097 at December 31, 2024 and 2023, respectively. The Corebridge contract was partially transferred to OneAmerica during the years ended December 31, 2024 and 2023. The investment contract contributions are maintained in a general account and in separate accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

These contracts meet the fully-benefit responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by OneAmerica and Corebridge represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contracts have certain restrictions that impact the ability to collect the full contract value, Plan management believes that the occurrence of events that would cause the plan to transact at less than contract value is not probable. OneAmerica and Corebridge may not terminate the contract at any amount less than contract value.

**(6) PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by American United Life Insurance Company and Corebridge (formerly VALIC), the custodians of the Plan for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions. Fees of \$20,980 incurred and paid for investment management services are reported on the statement of changes in net assets available for benefits. The Plan also permits notes receivable from participants. Therefore, transactions pertaining to these investments qualify as party-in-interest transactions. Certain administrative expenses paid by the Plan Sponsor qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(7) POLICY LOANS**

**(8) INCOME TAX STATUS**

Currently, 403(b) plans are not required to submit plans to the Internal Revenue Service for determination. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**(9) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**(10) SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 29, 2025, the date which the financial statements were available to be issued.
